The August 19, 2015 minutes were approved by unanimous consent.

Old Business - Program Updates

a. EBDM & Justice Reinvestment Initiative (JRI) - Tiana/Gary - Discussion

Tiana mentioned that Eau Claire Co. was not awarded the JRI Phase III grant. Since the additional funds will not be received, the part-time COMPAS assessor position could be eliminated. OWI arrests will no longer receive a COMPAS assessment, and this will be a benefit and will free up some of the time that it takes to complete the COMPAS evaluations. The 2016 CJCC county budget request will be adjusted and brought back to the Finance & Budget Committee.

b. Meth Response Committee – Gary King - Discussion/Action

Gary provided the members with an update on the Meth Response Committee and brief information on the subcommittees that relate to the larger group. The Recovery Coach with the Treatment Courts will be available to help with some of these cases. The group continues to move forward with the initiatives.

c. DNA/Fingerprint Collection Room Update – Discussion/Action

The Sheriff's Dept. has hired Special deputies and started providing training to the new staff. The PD will continue to run the room for an additional week. The Sheriff's Dept. will take over completely by the week of November 3rd.

d. COMPAS Update – Discussion
