FACT SHEET

TO FILE NO. 15-16/154

On both March 3, 2016 and March 15, 2016 the Judiciary and Law Committee discussed the concept of converting correctional officers within the county system to protective status. They forwarded a resolution to be considered at the March 15, 2016 board meeting. At the March 15, 2016 County Board of Supervisors meeting, Resolution 15-16/154 was referred back to the Committee on Human Resources. At its April 8, 2016 meeting, the Committee on Human Resources denied a request by a vote of 3 against, and 1 for, to support a change in state law to make County Civilian Correctional Officers protective status under the Wisconsin Retirement System.

At the April 19, 2016 County Board meeting, the board discussed the resolution and postponed action to the May 3, 2016 meeting.

The following items relevant to the consideration of this action:

- 1) Corporation Counsel has advised that under current law correctional officers do not meet the "active duty test".
- 2) A survey was completed of counties throughout Wisconsin regarding Correctional Officers and their status under the Wisconsin Retirement System. Thirty-four (34) counties responded and results are as follows:
 - a. 29 'General status'
 - b. 1 'Combination of Protective & General Status'
 - c. 4 'Protective status'
- 3) If approved, the fiscal impact for the 2016 Budget year includes the following:
 - a. General category annual contribution is 6.6% for the employer & employee.
 - b. Protective service category annual contribution is 10.36% for employer & 6.6% for employee.
 - c. With the current correctional officer and jail sergeant wages, the additional 3.76% employer contribution would cost the County an additional \$111,000 for 2016.
- 4) Additional points:
 - a. That the civilian correctional officers do not qualify as protective occupation participants since they do not meet the criteria for protective status as set forth in Wis. Stat. § 40.02(48)(a) as interpreted by Wisconsin appellate court decisions.
 - b. That we have several Eau Claire County employees who work in challenging work environments on a daily basis and all bring an incredible value to the service we provide in the community.
 - c. That if correctional officers met the criteria for protective status the potential exists that they would then by definition be eligible for full collective bargaining rights. It should be noted that the resolution is meant to have correctional officers on par with state correctional officers.
- 5) We have no data to support a direct link between protective service and retention. There is a lack of substantive evidence to support that protective service will improve retention. The impact of wage increases through classification and compensation and the net result is as of yet unknown. In 2015 Eau Claire County had seven (7) Correctional Officer terminations; this does not include the individuals who transferred to other positions in the county.

- 6) County and State Correctional officers both have to be certified by the State of Wisconsin to work in a correctional environment, and are required to complete "Principles of Subject Control" training and annual recertification training. County correctional officers do not undergo firearms training, however state correctional officers do.
- 7) Job responsibilities between county and state employees are similar. Correctional Officers frequently deal with fights, disruptive inmates who may be high on drugs, medical emergencies, contagious diseases, assisting arresting officers with combative inmates, drug investigations, and other highly dangerous situations.

WHEREAS, Eau Claire County created the civilian correctional officer classification in 1990 and began the transition from a jail staffed by deputy sheriffs to civilian correctional officers at that time; and

WHEREAS, civilian correctional officers do not meet the principal duties test that 51% or more of their duties consist of active law enforcement duties as set forth in Wis. Stat. § 40.02(48)(a) as interpreted by Wisconsin Appellate Court Decisions; and

WHEREAS, correctional officers are classified as general employees under the Wisconsin Retirement System and deputy sheriffs are classified as protective service.

NOW THEREFORE BE IT RESOLVED that the Eau Claire County Board of Supervisors support a change in state law to make county civilian correctional officers protective status under the Wisconsin Retirement System.

BE IT FURTHER RESOLVED that the Eau Claire County Board of Supervisors directs the county clerk to forward this resolution to the governor, assembly members and senators representing Eau Claire County and the

TO FILE NO. 15-16/154

At the March 15, 2016 County Board of Supervisors meeting, Resolution 15-16/154 was referred back to the Committee on Human Resources. At its April 8, 2016 meeting, the Committee on Human Resources denied a request by a vote of 3 against, and 1 for, to support a change in state law to make County Civilian Correctional Officers protective status under the Wisconsin Retirement System.

The following items we discussed during regarding the proposed change:

- 1) A survey was completed of counties throughout Wisconsin regarding Correctional Officers and their status under the Wisconsin Retirement System. Thirty-four (34) counties responded and results are as follows:
 - a. 29 'General status'
 - b. 1 'Combination of Protective & General Status'
 - c. 4 'Protective status'
- 2) If approved, the fiscal impact for the 2016 Budget year includes the following:
 - a. General category annual contribution is 6.6% for the employer & employee.
 - b. Protective service category annual contribution is 10.36% for employer & 6.6% for employee.
 - c. With the current correctional officer and jail sergeant wages, the additional 3.76% employer contribution would cost the County an additional \$111,000 for 2016.
- 3) The committee discussed and acknowledged:
 - a. That the civilian correctional officers do not qualify as protective occupation participants since they do not meet the criteria for protective status as set forth in Wis. Stat. § 40.02(48)(a) as interpreted by Wisconsin appellate court decisions.
 - b. That we have several employees who work in challenging work environments on a daily basis and all bring an incredible value to the service we provide in the community.
 - c. That if correctional officers met the criteria for protective status then they would be definition be eligible for full collective bargaining rights.

This ordinance updates the county code regarding flying clubs at the Chippewa Valley Regional Airport to comply with changes in Federal Regulations issued March 9, 2016.

Section 1. Reflects the number of the FAA Order that was updated.

Section 2. Limits aircraft owned by flying clubs that may be used for flight instruction and limits compensation for flight instructors or mechanics to either monetary compensation or credit against payment of dues of flight time, but not both forms of compensation concurrently.
