Horticulture Educator Update

Erin is applying for an EPA grant. This grant includes a position for a sustainability coordinator. Will also support other educational events, including Eco Teams and Community Gardens. Grant is approximately \$91,000 with nearly \$68,000 towards the position. Twenty-five percent of the grant has to go to subgrants, awarded by the grant holders, at a maximum of \$5,000/each. The match from the county will be in-kind, other groups will match with monetary values. The grant is due in April.

Eau Claire County UW-Extension Wisconsin Nutrition Education Program /SNAP-Ed

The UW-Extension Wisconsin Nutrition Education Program (WNEP) is a contractual agreement with the USDA Food and Nutrition Service via the State of Wisconsin Department of Health Services.

Eau Claire County UW-Extension WNEP

ECC WNEP collaborates with community partners to target its education to FoodShare, FoodShare eligible or low income county residents in the areas of dietary quality, food safety, food resource management and food security. ECC WNEP staffing currently includes one full time coordinator, Nancy Coffey; and two full time nutrition educators, Pamela Warren-Armstrong and Joy Weisner.

In cooperation with over 30 community agencies and organizations, Eau Claire County (ECC) WNEP provided almost 11,500 face-to-face direct teaching contacts with 2,218 non-duplicated learners in 2015. 98% of those WNEP teaching contacts involved multi-session teaching. Most learners participated in five or more lessons. IN 2016, ECC WNEP secured \$212,800 from Federal SNAP-Education funds to run the program.

2017 ECC WNEP Programming and Funding

2017 Funding is \$218,500. Funding allocation will be cut to \$175,000 in 2018. **WNEP direct teaching goals** planned include:

- Improve dietary quality for youth and adults. Group classes are taught by WNEP in school (Head Start, 1st, 3rd and 5th graders) and afterschool programs at low income schools. WNEP youth classes are also provided at McKinley Charter School, NW Juvenile Detention Center, Workforce Resource youth programming, Boys and Girls Club and Hmong Middle School Building Bridges Program. Adult programming is offered at Literacy Volunteers, Augusta School District, ECASD and Western Dairyland Head Start, Woodsedge Apartments, Workforce Resource with F-Set & W-2 clients, EC City Housing Authority, Park Towers Apartments and the Family Resource Center for Eau Claire County.
- Maximize food dollars of individuals and families of limited income through classes and WIC Shopping Matters tours at grocery stores. WNEP resource management classes are provided at NW Juvenile Detention, Workforce Resource (youth, adult W-2 and adult F-Set programs), Western Dairyland Fresh Start, EC City Housing Authority, and LSS Transitions and Affinity House.

WNEP Joins Community Collaborative Efforts to Prevent Obesity and Increase Food Security
To be effective in improving residents' health and wellness, communities need to be cognizant
of the relationships between food insecurity, health and chronic diseases, and their long term
impacts on health disparities. WNEP will use a collaborative approach to align with community
systems to make the healthy choice the easy choice for the low income residents we serve.

• Partner to promote and facilitate Eau Claire Downtown Farmers Market - Market Match Incentive Program for FoodShare participants.
In 2015, a new Market Match FoodShare incentive program was added at the market token program. With Market Match, for every dollar token a FoodShare patron purchases with their Quest card, their dollars are doubled up to \$10 per week. For 2016, Market Match funds include: EC City (\$4,000 for promotion), United Healthcare (\$2,000), JAMF (\$2,500) and Group Health Cooperative (\$7,500).

In 2015, with the token program and Market Match, unduplicated FS patrons rose to 288, a 75% increase from 2014, and increased FoodShare sales to \$8,122. Including the \$5,903 of direct Market Match dollars distributed to FoodShare patrons, as well as \$9,519 in credit/debit token sales, a total of \$23,544 was brought into the 2015 market. Through the life of the Market Match and token program (2012-2015), over \$52,000 of income has been generated for the market.

- Food as Medicine Planning Partnership is working to create a strategic plan to increase access to healthy food for low-income ECC residents. Feed My People Food Bank Director, UWEC Nursing Professor and Coffey, WNEP Coordinator; the Food As Medicine Partnership (FAMP) core team were awarded \$50,000 Wisconsin Partnership Project 2 year planning grant, ending in May 2016. Partnership member representatives include: clinics, hospitals, health insurance companies, City-County health department and non-profits as well as community members of limited income. Currently the FAMP team is working to acquire funds to pilot implementation of the food insecurity screening tool in at least four healthcare and nonprofit settings and connect food resources to those who are food insecure.
- Partner to increase awareness and volunteer assistance to improve Food Security.
 Hidden Hunger quarterly newsletter currently emailed to 250 community residents.
 Coffey, the WNEP Coordinator, leads this initiative through Hunger Prevention Coalition for Eau Claire County.
- Partner with Healthy Communities Chronic Disease Action Team Retail Grocery Store
 Initiative to increase access to healthy foods and reduce obesity.
