Judge Gabler called the meeting to order at 7:33 a.m.

Review/Approval of Minutes / Discussion - Action

• February 17, 2016

ACTION: Kathy Schauf made a motion to approve the minutes as presented. Motion carried by unanimous consent.

Old Business - Program Updates

a. EBDM & Justice Reinvestment Initiative (JRI) – Tiana – Discussion

JRI funding has provided a half time case manager (Miranda) working with the Methamphetamine program. The funding is also being used for contracting with Farhman Center for intensive case management for individuals with meth addiction.

b. <u>State EBDM Update – Tiana – Discussion</u>

Application for Phase VI is due in June, working with the state EBDM team. The team is working on pretrial reform and the state bail system.

c. Methamphetamine Response Committee Update – Gary – Discussion

Gary provided an update on the spike of intakes at court and jail population for individuals with methamphetamine related charges.

d. <u>Strategic Planning Review – Discussion</u>

Tiana reviewed the four priorities that were developed last year for the council's strategic plan. After review, it was determined that they have good progress or will be addressed this year. She mentioned that it would be beneficial to have a local training.

e. Recent Meetings/Trainings - Discussion

The group mentioned the NIC pretrial conference in Colorado and the "Stepping Up" initiative program in Washington D.C.

2. New Business

a. NIC Pretrial Conference Review - Discussion/Action

Tiana briefly mentioned the recent conference that was attended in Colorado discussing pretrial programs.

b. "Stepping Up" Initiative – Tiana – Discussion/Action

Gregg provided a summary of the national Stepping Up Initiative to reduce the prevalence of individuals with mental illness in the jails. Eau Claire County was selected to attend the initiative "kick off" program in Washington D.C. this week.

c. Juvenile Security & Facilities - Discussion/Action

Tim provided information regarding any juveniles that are being brought down to court from the detention center and that they are brought down with blue jumpsuits and shackles. A group of individuals are assessing the need for the use of these measures and drafting a policy to address these changes.

d. Comprehensive Community Services (CCS) Application Update – Diane C. –Discussion

Diane mentioned that the county is certified for the Comprehensive Community Service program through the state as of April 1. The department has already received the first applications and will continue to build the program.

e. "Hot Topics" in your field – Discussion/Action

Jail holds were discussed at length. It was suggested to develop a resolution. Further discussion will be made with DOC staff. This item will be brought back to the June full council meeting.

f. Other

Dr. Justin Patchin's "It seems to me" article addressing university funding.
