The meeting was called to order by Chair Patrick LaVelle at 5:30 p.m.

1. Confirmation of meeting notice - Meeting notice was confirmed.

- 2. Approval of minutes from June 8, 2016 meeting Bruce moved to approve the minutes; motion carried 4-0.
- 3. Public Input No members of the public were present for this item.
- 4. Report from Eau Claire County Highway Commissioner Jon Johnson was present for this item. He said the Highway Committee had asked both Parks and Forest and Judiciary and Law Committees to discuss dumping. Kevin shared his ideas like studying what has worked on a national basis, media campaigns, and social medial. Pat wondered if the Sheriff's Department has any night vision cameras as that seems to be the time of day when dumping happens. Kevin said the Parks & Forest Committee are interested in collaborating with Highway and Judiciary and Law and would suggest a multi-pronged approach.
- 7. Lake Altoona Master Plan Phil Johnson of Ayres Associates was present to discuss this item. He said the public is apathetic on this issue as very low attendance at the listening sessions indicated. He presented three different directions the committee could choose to proceed in developing the master plan: 1) Public water utilizing the water component as the major emphasis; 2) Enterprise whereby a private entity develops and operates park activities/functions; and 3) Group/public. After discussion by the committee, it was decided to go the direction of Group/public. Phil indicated then that Ayres will formulate the master plan from a group use perspective. Phil also noted that he and Josh will be meeting with the City of Altoona Planner to talk about the park. Tami suggested inviting users and Phil stated they had already provided input.
- 5. Timber Sale Extension Requests Kevin made a motion to approve the Timber Sale Extensions as recommended by staff; motion carried 4-0.

- 6. 2016 First Quarter Budget Report Presentation Bobbi handed out an updated report correcting the levy amount to zero.
- 8. Expo Center Status Report Josh reported things are moving along, however, there is no new information to report.
- 9. Franks Property recommendation from Stewardship Committee Kevin reported he had been authorized by the Stewardship Committee to offer Mr. Franks \$125,000. Mr Franks countered at \$139,000 and Kevin came back with the maximum amount of \$135,000 which was the maximum offer from the Stewardship Committee. Bruce and Pat thought Kevin should offer Mr. Franks \$137,000 with contingencies stated such as closing costs to be paid by the county, grant from state Stewardship Fund is awarded, and funding gap is closed. Bruce made a motion to authorize Kevin to offer the seller \$137,000 with contingencies; motion carried 4-0. The committee thanked Kevin for his work on this project.
- 10. 2017 Budget Process Nothing to report.
- 11. Correspondence Josh was contacted by the Army National Guard about doing a clean-up at Big Falls July 23. Kevin suggested maybe they could also remove the concrete tables and demo one of the sheds at Pinter Pines. Josh will contact them.
- 12. Staff and committee reports Nothing to report.
- 13. Parks and Forest Advisory Committee input and assignments: nothing to report.
- 14. Expo Advisory Committee input and assignments: nothing to report.
