### **MEETING MINUTES**

The meeting was called to order by Chair Patrick LaVelle at 5:30 p.m.

1. Confirmation of meeting notice – Meeting notice was confirmed.

- 2. Approval of minutes from June 22, 2016 meeting Bruce moved to approve the minutes; motion carried 4-0.
- 3. Public Input No members of the public were present for this item.
- 4. Expo Center Status Pat reported he attended an Administration Committee meeting and things are moving along. He was satisfied that an agreement could be made between the county and Curlers.
- 6. 2017 Budget Process Josh stated there was nothing to discuss as he was waiting on projected personnel costs from Finance/Human Resources Departments but would likely have a draft of accounts ready at the next meeting. Ms. Schauf added that by postponing forecasting health insurance costs by a month the estimate would most likely be closer to the actual costs for 2017.
- 7. Correspondence Nothing to report.
- 8. Staff & Committee Reports Josh reported the playground on the dayside at Coon Fork Lake Park was nearly completed. Some projects are beginning to fall behind due to staff taking PTO.
- 9. Expo Advisory Committee Josh felt that the committee would have issues to discuss after the agreement between the Curlers and the county was ratified.
- 10. Parks & Forest Advisory Committee Nothing to report
- 11. Committee Meeting Dates No changes.
- 12. Future and pending items Nothing to report.

- 13. Lake Eau Claire Association Report Rod Zika, Marlo Orth and Vicki Reed were present from the Lake Association. Rod Zika showed a promotional video for Lake Eau Claire and gave a PowerPoint presentation on the Lake Eau Claire Management Plan and Goals.
- 14. Tour Facilities The committee, staff and lake association members boarded a pontoon and toured Lake Eau Claire.
- 5. Stewardship Committee Report Kevin reported that the state Stewardship Grant required property be in an individual's ownership for three or more years to receive the full grant amount. In light of that requirement, the Frank Property could not be purchased in full and the Stewardship Committee may make an offer for only the portion with river frontage. He added another parcel is being considered. The committee thanked Kevin for his work on this project.

Motion by Bruce to adjourn. Motion carried and the meeting adjourned at 7:55 p.m.
