Chair Leary called the meeting to order at 5:15 PM.

Review / Approval of Committee Minutes / June 15, 2016

Motion by Supervisor DeLuka to approve the minutes as distributed. Motion carried 3-0.

Review Bills / Discussion / June 2016

The bills were reviewed.

Public Input

No members of the public present.

Youth in Governance Update / Discussion – Action

The committee generated ideas on how to increase participation from area high school youth. Supervisor Bates made a motion to approve Resolution Number 16-17/026 to extend the Youth In Governance program for the committees on UW-Extension and Judiciary and Law and expanding to Parks and Forest Committee. Motion carried 4-0.

Update on WACEC State Conference / Discussion

Supervisors Bates, Schraufnagel, DeLuka, and Leary attended. Discussion at conference focused on the state budget. Increase discussions, town halls, and meetings with the county partner will be expected in the future of reorganization of UW-Extension.

Update on *nEXT Generation* Model and Hub Situation / Discussion – Action

Current discussion across groups indicate that changes will be determined in early 2017, but won't take effect until after the new fiscal year of 2017-2018. Faculty and academic staff have signed contracts through June 30, 2016 at this time.

Greenhouse Update / Discussion

Will appear on the August agenda as Erin LaFaive was unable to attend July meeting.

Preliminary Budget Updates / Discussion

Upcoming budget hearings in the near future for all county departments. Agents and UW-Extension supporters encouraged to attend. From the UW-Extension side, salary increases are being planned for Mark Hagedorn (move to full professor in the Department of Agriculture/Agriculture Business) and Erin LaFaive (move to senior lecturer) and a two percent raise for UW-Extension staff. Erin and Sara will share changes to office budget as it progresses.

Agriculture Program Update / Discussion - Action

Mark Hagedorn shared multiple areas of education for fair participants and fair goers, including increased education on animal well-being and care, RFID tags for market animals, and increased biosecurity practices. Mark continues to be actively involved in working with the 4-H Youth

Development Agent in youth agriculture programming, including increasing participation and educational events for youth in the dairy project, which will see its largest numbers of entries in five years at the 2016 county fair.

Scheduling of Future Meetings / Agenda Items

The next meeting is scheduled for August 31 at 5:15pm at the UW-Extension Office. Agenda items include updates on nEXT Generation, the greenhouse, budget, and an educator report from the Horticulture educator Erin LaFaive.

Greenhouse update 8/25/16 By Erin LaFaive

Current location of the Greenhouse

Greenhouse materials are being stored at Steve Terwilliger's house in Eau Claire. He and his daughter, Hanna, helped build it. Hanna was the UWEX Eau Claire County 2015-2016 AmeriCorps VISTA. He is willing to put it back together and add aluminum reinforcements to the frame.

Insurance & Warranties

County insurance has a \$5,000 deductible and the greenhouse cost just under \$2,000. I called the company and they said there isn't any warranty or guarantee due to acts of nature.

Future Plans for the Greenhouse

Steve estimates it will take \$200-\$300 to add extra supports and replace a few of the broken panels.

I think the greenhouse should be moved to the SouthSide Community Garden. I think it would get more use than at the Jeffers Garden spot because of being in the city near walking/bike trails and bus routes. Only 3 people have rented it since we've put it up Also, there's a bit more wind break over there.

I'd have to go through the permitting process again, and Southside Garden would have to amend their agreement with the City of Eau Claire.

It wouldn't work at Forest Street Community Garden because they are in a FEMA floodplain and this structure would be in compliance with those rules.

Lakeshore Community Garden I suspect is too small to hold a structure in their space.

I'm not sure if Demmler has space for a greenhouse this size.



UW-Extension Eau Claire County 2017 Budget

University of Wisconsin-Extension is a unique partnership of counties, the U.S. Department of Agriculture, and the University of Wisconsin working together to help people put knowledge to work. It reflects the vision that has become known as The Wisconsin Idea. This partnership brings education to people where they live, through Extension offices, in each of Wisconsin's counties. It supports educational programs for farmers, businesses, communities, families, and young people. In 2016 staff worked to bolster and expand programming through cost effective and innovative means including: AmeriCorps VISTA employees, interns, grants, increasing user fees, and partnering. For every \$1 of county levy money applied to the local county extension office in 2016, residents received more than \$5 back in the form of leverage from volunteers, grants, donation, and equipment. Extension educators developed new programs to help residents cope with present and impeding challenges including: food insecurity, farm transfers, and assistance to youth and families and those reentering the community after incarceration. We look towards the future to continually changing community needs.

Programs & Services

The programs and services provided by the UW-Extension Department include:

<u>Agriculture</u> – promotes profitability and responds to the needs of the farming community with research based, unbiased information and resources. Agriculture contributes over \$600 million in economic activity for the county and over 4,000 local jobs annually. This program works to help modernize farms and assist with farm succession, helped sustain jobs in agriculture in Eau Claire County. (Strategic Plan Issues #3, #4, #5).

<u>Eau Claire County Fair</u> - educates supports and honors county youth through the venue of a well-run, family-oriented, and sustainable fair. The Fair Committee is a working committee comprised of volunteer members that provide hands-on guidance and assistance with oversight from the UW-Extension office and the Extension Education Committee. The fair committee and volunteer groups continue to expand outreach and programs for attendees and had higher attendance and support in 2015. (Strategic Plan Issue #3).

<u>Family Living</u> —helps families understand child development and respond to parenting challenges and issues; helps families move toward economic and personal stability; works to prevent substance abuse; and develop community organizations and resources to support underserved groups including: homeless, formerly incarcerated, and immigrant populations. Programming continues to focus on "digital parenting," helping to educate and empower parents and caretakers of youth via safe technology use. (Strategic Plan Issues #2, #3, #4, #5).

<u>4-H & Youth Development</u> - responds to the needs of the community relating to youth development. Opportunities range from traditional 4-H club activities to generalized youth programs, after school programs, camps, and others that serve youth of all ages in the county. This year, the after school program continued to expand outreach in new schools as well as day camps, utilizing among other resources, a new 4-H summer intern. Life skill development continues to be a major focus in programming for both youth in 4-H clubs as well as youth in outreach programming. (Strategic Plan Issues #1, #2, #3, #5).

<u>Horticulture</u> – provides horticultural and environmental information to consumers and businesses through educational and volunteer programs and media using university based resources. Assistance is provided to the public through answering walk-in, phone call, and email questions about gardening, plant identification, diseases, pests, and invasive species. Helping the public grow nutritious food in an economical and environmental sound way. (Strategic Plan Issues #1, #2, #3, #4).

<u>Wisconsin Nutrition Education Program (WNEP)</u> - provides USDA money to make local education efforts possible. Educators provide community based nutrition education designed to help low income individuals and families choose healthy foods and active lifestyles. WNEP collaborates with over 25 community partners to assist low income county residents in the areas of dietary quality, food safety, food resource management, and food security. WNEP staff continues to partner with UW-Eau Claire AmeriCorps VISTAs and uses grants to employ a new system at the Downtown Farmers Market that makes it possible for area residents to use QUEST and debit cards. Vendors have new business from low income residents. Access to healthy, locally grown food has improved (Strategic Plan Issues #1, #2, #3, #4, #5).

Budget Explanations

Our budget, just as many in the County, is developed around wages and fringe benefits. UW-Extension staff salaries will increase in the amount of \$5,042, due to promotions and 2% state pay raises due July 2017. We were able to balance our 2017 budget by decreasing operational costs and reallocating funds. Specifically, we eliminated the overtime line item as we only have 3 part-time

Administrative Specialists and reduced the printing and duplicating line item.

Our biggest challenge will occur with the 2018 budget and beyond. While we have a balanced budget for 2016 and 2017 we have continually reduced our operational budget to meet salary and staffing needs. Programs are continually evaluated to meet the needs of the Eau Claire County community, the County's strategic plan, and the UW System. In order to maintain our current tax levy value, while facing changes in personnel costs and position descriptions and costs associated with this and future biennial budgets, extensive changes will be seen in our budget.

Challenges

Challenges for the 2017 budget center around working through the transition of the UW System budget cuts and position description changes. These changes affect the current vacant Office Manager position that was vacated by Karen Blaeser due to retirement. We currently have a LTE at 29 hours per week to manage the financial portions of the UWEX Eau Claire County office. However, if the county based Department Head role is eliminated from the UWEX structure, an Office Manager is critical to continued organizational success of the local county UWEX office. This timeline creates a challenge because we are not certain the UWEX Administration will have the department head roles established by the time an Office Manager decision needs to be made. Current contracts run through June 30, 2017 with anticipated changes to position in UWEX occurring Summer and Fall of 2017. LTE can only go until mid-April as we need to make a decision about hiring an Office Manager or changing the position to a Financial Specialist.
