<u>Intergovernmental Cooperative Agreement Between Eau Claire County and the Village of Fairchild / Discussion - Action</u>

Keith Zehms and Janet Loomis were present to review with the Committee the Intergovernmental Agreement between Eau Claire County and the Village of Fairchild. Village officials will be meeting on Thursday, August 18th to review language in the agreement. If approved by the Village of Fairchild, a resolution and the Intergovernmental Agreement will be forwarded to the September 20, 2016, county board meeting in September. Motion by Supervisor Leary to approve of the Intergovernmental Agreement as written with the Village of Fairchild. Motion carried.

<u>Proposed Resolution / 16-17/039 / "Resolution Awarding the Sale of \$12,795,000 General Obligation Promissory Notes, Series 2016A" / Discussion - Action</u>

Sean Lentz from Ehlers & Associates, Inc. reviewed with the committee the recent sale of general obligation bonds. He also informed the committee that Eau Claire County had received a bond rating of Aa1. Due to lower interest rates, the new borrowing amount is \$12,630,000. Motion by Supervisor Pagonis to approve of the resolution awarding the sale of \$12,630,000 General Obligation Promissory Notes. Motion carried.

<u>Proposed Resolution / 16-17/040 / "Resolution Authorizing the Issuance and Sale of \$14,540,000 General Obligation Refunding Bonds, Series 2016B" / Discussion – Action</u>

Motion by Supervisor Conlin to approve of File No. 16-17/040, Authorizing the Issuance and Sale of \$14,540,000 General Obligation Refunding Bonds. Motion carried.

Chairperson Jim Dunning called the meeting to order at 4:30 pm.

<u>Condemnation Order / Tax Delinquent Property in Village of Fairchild / Committee</u> <u>Consideration of Process</u>

Janet Loomis, County Clerk, was present to discuss property owned by Dorothy McDonald in the Village of Fairchild where a condemnation order was issued. Property is tax delinquent back to 2011. County Clerk wants to get input from the committee as to next steps; Corporation Counsel advised not to do anything.

Handling of Vouchers and Payments Over \$10,000

Corporation Counsel needs best practices from Clifton LarsenAllen. Bring back to next meeting.

Recycling Program Budget Amendment / Discussion – Action

Matt Michels from Planning and Development is requesting a budget amendment to the 2016 county budget as an increase to the recycling grant appropriation for fiscal year 2015-16 was approved by the state assembly and signed by the governor (Wisconsin Act 392). This amounts to a restoration of \$86,793 in additional funding to Eau Claire County of the nearly \$110,000 grant funding reduction. Michels discussed that the following priority areas would be fulfilled upon receiving the additional recycling grant funds:

- Use of Fund Balance
- Fulfill Contractual Obligations
- Public Outreach
- Replace Aging Infrastructure

There is no impact to county levy and the Committee on Planning and Development endorses the budget amendment. Motion by Supervisor Leary to approve of the request as submitted. Motion carried.

In Rem vs. Tax Deed / Consideration of Positives and Negatives Discussion – Action

Keith Zehms, Corporation Counsel briefly reviewed the difference between In Rem vs. Tax Deed. How does the process differ? A concern made is how do we manage from a staffing standpoint? It was stated that some Wisconsin counties do both. Other concerns made were with contaminated properties.

County Treasurer, Glenda Lyons, doesn't know which one is more efficient. County Administrator stated that In Rem should be used where the properties are more valuable – this would give the county a better return. Also, there is a better bidding climate with In-Rem. Committee would like more information; i.e., best practices; how it's worked for other counties and how other counties divide duties amongst departments. It was recommended that staff contact other counties that have both processes in place. County Administrator suggested that a flow chart be drawn up. This item to be layed on the table.

Internal Controls / Progress, Planning & Priorities / Discussion - Action

Cash handling project: working in respective areas and documenting changes. An update will be provided to Committee and a response will be drafted by departments based on the report that was submitted.

Living Wage Ordinance / Discussion and Consideration / Action

Committee reviewed the living wage ordinance and the action taken by the Human Services Board, Committee on Human Resources, Committee on Finance & Budget and Aging & Disability Resource Center Board. There are a number of amendments and other documentation that have been added to the "pending legislation" link on the county's website.

Staff will be working on estimates regarding how much this ordinance will cost the county.

2017 Budget / Discussion - Action

<u>Capital Improvement Plan and Debt Service</u>: committee received a capital projects request summary sheet.

<u>Budget Survey</u>: Chairperson Jim Dunning and Sharon Rasmusson from Administration will meet to review budget survey. Goal is to have the 2017 budget survey on the county's website by the end of July.

Proposed Resolution / Initial Resolution Authorizing the Borrowing of Not to Exceed \$13,000,000

As part of the approved 2016 Eau Claire county budget, the County Board approved borrowing of \$12.626 million in general obligation debt to pay for highway projects, information systems software/hardware, general building repairs and maintenance, vehicle replacement and contribution to the construction of the Confluence Community Arts project. Scott Rasmussen, Finance Director estimates that this issue will add approximately \$1.5 million in additional debt service payments for each of the years 2017-2026, based on a 10-year payback.

Motion by Supervisor Conlin to authorize the borrowing of not to exceed \$13,000,000 for capital projects named above. Motion carried.

<u>Resolution Providing for the Sale of Not to Exceed \$15,000,000 General Obligation Refunding Bonds / File No. 16-17/033 / Discussion – Action</u>

As part of Eau Claire County's financial services contract with Ehlers, there is an obligation to monitor opportunities for the county to refund or refinance existing debt at lower interest rates. In working on the 2016 debt issuance to fund approved capital projects, Ehlers identified the 2008 issuance of \$25,000,000 General Obligation Building Bonds for potential refunding. The refunding is expected to reduce interest expense by approximately \$183,000 over the next 11 years. The estimated savings presented would be pure interest savings.

Motion by Supervisor Conlin to approve of the sale of not to exceed \$15,000,000 in general obligation refunding bonds. Motion carried.

2017 Departmental Budget Presentation / Discussion – Action

a) Finance Department

Scott Rasmussen, Finance Director, presented the 2017 Finance Department budget to the committee. Motion by Supervisor Smiar to accept the 2017 Finance Department's budget as presented.

Committee adjourned to the Public Input Session at 6:26 pm. Members introduced themselves to those that were in attendance.

Chairperson Dunning provided a brief overview of the 2017 county budget process. He told the audience that the Committee likes to hear what programs/services are important. In addition he encouraged people to take the budget survey for additional feedback.

Carl Anton

- Sr. Center Program. Wants the county to continue funding as this is a great way for the elderly to stay in their homes; provides meals and a social environment.
- Living Wage: Social Injustice. Need to recognize that services provided are not disadvantaged by the living way ordinance.
- Concerned about roads and funding concerns

Ann Hurst

• Wants county to continue supporting the rural initiative program (funds provided by the Family Resource Center). This program offers GED prep, counseling needs through CVTC (adult basic education)

Barb Pritzl

- Augusta Senior Center Director Senior Center serves the entire community
- Flu shot clinics
- WIC

- Options Counselor from the ADRC comes twice a week to center
- Elder Benefit Specialist visits
- Concern with Living Wage ordinance (meal site may have changes)
- Uncertain of Title III B funding
- Senior Center has sustained funding; yet no increase in funding since Barb has been Director
- Approximately 450 visitors per year visit the Center

Marlo Orth

- Lake Rehabilitation Fund / Lake Eau Claire Association
- Appreciates the collaboration with Land Conservation, Parks & Forest and DNR
- Need to take care of sediment

<u>Fred Poss</u> (President of Lake Eau Claire)

- \$100,000 request
- Need to clean sand traps every 2 years
- Aeration system costs \$2,000/month to operate
- Installed 199 fish cribs in lake
- Heron population is growing
- Wants continued support from county

Mike Lee

- Installation of an emergency warning siren on Lake Eau Claire (daughter's project)
- Total cost of \$25,000 (working on funding)

Roxanne Traczek

• Appreciation for rural initiative programs and financial assistance of program, especially the Play Pals program for the kids.

Nicole Conklin

- Preschool play group / community development
- Village of Fairchild needs revitalization county and village need to collaborate

Del Thorson

- Continued support to operate the Senior Center at current levels.
- Sr. Center provides meals, companionship
