# **MEMORANDUM**

SUBJECT: Psychiatrist and Psychologist Fees

The county board at Sec. 4.15.010 of the County Code pursuant to Wis. Stat. 51.20(18)(a) has established fees for professional examiners and witnesses in involuntary commitment actions. Licensed physicians, including psychiatrists are currently paid \$256.00 per hour and licensed psychologists are paid \$150.00 per hour. Each year our office does a survey on psychiatrist and psychologist rates, a copy of which is attached. The average rate for psychiatrists is \$392.67 per hour and for psychologists is \$295.43 per hour.

Last year the county board increased the medical doctor/psychiatrist rate from \$222.50 to \$256.00 per hour and the psychologist rate from \$134.00 to \$150.00 per hour. The previous year the rates were increased by 3%. My recommendation is an increase between 3% and 4%, specifically that the medical doctor/psychiatrist rate be raised from \$256.00 to \$265.00 which would equate to an increase of approximately \$1448.00 and the psychologist rate be increased from \$150.00 to \$155.00 which would equate to an increase of approximately \$2102.50 for a total increase in 2017 of \$3550.50.

We have had quite a bit of difficulty in 2016 obtaining psychiatrists to do examinations and to testify. Although the proposed increase will not solve that issue, we will not fall farther behind.
