1. Call meeting to order

Chairman Henning called the meeting to order at 6:21 a.m.

2. Confirmation of meeting notice - Review

3. Past committee meeting minutes (1/5/) - Review/Action

Motion: Ray Henning to approve meeting minutes. Motion carried 5-0

4. Public comment -

Gloria Adams inquired on how wide is a CTH from center to right of way? Commissioner Johnson explained that most CTH are 33 from the center line in each direction but it does vary in some cases. Suggested putting together a map that indicates CTH width to be created and put on the Highway department website in the future.

5. Parking Ordinance CTH KB – Review/Action

Commissioner Johnson handed out a final draft of a parking ordinance in relation to school events and parking on CTH KB. No parking signs have been placed and ordinance was discussed at the Altoona's school PTO meeting. Motion by Supervisor Clark to forward ordinance to County Board for review. Motion carried 5-0

- Post storm meeting to be held with operations and share lessons learned.
- Shared letter of appreciation received by the Highway Department concerning assistance given to a motorist during last winter storm.
- Communicating with City of Eau Claire on ways to increase communication during snow plowing. Looking into similar radios to be able work together for more efficient snow removal. May apply for assistance through the innovation fund.
- Meetings to be held with cities and townships of areas affected by upcoming CIP projects.
- Discussing policy concerning formal bid process and working with Purchasing concerning bridge proposals.
- Strategic goal to review and update County Code.
- Meeting new representatives concerning state property located near the State Patrol.
