1. Call meeting to order

Chairman Henning called the meeting to order at 6:16 a.m.

2. Confirmation of meeting notice - Review

Meeting notice confirmed.

3. Past committee meeting minutes (3/2/17) - Review/Action

Motion: Supervisor Clark moved for approval. Motion Approved 5-0

4. Public comment -

5. Update on inquiry with DOT and planning on state property-Discussion/Action

In discussions with the DOT and planning, Commissioner Johnson was advised that the property will need to go through Chapter 16 which opens discussions to all state agencies for acquisition prior to county interest. This may take upwards of 12-18 months to learn if property is available. If available for county acquisition the property would require an appraisal and environmental survey which cost incurred may fall on the interested party as well as the value of the property.

Motion by Supervisor Clark for Eau Claire County to initiate a formal process for identifying alternative site locations. Motion approved 5-0

The 120 acre property owned by Eau Claire County which includes the Lowes Creek Park was also discussed as an option to look into for site consideration. The Highway department would need approximately 40 acres of the 120 acres available at this location. Utilizing county owned property would save money in comparison to purchasing property.

6. Staff and committee reports - Discussion/Action

Commissioner Jon Johnson spoke on the following:

- CIP for CTH K was bid out and came in under the estimate. Project will start right away in the spring.
- The department has received some internal and external application for the open positions.
 Application period ends on Sunday, March 19th.
- Department has gone to weekly accounts payable payments to improve on timing.
- One truck remains of the large fleet to be delivered and bidding out of next round of trucks will occur soon.
- Offsite storage facility lease runs through 2017. The storage was acquired for machinery that
 otherwise would have sat outside for the winter and has proven very beneficial.

Staff and committee report continued

- Department is working with Sherriff Kramer to acquire equipment needed when they become available. Currently the department is in need of a forklift.
- Department is going through our yard and auctioning any items that we no longer have a need for.
- Attending NACE conference in April in Cincinnati. Conference will be held in Eau Claire in 2018
- Has been elected the board for the Wisconsin County Highway Association.
- Advised on regulations that prohibit the committee as a group to meet and discuss county business at an unscheduled and unpublicized meeting.
