1. Call meeting to order

Chairman Henning called the meeting to order at 6:17 a.m.

5. Update on Altoona property easement – Discussion/Action

This easement adds and gives rights to Xcel energy to be in the existing easement. Purpose is to provide gas service to a backup generator for the cell tower located on the Altoona Highway property. Motion: Supervisor Clark moved to approve adding Xcel to existing easement. Motion Approved 5-0

6. Staff and committee reports - Discussion/Action

Commissioner Jon Johnson spoke on the following:

- General journal entries have been completed for 2016. Working with CLA on updating the balance sheet.
- 2017 bids are out for asphalt and materials. Possible savings of up to 10% on CIP projects due to asphalt prices trending lower than originally anticipated. Also working with local townships and departments with our bids to share in cost savings.
- Meeting scheduled with purchasing in two weeks to discuss more on the bid process.
- Met and shared with townships information on the 50/50 bridge program and its benefits.
- Large fleet update. All of the large fleet trucks have been delivered. Receiving credit from vendor for timelines not met for delivery of 4 trucks. Joint meetings or discussions with finance will occur to discuss funding for continued replacement of aged large fleet.
- Small fleet update. 5 trucks were received last Friday and remaining 5 were received today, which was 3 months ahead of schedule.
- Interviews were completed for the lead positions as well as the Shop Supervisor
- Chairman Henning and Commissioner Johnson to attend a transportation conference in Madison in May.
- Next week, will be attending the NACE conference at the Wisconsin booth in Cincinnati. Next years conference will be held in Wisconsin.
- Attended a conference in Madison a week ago where there was good dialogue at the state DOT level on funding.
