The meeting was called to order by Chair Patrick LaVelle at 5:00 p.m.

- 1. Confirmation of meeting notice Meeting notice was confirmed.
- 2. Approval of minutes from April 25, 2017 Meeting Kevin made a motion to approve minutes from the April 25 meeting; motion carried 5-0.
- 3. Public Input No one was present to speak on this item.
- 10. Lowes Creek Park Reclamation Project Update Josh stated there was nothing to report.
- 5. American Legion Post 53 Auxiliary request to use Expo Center September 21 and 22nd Jane Dale with the American Legion Auxiliary and Tom Moore, Veterans Services were present. The event is called "Stand Down" will offer services to homeless veterans like a warm and nutritious meal, medical services, employment opportunities, as well as take away items like clothing, sleeping bags and hygiene items. Tim offered to supervise the event volunteers which will include set—up on September 21 and then during the event on the 22nd as well as take down. Kevin thought Tim should work with Clint. Bruce, a WWII veteran, made a motion to let the event take place at no charge with Tim Moore, Veteran's Officer supervising volunteers and working with Clint; motion carried 5-0.
- 4. Award Timber Sales Brooke answered questions on the timber sale bids. Tow sales received no bids and will be offered again the fall. Markets are down so Kevin advised Pat to include an explanation to the county board when reporting on the Spring Timber Sale results. Kevin made a motion to award the timber sales to the highest bidder; motion carried 5-0.
- 6. Request to add .19 FTE Forester to staff Josh gave background information on the request. There is funding for this position and Human Resources has requested this be added to as permanent staff position at 400 hours annually. Kevin said it makes sense to keep the position as long as we are under our annual allowable cut. Bruce moved to establish this position as permanent; motion carried 5-0.
- 8. Lake Eau Claire Dredging Project County Administrator Kathryn Schauf was present along with Greg Leonard, Land Conservation Division County Conservationist and stated the viability of lakes is essential to Eau Claire County. Kevin had contacted a and mine company about the possibility of using the spoils materials for reclamation of sand mines but hadn't gotten word on their decision. Administrator Schauf suggestions all options be explored in order to come to an acceptable plan for all parties. Marlo stated they wanted to be good partners with the county to save the lakes for the future. Vicki Funne-Reed of the lake district is hoping to come up to a solution for the "long Haul" and trying to have a solution in place prior to needing the site to deposit spoils. Kevin proposed another site and

Brooke stated there will be increased costs. Administrator Schauf suggested Greg, Josh and Brooke do an analysis of sites suggested and bring back to next month's meetings. Tami suggested those sites be included in the park tour which was set for the 2nd Wednesday in June at Lake Eau Claire Park – June 14.

- 11. Expo/Curling Club Lease Extension The county submitted a proposal to the Curling Club and are waiting for the Curler's Board to act on it.
- 9. Lake Altoona Master Plan Josh talked with Phil Johnson about changing the plan to accommodate suggested changes in the plan by the Ski Sprites. Phil had not gotten back to Josh.

16	camping unit must be removed from the county forest for at least one night before the camping		
17	party is eligible to return. Any camper or campers who violate the rules and regulations of this		
18	chapter or of good conduct, including cutting or defacing timber, carelessness with fire, violation of		
19	game, fish and litter regulations shall be subject to ejection from the county forest and subject to the		
20	penalties provided by or	dinances and state law.
