The meeting was called to order by Chair Patrick LaVelle at 5:00 p.m.

- 1. Confirmation of meeting notice Meeting notice was confirmed.
- 2. Approval of minutes from May 9, 2017 Meeting Gary made a motion to approve minutes from the May 9 meeting; motion carried 5-0.
- 3. Public Input No one was present to speak on this item.
- 8. Lowes Creek Park Reclamation Project Update Josh stated there was nothing to report.
- 4. Tower Ridge Disc Golf Tournament and Illegal Parking Issue Troy reported that there were 153 golfers, 57 passes were given out and because of all the rain, cars got stuck in the parking lot and had to park on the road. Tom said lots of work has been done on the courses including 15 cement pads. He also said there are a few wet areas that need consideration. CVDGO will work with the department to see if anything can be done to remedy the situation.

- 6. Lake Altoona Master Plan Josh announced that Phil Johnson with Ayres & Associates is retiring June 2 and Chris Silewski will be taking his place. Kevin said he'd rather the plan be flexible rather than hard and fast and that 3-D or animation wouldn't be necessary. Josh will ask for a new proposal. Kevin moved to authorize Josh to negotiate a lesser scope for the plan revision; motion carried.
- Amend section 16.30.529.A.1 County Forest Use Regulations This amendment is to allow camping
  year round in the county forest. After some discussion, the committee decided to bring the resolution
  back to the next meeting for more discussion and action.
