The meeting was called to order by Chair Patrick LaVelle at 5:30 p.m.

- 1. Confirmation of meeting notice Meeting notice was confirmed.
- 2. Approval of minutes from June 28, 2017 Meeting Tami made a motion to approve minutes from the June 28 meeting; motion carried 4-0.
- 3. Public Input No one was present to speak on this item.
- 4. Proposal by Boy Scout Troop 124 to Adopt Pinter Pines Laura Hurd stated the Boy Scouts were definitely interested but had some reservations as to effective dates of the agreement and Josh said those dates could be changed. Bob Paddock added that the scouts should understand it is a wilderness area and services would not be available and Laura stated they did. Kevin moved to accept the agreement to Adopt Pinter Pines by Boy Scout Troop 124 as written; motion carreid 4-0.
- 5. Resolution 17-18/037 Supporting an increase of the "Payment In Lieu of Taxes (PILT)" for county forest acres Josh explained this is a state-aid reimbursement and no county funds are used. Gary made a motion to support the resolution; motion carried 4-0.
- 8. To amend section 16.30.529 A.1. County Forest Use Regulation Staff will bring back specific changes in forest uses to a future meeting that will address special use areas in additional to general camping regulations.
- 9. Lowes Creek Park Reclamation Project Update Nothing new to report. The committee is waiting for Commonweal Development to submit the reclamation plan to Josh. Stuart from Commonweal had emailed Josh and said they were planning on sending in the wetland delineation for concurrence with the DNR.
- 10. Pinter Pines/Coon Gut Property Future Plan No action.

13. Correspondence – Josh and Captain Staber from the Sheriff's Department had a meeting. The Sheriff's Department would like to see speed limits on the ATV/UTV Trails. Josh will invite Capt. Staber to a committee meeting in the future. Josh has received three complaints about buggies not paying the \$3 fee. Josh told the caller to send a written complaint to the committee.

- 14. Staff & Committee member reports Josh met with Jackson County about departmental fees and may come back to the committee with some fee change proposals. Pat reported he was contacted by Vicki James, owner of "Snowie" food cart about selling at Lake Altoona prior to having the contract signed and he agreed since all permits and insurance proof were received by the department.
- 15. Advisory Committee Input/Assignments Pat suggested Laura Hurd be sent information on applying for a position on the Advisory Committee as there is one vacancy. She said she would look over the information and consider it.
- 16. Tour park facilities Tess provided some written comments about park improvements made and revenue and use comparisons with past year
