The meeting was called to order by Chair Patrick LaVelle at 5:30 p.m.

- 1. Confirmation of meeting notice Meeting notice was confirmed.
- 2. Approval of minutes from June 28, 2017 Meeting Bruce made a motion to approve minutes from the July 12 meeting; motion carried 4-0.
- 3. Public Input No one was present to speak on this item.
- 4. Non-motorized Traffic in parks Discussion ensued about the type of vehicles, enforcement, etc. The committee asked staff to bring information back to the next meeting regarding what other county and state policies are.
- 5. To amend section 16.30.529 A.1. County Forest Use Regulation Bobbi explained that after reviewing Chapter 16 regarding special use areas, the ordinance as written should be approved if it was the committee's decision to do so as the special use areas are discussed in Chapter 16 elsewhere. Plus, Pinter Pines should be added as a special use area. Gary moved to accept the ordinance changes for county forest camping; motion carried 4-0.
- 6. Review of 2018 Budget Josh presented a draft of the 2018 budget. He discussed changes to revenue accounts and reasons for the changes. Expenditure increases are largely due to personnel costs. The committee was to communicate with Josh anything they wished to change after a more thorough review. Josh will present the final 2018 budget to the committee at the next meeting August 9.
- 7. Lowes Creek Park Reclamation Jamie and Stuart from Commonweal Development sent Josh a preliminary plan for Lowes Creek. Committee approval of the plan is necessary before they can move forward with any reclamation.
- 8. Expo/Curling Club Lease Extension Nothing to report.
- 9. Stewardship Committee report Nothing to report.
- 10. Pinter Pines/Coon Gut Property Future Plan Kevin stated water and sewer at the site should be discontinued and replaced with pit and/or composting toilets. His thought was to make the site more rustic - without heaters but using wood for heat. He will bring in his ideas and share with the committee at a future meeting.

13. Correspondence – Nothing to report.

- 14. Staff & Committee member reports Jody said the "zipline" at Coon Fork is in need of repair and out of order at this time. They have ordered the necessary parts for the repair and hope to have it operable soon. Kevin said some docks and a pontoon washed down the river below Harstad Park. The owner of the pontoon has been contacted but owner of dock parts are unknown. Kevin will try to pinpoint the exact location of the docks so staff can plan for removal.
- 15. Advisory Committee Input/Assignments The Advisory Committee will be invited to the next meeting as well as Laura Hurd and the user groups at Tower Ridge.
- 16. Tour park facilities –Those in attendance were encouraged to inspect park areas that interested them on their own.
