# Public Input

#### 2017 Fair / Discussion - Action

Jenny spoke on her communications with the Eau Claire Humane Association and checked with the Fair Committee, about the association being present on Friday and Sunday of the Fair. Public input expressed. It was expressed that the animals must be behind a barrier. They will be located at the edge of the kids day tent. Motion made to accept their entry made by Jodi Thesing-Ritter, with the motion seconded by Leslie Strey. No discussion. Motion passed 8-0. *Golf Carts:* Four golf carts were acquired (\$225 total). Motion made to approve the renting of the golf carts made by Scot Zimmerman, motion seconded by Jenny Regalia, motion passed 8-0.

Petting Zoo: Emily Jaquish will be helping with the petting zoo this year. Setup for petting zoo will be included in fair setup, and a request was made to invite others to bring animals. Jodi Thesing-Ritter and Debbie Kitchen will look into getting more animals.

*Kids Day:* Jodi Thesing-Ritter shared the need for more kids day prize items. Items can be left at the fair shed. A request will be added to the Cloverleaves.

Bleacher Update: The Eau Claire County Fair has acquired 6 21ft bleachers and 4 15ft bleachers, totaling \$13,900. Special thanks to our generous donors. The bleachers, when not in use, will be stored at Zimmerman Farms. Insurance will be purchased (\$1,000 approximate quote) for the bleachers. Recognition for donors will be made at the beginning of the auction, and the "Partner(s) in the Fair" Award will be given to these donors/partners. The bleachers should be ready for pickup by July 7th. An assembly date must be chosen to put the bleacher sets together. July 23rd was proposed. Additional materials needed: rubber mallet, wrenches, drills... etc. It will be a potluck for those that assist. There will be recognition plaques added to the bleachers.

Distinguished Fair Service: A single nomination was made, and this individual was selected for the award by the committee.

Special Awards: With support from clubs, all of the trophies were ordered.

Superintendents: Reminder to encourage youth to send thank you's for awards. State fair exhibits will be taken by Eau Claire Intern Erin.

Andy at the Fair: Andy will be at the Fairgrounds working in the fair office this year.

Insurance- No discussion.

Biosecurity- No discussion.

Sign Up Genius- Dakota Roettger updated the committee regarding the status of the signups. Weekly updates will be sent out by Andy, More individuals are needed to work the malt side of the dairy shack. Dakota Roettger will contact Jane Mueller. 4-H clubs, county FFA chapters will be sent signup links again.

Set Up/ Tear Down- Materials still needed: Caution tape, packing tape, duct tape, new hand sanitizer, etc. Setup for the inside of the expo building is planned out.
