Fact Sheet to Proposed Ordinance 17-18

Background

The Aging & Disability Resource Center receives and manages the State of Wisconsin, Department of Transportation, specialized transportation grant as designated by State Statute s.85.21. There is no statutory requirement to have an advisory committee specific to transportation coordination; however, Eau Claire County had such committee from 1988-2014. This committee was known as the Transportation Coordination Advisory Committee, or TCAC. This committee was advisory to the ADRC Board. The committee dissolved in 2014 as there were challenges with quorums and the ADRC Board was willing to fulfill the role that TCAC had previously.

Proposal

Some members of the ADRC Board have expressed interest in seeing the Transportation Coordination Advisory Committee re-established. There have been and will continue to be changes to the specialized transportation program which have required a lot of discussion. The TCAC would be able to focus its attention specifically on transportation services and make recommendations to the ADRC Board. The TCAC membership is diverse and very specific to transportation stakeholders in Eau Claire County. Additionally, the ADRC will begin the Request for Proposal process in 2018 for 2019 services, in addition to the 5 year transportation coordination plan.

No fiscal impact.

- TO CREATE SECTION 2.05.612 A. OF THE CODE: TRANSPORTATION COORDINATION ADVISORY COMMITTEE -

The County Board of Supervisors of the County of Eau Claire does ordain as follows:

SECTION 1. That Subsection A. of Section 2.05.612 of the code be created to read:

<u>2.05.612 Transportation Coordination Advisory Com</u>mittee.

- A. The committee shall consist of nine persons knowledgeable of and interested in the special transportation needs in the community appointed by the chair of the county board, upon the recommendation of the ADRC board, for staggered 3-year terms commencing on the third Tuesday of April and in the following manner:
- 1. Annual vacancies shall be noticed publicly. The ADRC board shall submit a list of nominees to the county board chair prior to the consideration of any committee appointments.
- 2. Four members shall be consumers who are age 60 or older or adults with disabilities.
 - 3. One member shall be a veteran.
 - 4. One member shall be a county board ADRC board member.
 - 5. Two members shall be consumers, 1 of whom shall be a rural consumer.
 - 6. Three members shall be elderly.
 - 7. Two members shall be persons with a physical disability.
 - 8. One member shall be a City of Eau Claire Division of Transit representative.
- 9. One member shall be a Center for Independent Living for Western Wisconsin, Inc. staff person.
- 10. One member shall be a staff person of a managed care organization serving Eau Claire County.
- 11. All members shall be citizens of the county at the time of appointment and for the duration of their terms and at least two_members shall be from the rural area.
- 12. Should any member no longer meet the qualification for appointment, the member's seat shall be declared vacant.
- 13. Midterm vacancies may be filled from a list of citizens who have applied for annual vacancies but have not been selected, or through a separate public notice, or by using both methods.

Background:

Specialized transportation services using 85.21 aid must serve seniors (60+) and adults with disabilities. Excess funds from 85.21 base contract are put into a trust. The 85.21 trust allocation, which is set by state Department of Transportation (DOT), is \$80,000. The current ADRC trust amount sits at \$90,324.77, thus creating a surplus of \$10,324.77 that needs to be spent by the end of the calendar year. Additionally, current end of the year projections for 2017 for the 85.21 grant estimate a surplus of approximately \$15,000 which would also roll into the trust. Per Trans 1, Wis. Admin., a county may use the aid that it holds in trust for purchasing or maintaining <u>capital</u> equipment used in its specialized transit program. All such expenditures must conform to the county's Department-approved trust fund plan which lists specific expenses to be incurred. This money <u>cannot</u> be used for direct service of individuals which includes paratransit rides, city bus rides, vouchers for rides, etc.

According to contract regarding trusts, State 85.21 aid which has not been expended for 2017 expenses must be returned to the Department unless the aid is to be held by the county in trust. If a county is unable to spend its 85.21 within the calendar year, they should contact the 85.21 Program Manager for guidance to develop a plan to spend the funds, as well as to approve fund spending.

Since the ADRC does not operate a fleet, expending the trust funds can be more of a challenge. Exploration with DOT has been done throughout 2017 once the trust balance was known, and multiple suggestions were requested by the ADRC to DOT. The following are the remaining current options to spend the money:

Potential Options:

- 1. Contribute \$32,000 (maximum cost) toward a scheduling database system that will be implemented in the Veteran's department. This amount, along with the amount Veterans is able to contribute with their trust fund of \$10,000, will equal the full amount of the program for purchase. This \$32,000 (maximum) would allow the ADRC and Veterans to utilize the program. There are no continued costs for the ADRC. There are annual costs which cover ongoing upgrades, licensing fees as well as technology support, which would be covered by Veteran's annually.
- 2. Provide the full balance of \$10,324.77 to the City to purchase a hoist to allow the mechanics to work on their ADA compliant equipment including ramps, as well as brakes, oil, etc. in house. This would allow the expansion of this program for efficiency directly affecting our consumers. This would be a one-time purchase amount in order to secure the hoist for the city.
- 3. Purchase a transit vehicle in the estimated amount of \$22,900 through Eau Claire Ford, to be able to transport individuals to places such as the grocery store, shopping, events, etc. Coordination of the rides with this vehicle would be done by the ADRC and options are currently being explored.
- 4. Do nothing and request the money be given back to DOT.


