5. WHSCA ATV route guidelines - Discussion

Commissioner Johnson shared ATV route guidelines document produced by the WI DNR, Wisconsin Highway Safety Coordinators Associations, and the Town of Rome Superintendent. In summary, the guidelines recommended:

- Municipalities are the only entity that are able to submit route requests
- Applicable application fee to be collected
- Annual fee for approved route

After discussion, Supervisor Kathy Clark suggestion implementing these items into Eau Claire County ATV application policy. This item will be on the next committee agenda for action.

6. Highway Commissioner Report

• Beet Heet product usage with salt brine

Operations supervisor Nick Carroll spoke to the committee on winter road treatment methods including anti-icing, pre-wet systems, and different types of solutions used. Currently, the department is putting salt brine at approximately 23.3% salinity down on the road and bridges prior to a winter storm. This pre-treatment can be applied up to a couple days prior to winter storm activities and be affective. Beet Heet product is a high quality beet juice that contains 3 chlorides that can be mixed with the salt brine solution to lower the effective temperature of the application. It also is better for the environment in comparison to rock salt or calcium chloride.

Highway maintenance and construction update Commissioner Jon Johnson spoke on the following:

- WCHA Professional Development Leadership Conference is being held on Dec 4th & 5th.
 All Committee members are invited to attend.
- o WCHA Winter road school is being held Jan 15th-17th
- Discussion with WISDOT Secretary Ross on state owned land.
- Signals for intersection of 312 and CTH EE are scheduled to be completed in December.

- Highway maintenance and construction update
 Operations Manager Brian Spilde spoke on the following:
 - o Currently completing the shouldering of the majority of road improvement projects
 - Curb replacement on CTH B scheduled to be completed next week
 - o On schedule to have most of the patching completed by Thanksgiving
 - o Farhner to complete 27 miles of fog sealing and striping
 - o Working with engineering on erosion and washouts
 - Will be working on brushing for the remainder of the year
 - o Transporting fill from the Hwy 93 site
