SECTION 8 HOUSING CHOICE VOUCHER PROGRAM

Under this program, monthly rent and utility subsidies are made to private landlords on behalf of very-low income families in Eau Claire County. The average payments per month for this past year were \$79,139. Since this program began in 1987, 61,117 monthly rent subsidies have been made on behalf of about 1,700 county residents. The monthly voucher payment per family currently averages \$388 and the length of time that a family participates in the program averages about 45 months. Total rent expenditures for the program to date equals \$18,167,704.

FAMILY SELF-SUFFICIENCY (FSS) PROGRAM

This program is operated in conjunction with the Voucher and Public Housing programs. Under this program, rental assistance and low-rent housing occupancy are coordinated with public and private resources to enable eligible families to achieve economic independence and self-sufficiency. A total of 368 families have participated in the FSS program; 12 families are currently under contract and participating fully in the program. So far, 69 families have achieved self-sufficiency under the program, and \$279,632 in escrow account funds has been disbursed to 62 families.

PUBLIC HOUSING PROGRAM

The Eau Claire County Housing Authority currently owns 16-Public Housing units. Under this program, tenants pay a reduced rent based on 30% of their monthly income. HUD subsidies are received to assist in the maintenance and management costs of the program.

Net rents received from public housing tenants averaged \$164 per month during 2017, reflecting monthly household incomes of about \$1,840 each. \$19,792 is currently on deposit into the FSS escrow accounts of public housing families.

Under the Housing Authority's Homeownership Plan, the families occupying public housing units may be able to purchase them when they have achieved and maintained self-sufficiency for at least 12 months. Twelve families have purchased their housing units. At least ten other families have purchased homes other than their public housing unit.

Funds from the sale of these homes are being reused to further the program-additional units are purchased and rehabbed, and then rented out under this program. Also, new homes are constructed using Housing Authority funds for private contractors and administrative costs, and Western Dairyland FreshStart Program funds for youth construction labor and materials. Since we began, two homes in the Town of Washington, four homes in the City of Augusta, eight homes in the Village of Fall Creek, and one home in the City of Altoona were constructed and sold to low-income families through our collaboration with Western Dairyland. Under the FreshStart Program, ten "troubled" youth, ages 17-24, receive classroom and on-the-job training in all aspects of new home construction under the supervision of a construction supervisor. They are also helped to achieve high school diplomas and/or technical school or college diplomas or degrees.

HOUSING REHABILITATION

The Housing Authority continues to administer reused revolving funds from past CDBG and HOME, Augusta and Village of Fairchild CDBG programs, and its Emergency Rehabilitation program for additional housing rehabilitation loans. These loans are 0% interest, deferred payment and are generally not repaid until the homeowner sells the property. During the past year, the Housing Authority has completed three projects from these funding sources for a total of \$84,113.

Beginning in 2013, Wisconsin began to distribute its Small Cities CDBG funds to seven regional consortia rather than to individual municipalities. Eau Claire County is a member of the ten-county West Central Regional Housing Consortia (WCRHC). A WCRHC housing committee with representatives from all ten counties has determined how future funding awards are distributed among the consortia members. Chippewa County (administered by Chippewa County Housing Authority) is the lead agency for this region. In 2015, they contracted with Eau Claire County Housing Authority for the assistance in the administration of Eau Claire, Buffalo and Pepin Counties. Since then, we have assisted Chippewa County to process 29 loans in Eau Claire, Pepin and Buffalo Counties (Total \$586,523; Eau Claire County \$122,296).

The Housing Authority also began working with the Chippewa County Housing Authority near the end of 2016 to administer Buffalo Emergency Assistance Program (EAP) which provides housing rehabilitation grants for flood victims. So far, eight applicants have received \$380,202. We have also been assisting the City of Mondovi in administration of their revolving CDBG program and have processed two applications for a total of \$40,127.

HOUSING COST REDUCTION INITIATIVE (HCRI) PROGRAM

State HCRI funds are used for homebuyer down payment/closing cost loans. Four down payment/closing cost loans (\$32,000) were made over the past year. These loans are also 0% interest, Deferred payment loans.

Repaid State HCRI and HODAP security deposit loan funds from a prior grant are re-used to assist additional families. Thirteen security deposit loans (\$6,500) were made during 2017 using revolving funds. These loans are at 0% interest; however, the recipients are required to make minimum monthly payments of \$25.

FAIRCHILD SENIOR LIVING

The Fairchild Senior Living building in the Village of Fairchild contains 11 handicapped accessible two-bedroom apartments. Occupancy is limited to very-low-income persons at least 55 years of age. In addition to the apartments, there are common kitchen, living room and laundry areas.

HOMEBUYER COUNSELING

The Housing Authority provides homebuyer counseling for Authority-assisted buyers and program participants.

ALTOONA HOUSING AUTHORITY ADMINISTRATION

The contract for the administration of the Altoona Housing Authority 36- public housing units was renegotiated in 2017. The contract involves full administration and property management services for 24 one-bedroom units at their Golden Acres 1 site and 12 two- and three-bedroom units in six duplexes scattered around Altoona.

STAFF TRANSITION TO HOUSING AUTHORITY EMPLOYEES

As a result of an interpretation of the Wisconsin Statutes by the attorney for Portage County that Housing Authority employees are not supposed to be County employees, near the end of 2016, the Housing Authority began transition from having a contractual relationship with the County for all of its staff and services to creating a separate entity for payroll, taxes, and insurance.

This process involved:

- 1. Moving housing authority office to new first floor location. This also required purchase of our own photocopier and email fax line.
- 2. A new agreement was negotiated with the County for space and limited services.
- 3. Corporation Counsel prepared County Code revisions and a resolution to enter in new Agreement with the Housing Authority.
- 4. Housing Authority Board signed a resolution canceling a former Agreement and providing reason for new Agreement and transition.
- 5. Staff job descriptions were revised.
- 6. Added payroll and Voucher Program monthly Voucher Management System submissions to fee accountant services.
- 7. Revised Housing Authority Bylaws.
- 8. Set up direct deposit of Housing Assistance Payments to landlords through our new account at Charter Bank. (In the past, the County Finance Dept processed these payments on our behalf.)
- 9. Housing Authority charge card obtained to order office supplies and equipment directly from suppliers.
- 10. Registration processes completed for Federal & State Withholding taxes/FICA/Medicare.
- 11. As a Public Agency, housing authority employees are still eligible to participate in the Wisconsin Retirement System. This was set up effective for July 1, 2017.
- 12. Researched all types of necessary insurances for health, workman's comp, business and property insurances. Employee Health, Disability and Life Insurance were secured for July 1, 2017. Other insurances were secured and effective for January 1, 2018.
- 13. Creation of a Housing Authority Employee Manual was drafted as of December 31, 2017.

During this process, two long-time employees working for the Housing Authority retired. Georgia Crownhart was hired as the new Executive Director. Two other staff were hired; Anne Bickle as a Housing Specialist and Nicole Benson as an Eligibility Specialist.

The Eau Claire Area Economic Development Corporation (EDC) promotes the economic prosperity of Eau Claire County. The organization is funded by both public sector entities and private businesses. The EDC provides a wide range of free services for entrepreneurs and businesses. Its activities center around strengthening local businesses, supporting the local talent pool, recruiting new businesses to the community, and supporting local entrepreneurs.

Both the county board chair and the county administrator serve on the EDC Board. During the past year, highlights include the following:

- Secured \$16.4 million in private investment and public sector funds were for local businesses.
- Hosted the Fireball Run, a travel adventure show that promoted Eau Claire County and spurred economic opportunities.
- Assisted 118 entrepreneurs through various EDC hosted initiatives.
- Led Startup 48, a weekend-long event to help individuals learn what it takes to run a startup company; 49 individuals participated.
- Conducted a Chippewa Valley Workforce Demand Survey to facilitate workforce grant awards, pinpoint internship and apprenticeship opportunities, and highlight areas to increase recruitment efforts.
- Collaborated with Momentum West to connect employers to their emerging workforce utilizing the Inspire Connections web portal; see: http://www.momentumwest.org/momentum-west/workforce/inspire-connections.

Lake Altoona Rehabilitation and Protection District Board submitted by Sue Miller

For the LARPD, 2017 was considerably quieter than 2016 (major dredging project when the lake was drawn down). The primary focus for 2017 was to complete the Lake Management Plan (LMP) for submission to the DNR. The Plan addresses three main areas – sedimentaion, water quality and fisheries.

Sedimentation of sand flowing into the lake, is an ongoing problem. The primary source of the sand appears to be upriver from the lake. Therefore, the long term fix would be to mitigate that problem, which will take more than just District residents working on that issue. Thus two district members have been attending the Watershed Coalition meetings to learn of the strategies that the broader coaliton may be reviewing and attempting to implement. The Eau Claire County Land and Water Conservation Division was the lead agency for the planning effort, with the Coalition actually encompassing stakeholders from five different counties. Sedimentaion was one of the prevalent concerns throughout the watershed area.

Water quality is another area in which the LARPD continues to focus (it is also another concern of the Watershed Coalition.) The LARPD has the water sampled several times a year, to test for ph balance, mercury and acid rain resistance. The overall quality of the lake is good and appears to be stable. Discussions have occurred with other interested parties in collaborating on monitoring the water quality both upstream and on the lake. This will continue to be pursued in 2018 and beyond.

The lake drawdown and dredging in 2016 had some impact on the fish habitat, with a presumed affect on some species of fish. Thus this was to be a major focus in 2017. However, the lead volunteer for this project suddenly passed away in early summer, leaving everything in limbo. Another district resident did come forth at the annual Fall LARPD board meetingand volunteered to coordinate the efforts around this project. As it was too late for any major activity for 2017, his focus would be geared to 2018. In the interim, he hoped to learn more about the work of the Lake Eau Claire residents in their efforts to improve the fish habitat and the restocking of fish in general. There are several volunteers ready and willing to do some of the work, once it is identified and coordinated.


Annual Liaison Report January 1, 2017 to December 31, 2017 Jim Dunning, County Representative Kevin Stelljes, County Representative

The Chippewa-Eau Claire Metropolitan Planning Organization (MPO) met four times during 2017. During 2017, the following actions or discussions were held.

- 1. Resolution17-01 was discussed and approved. This authorized the fourth amendment that added projects to the Transportation Improvement Program for the Chippewa-Eau Claire Urbanized Area (2016-2020). Added projects were for the Eau Claire Transit, Chippewa Falls Shared Ride Taxi, and the Center for Independent Living of Western Wisconsin. It also adjusted the three-county bicycle and pedestrian plan, adjusted funding changes to the Half Moon Lake Bridge, the Dewey Street Bridge and Bartlett Avenue.
- 2. Changes were made to the MPO By-laws that removed the weighted voting and replaced it with equal votes for all members.
- 3. The proposed update to the Cooperative Planning Agreement was reviewed and approved. It addressed the working relationship between the MPO, WisDOT, FHWA, and the local transit agencies.
- 4. Resolution 17-02 was discussed and the fifth amendment to the TIP program was approved. This included four WisDOT projects for design work on STH 29, two projects on USH 53, traffic equipment installation from IH 94 to Golf Road and resurfacing portions of 40th Ave.
- 5. A review of the upcoming Transportation Improvement Program (TIP) funding was held.
- 6. An update on the Metropolitan Bicycle and Pedestrian Plan was completed.
- 7. A review of the study of the Gateway Drive extension between Altoona and Eau Claire by the City of Eau Claire was held.
- 8. The process to discuss a 3-County Bicycle and Pedestrian Plan with Chippewa, Dunn and Eau Claire Counties has begun.
- 9. A study of the Safe Routes to School has begun.
- 10. Resolution 17-03 was discussed and the sixth amendment to the TIP program was approved. This recognized the receipt of funding by Western Dairyland for their Work-

- n-Wheels program. The schedule for engineering on Bartlett Ave. in Altoona was moved up to 2017 and WisDOT added an Intelligent Transportation Systems project on USH 53.
- 11. The projects involved with the Surface Transportation Block Grant were ranked and funding was recommended for the top four projects.
- 12. A review of the projects for the TIP 2018-2022 was conducted. Resolution 17-04 was discussed and approved. This adopted the Transportation Improvement Program for the Chippewa-Eau Claire Urbanized Area for 2018-2011.
- 13. A discussion of the 2018 Work Program suggestions was held. This included projects remaining from the 2017 list and new programs for 2018.
- 14. Resolution 17-05 was reviewed and approved. This adopted the Unified Planning Work Program and certifies that the metropolitan transportation planning process is addressing major issues facing the metropolitan planning area.
- 15. Resolution 17-06 was reviewed and approved. This approved the Chippewa-Eau Claire Metropolitan Planning Organization Title VI, Language Assistance and Public Involvement Plan (as amended and updated).

WIOA

The Workforce Innovation and Opportunity Act (WIOA) is designed to help job seekers access employment, education, training and support services to succeed in the labor market, and to match employers with the skilled workers they need to compete in the global economy.

The role of the West Central Workforce Development Board is to:

Increase access to and opportunities for employment, education, training and support services they need to succeed in the labor market.

To support alignment of partners to support a comprehensive, accessible and high quality workforce.

To improve the quality and labor market relevance of workforce investment, education, and economic development efforts.

To promote improvement in the structure and delivery of services.

To provide workforce investment activities, through statewide and local workforce development systems, that increase employment, retention, and earnings of participants, and increase attainment of recognized postsecondary credentials by participation and as a result improve quality of workforce, increase economic self-sufficiency.

One-Stop Operator

What is the role of a One-Stop Operator? The operator is charged with coordinating the service delivery among partner agencies in One-Stop Centers. Duties include but are not limited to:

Managing daily operations in coordination with WIOA fiscal agent for the lease, utilities and other activities to support the center

Managing partner responsibilities defined in the Memorandum of Understanding (MOU) among partners

Managing hours of operation

Managing services for individuals and businesses

Ensure that basic services are available (orientations, labor market information, resource room)

Implementing of Local Workforce Development Board Policy and Adhering to all federal and state regulations and policies

Reporting to Local Workforce Development Board on operations, performance and continuous improvement recommendations

The One-Stop Operator cannot assist in the development, preparation and submission of local plans. They cannot manage or assist in the competitive process for selecting operators or select or terminate One-Stop Operator, Career Services and Youth Providers. Local Workforce Development Boards are responsible for the negotiated performance measures and budgets.

WIOA Success Stories

Xou's story shows just how powerful some networking opportunities and leverage offered by the WCWWDB service provider Workforce Resource can impact the success of obtaining employment for those we serve. Xou had worked various temporary positions throughout his adult life, earning \$12-\$14/hour. Prior to enrolling in WIOA programs. During his tenure at his last position, the plant he was working at closed and relocated a portion of its operations out of the United States. Because of this, Xou qualified for both the Trade Adjustment Act (TAA) and the Workforce Innovational and Opportunity Act (WIOA) Dislocated Worker Program.

Xou had already begun his first semester of the Manufacturing Engineering program at Chippewa Valley Technical College (CVTC) in Eau Claire before being laid off. After enrolling in the WIOA Dislocated Worker Program through the St. Croix Valley Job Center in River Falls, Xou received assistance with some of the costs of transportation. TAA covered the costs of his tuition, including his books. Xou's WIOA case manager also assisted him with advice on his resume and job search tips, including the notion of making the most of networking opportunities, and taking advantage of informational interviewing and/or employer visits during his CVTC training.

Xou introduced himself to a representative from Fairmont Santrol upon the company's visit to CVTC, which affirmed that the assistance and efforts that he received paid off! Fairmont Santrol was at CVTC to specifically discuss the in-demand field of manufacturing engineering, and Xou was able to connect with the speaker upon completion of the presentation. Xou connected with the company again in December of 2016 when he graduated from CVTC, and in February of 2017, Xou was hired at Fairmont Santrol making \$57,000 a year with full benefits.


Ashley was referred to the WIOA Out of School Youth program in May of 2016 by her former Special Education teacher at her high school. Ashley had no driver's license, no work history, she was homeless, and really had no career direction in mind. She had just graduated high school and was "lost" on her journey to independence.

WRI staff immediately enrolled Ashley in work readiness services including Work Experience, Financial Planning, Career Exploration, and Support Services. Ashley completed several workshops and webinars and was able to choose a career path, obtain her driver's license, and learn how to utilize and adhere to a budget. Staff assisted Ashley with providing her with the basic needs of housing, opening a checking account, and signing up for Food Share Employment and Training. Throughout the winter, Ashley learned the work readiness skills that would lead her to being employed in the future. Ashley was placed on a paid work experience in March of 2017 at a local grocery store as a deli/bakery associate.

After just two months, the bakery manager was so impressed with Ashley's pleasant personality and excellent customer service skills that they hired her on as a full-time employee in June of 2017. Ashley is still happily employed and always greets you with a smile when you visit the bakery department.

- Greenwood DNR applications
- Administration of several Community Development Block Grants
- Updates of Comprehensive Plans for the city of Cumberland and the village of Frederic
- Sewer Service Reviews for Eau Claire, Menomonie and Hudson
- Updating the policies and procedures section of the Eau Claire Area Sewer Service Plan.

- Western Dairyland is a community action agency which covers four counties (Eau Claire, Buffalo, Pepin, and Trempealeau). The agency is governed by a 24-member Board of Directors comprised of eight income-eligible constituents, eight County Board Supervisors, and eight members representing private groups and organizations. Western Dairyland offers programs in Child Education, Energy and Housing, Food Programs, Economic Development, Community Services, Youth Development, Homeless Services, Transportation, Senior Services, Health Services, and Job Training.
- In 2018, Western Dairyland served more than 6000 persons (unduplicated count)
- The survey results of the Strategic Plan, completed during the year, indicate strong and positive connections between Western Dairyland and other community agencies and local governments and strong rural outreach. Awareness of and knowledge about the services of the agency is high. The public relations work of Western Dairyland confirms that the best work is done when all of the agencies and governments work together. The strategic plan may be viewed at www.westernDairyland.org/plan.
- The Head Start program now offers dental services through a teledental connection provided by Marshfield Clinic.
- The Business Center of Western Dairyland has secured a grant from the Public Services Commission to offer mobile hotspots and laptops to rural businesses.
- The finances of the agency are strong. The audit for FY 2016 was unqualified; the agency operated in the black. The audit for FY 2017 will be completed in April. Monthly reports to the Board of Directors through the year indicate that the audit for FY 2017 will show similar results. In FY 2016, Revenue was \$12,084,203, and Expenses were \$12,084,203.
- Current concerns:
 - Cuts in funding from HUD for rapid re-housing, about \$270,000, take effect in June. Approximately 75% of this funding provides rental assistance to 26 families (FY 2017) for up to twelve months.
 - O The lack of a federal budget means that funding proceeds on an almost monthly basis, with very little predictability and with little no increase in funding levels, despite ongoing increases in costs. Funding sources affected are CDBG, CSBG, LiHEAP energy assistance, weatherization, Americorps, and RSVP, as well as associated indirect costs.
 - Lengthy lag time in state reimbursements, between submission of billing and payment, creates problems in cash flow, diverting cash flow which can be used in program areas.


