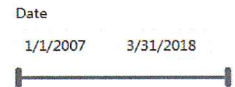

March 2018**

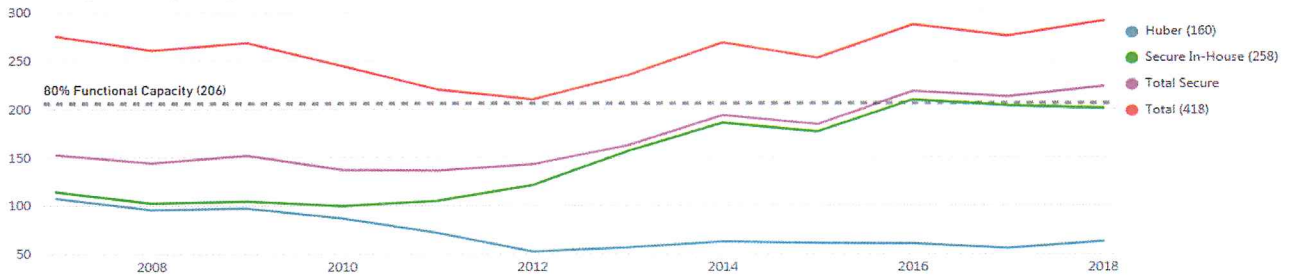

Average Daily Population

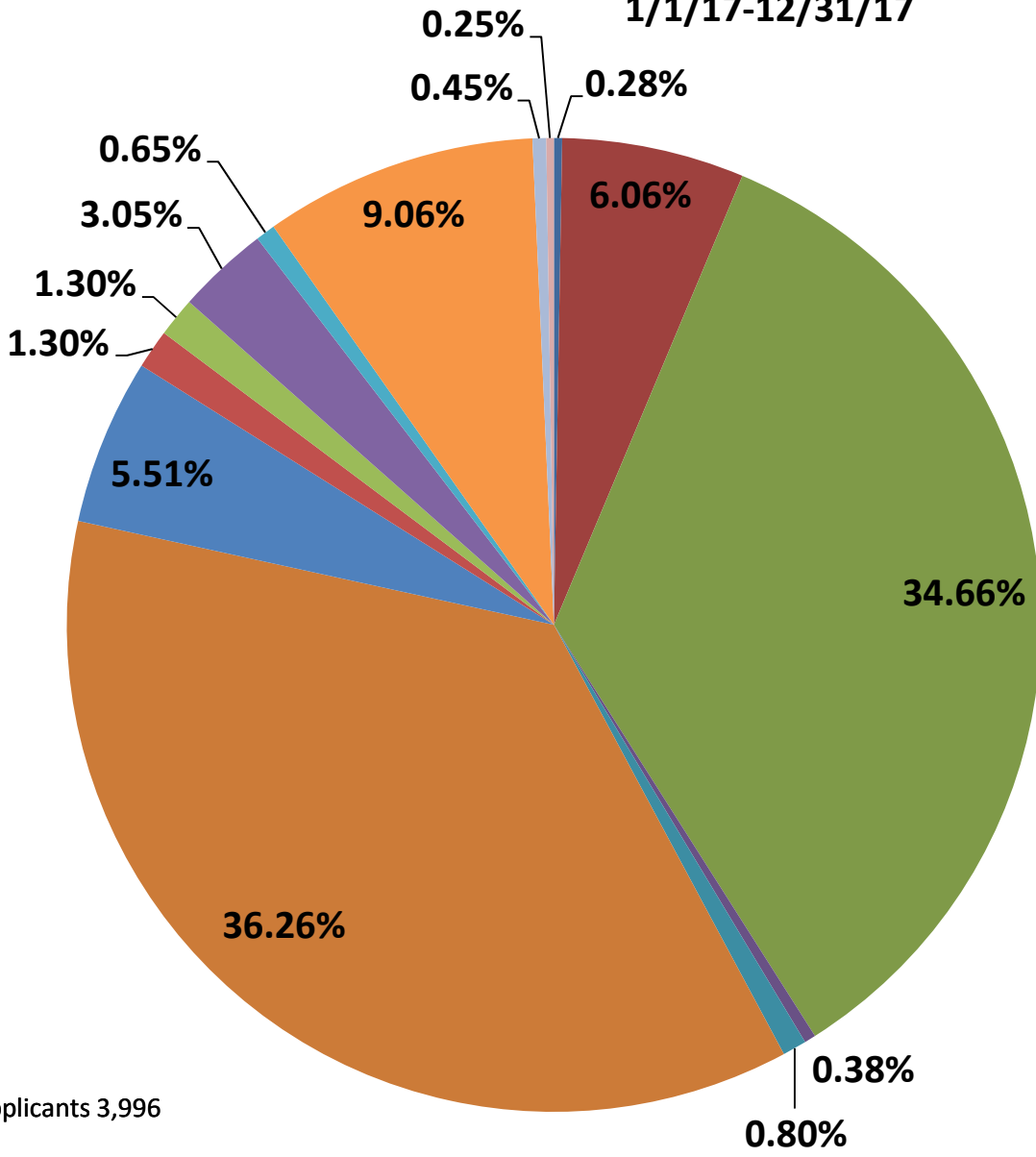

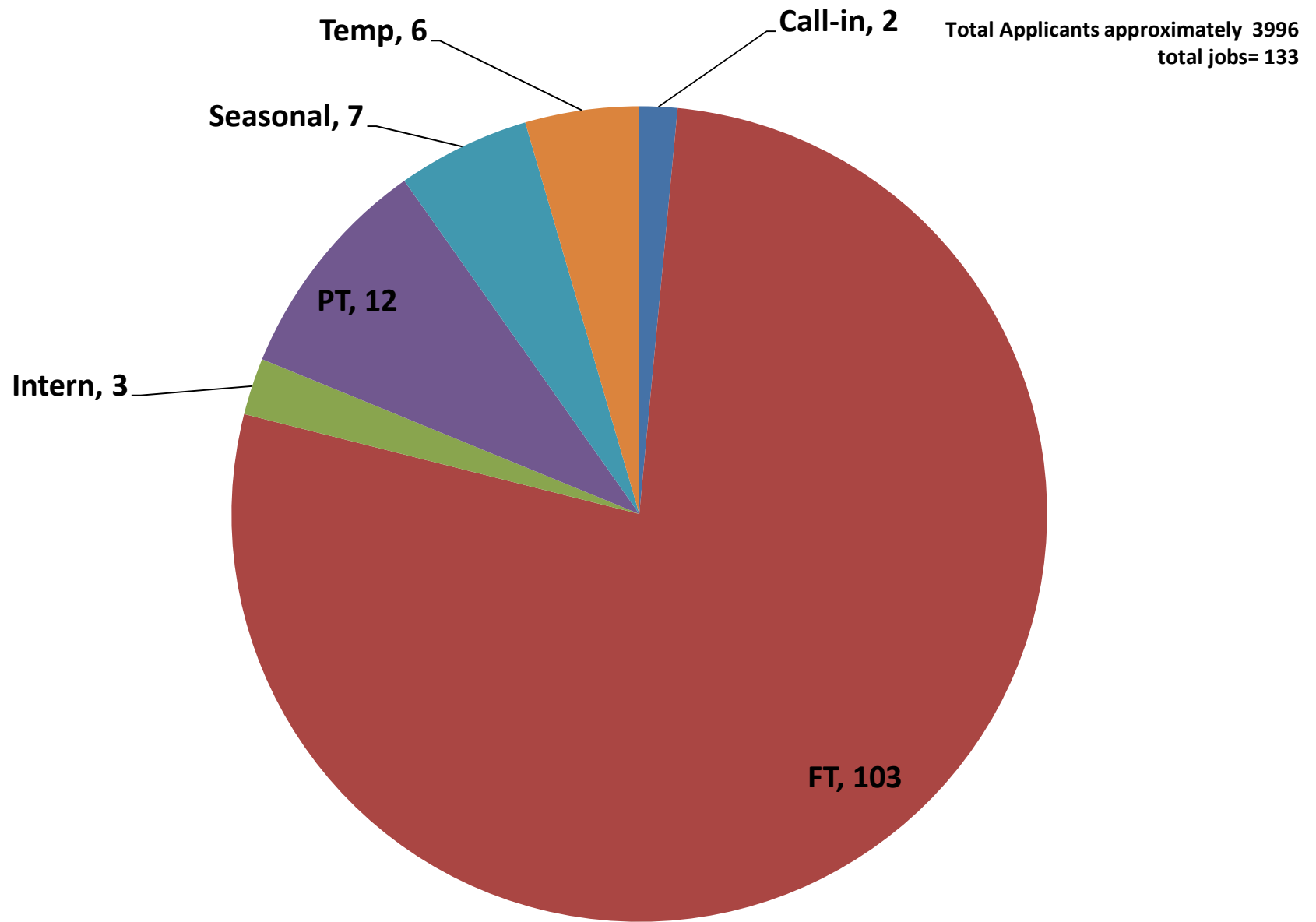

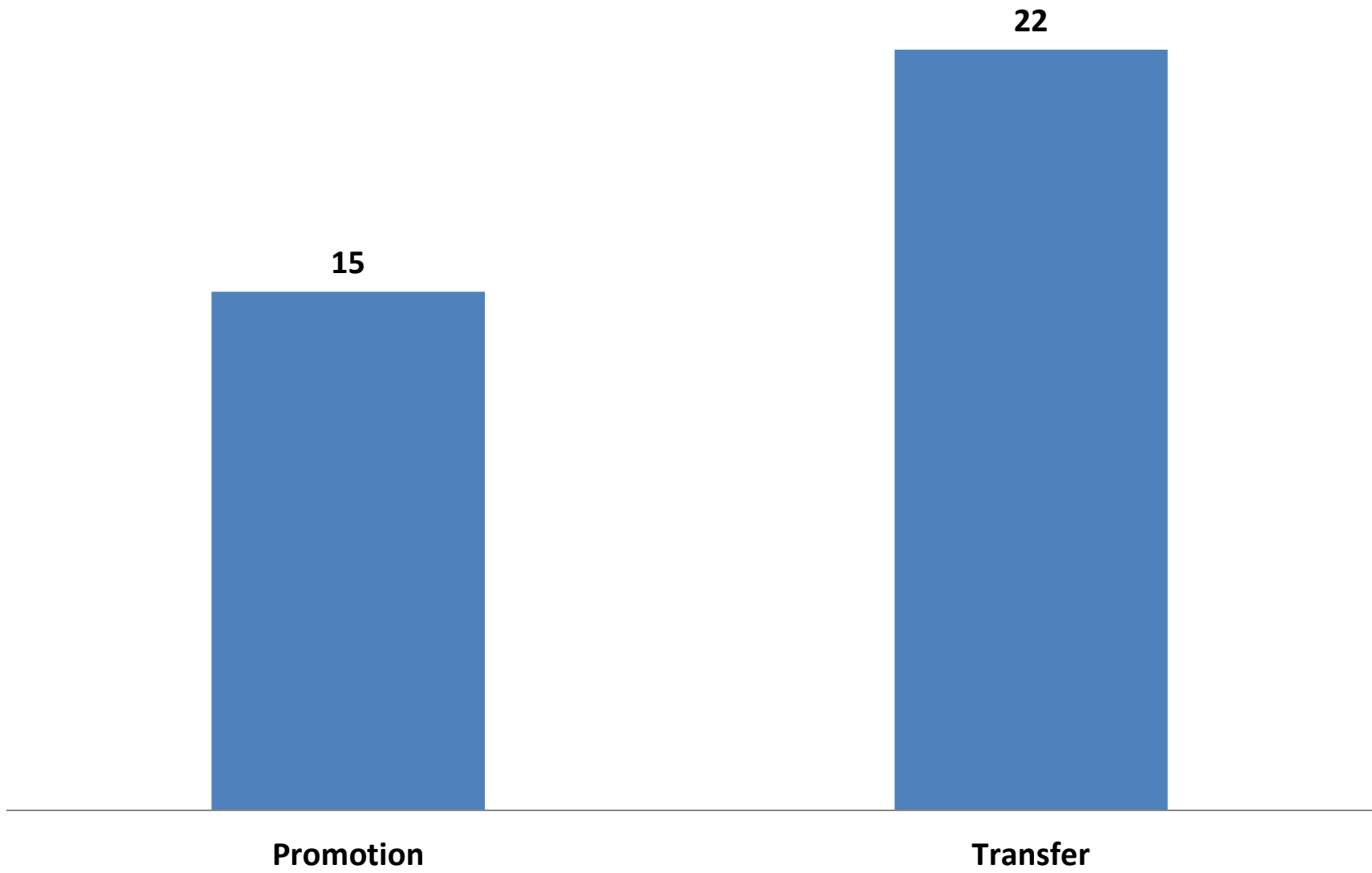

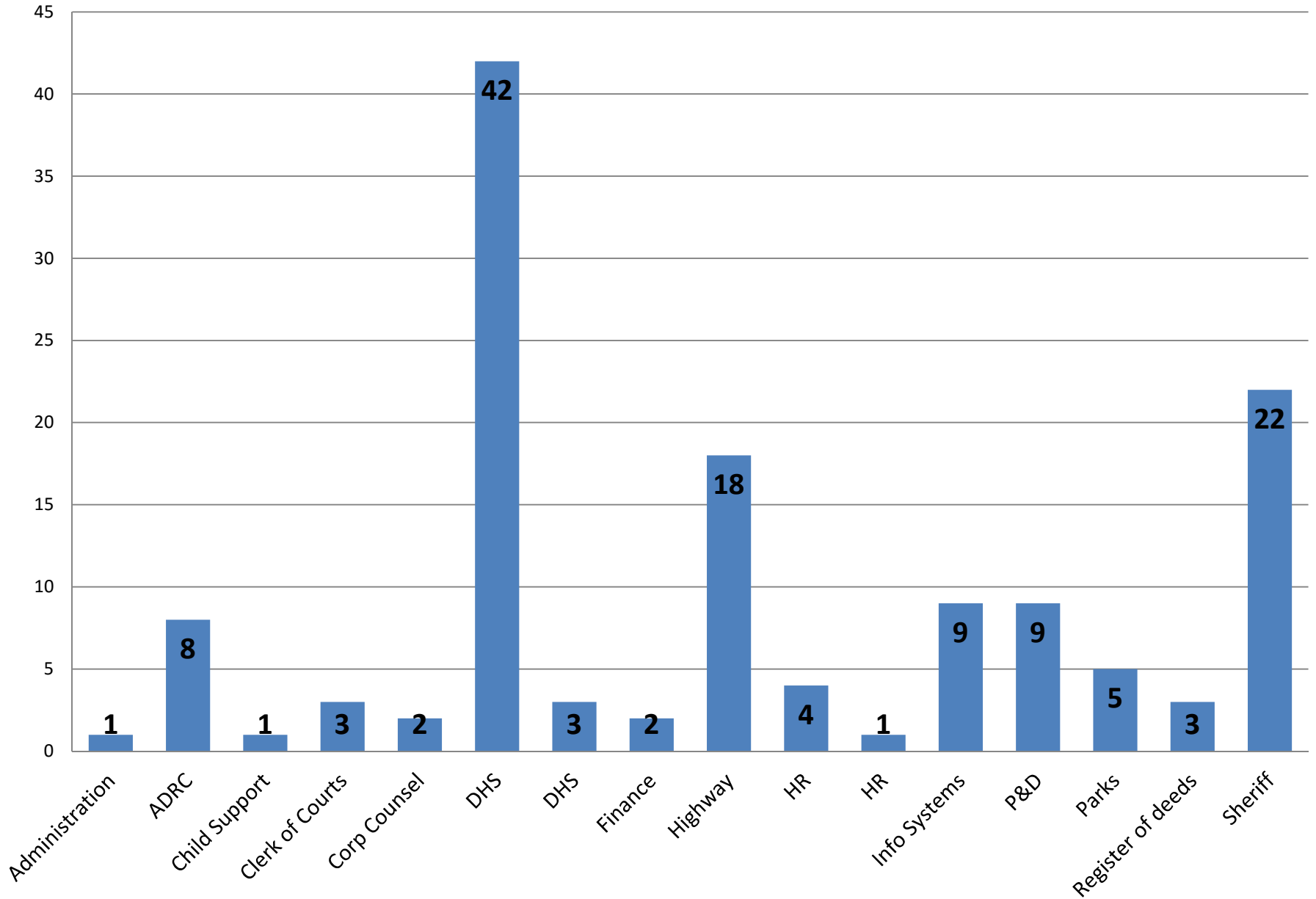

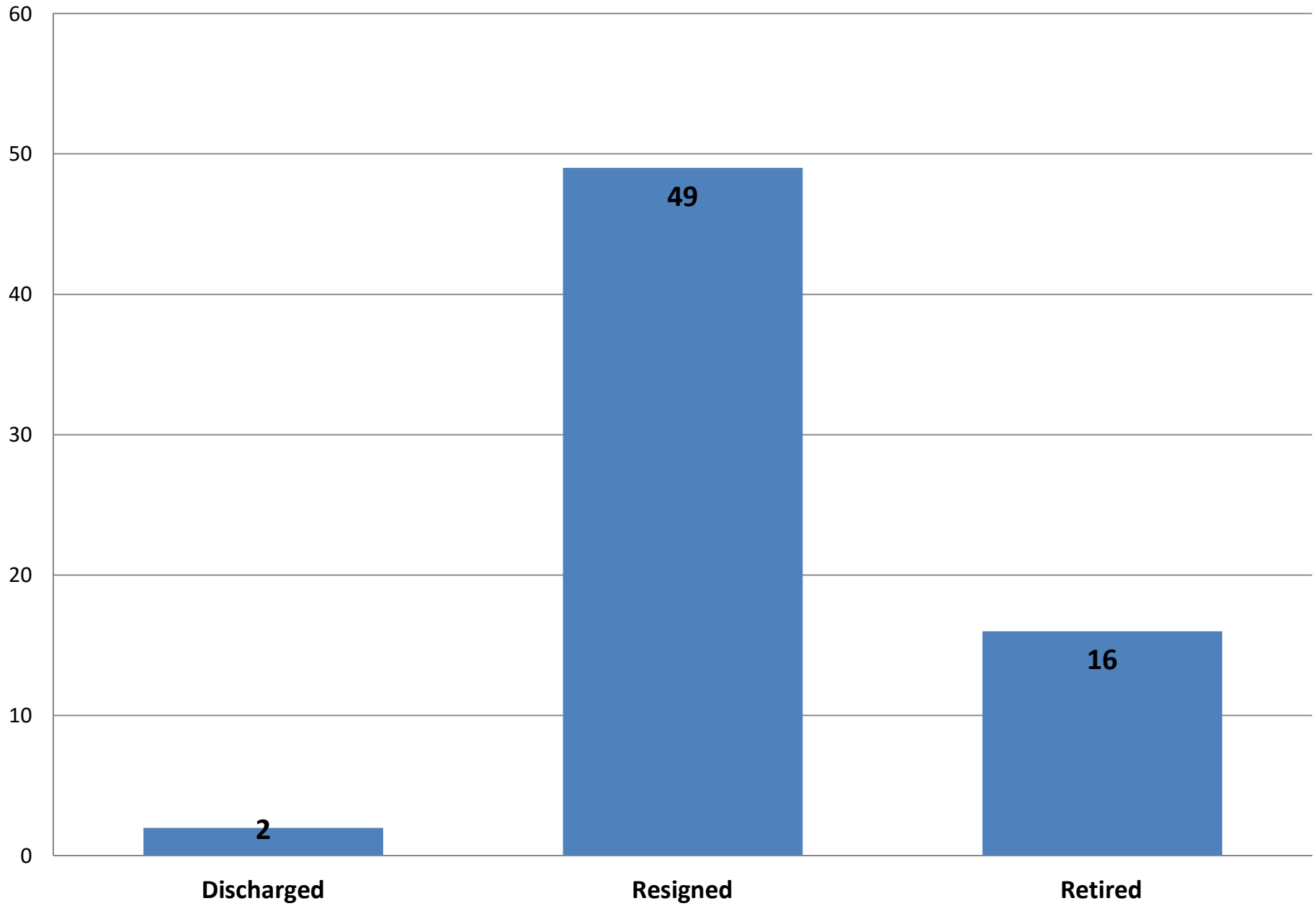

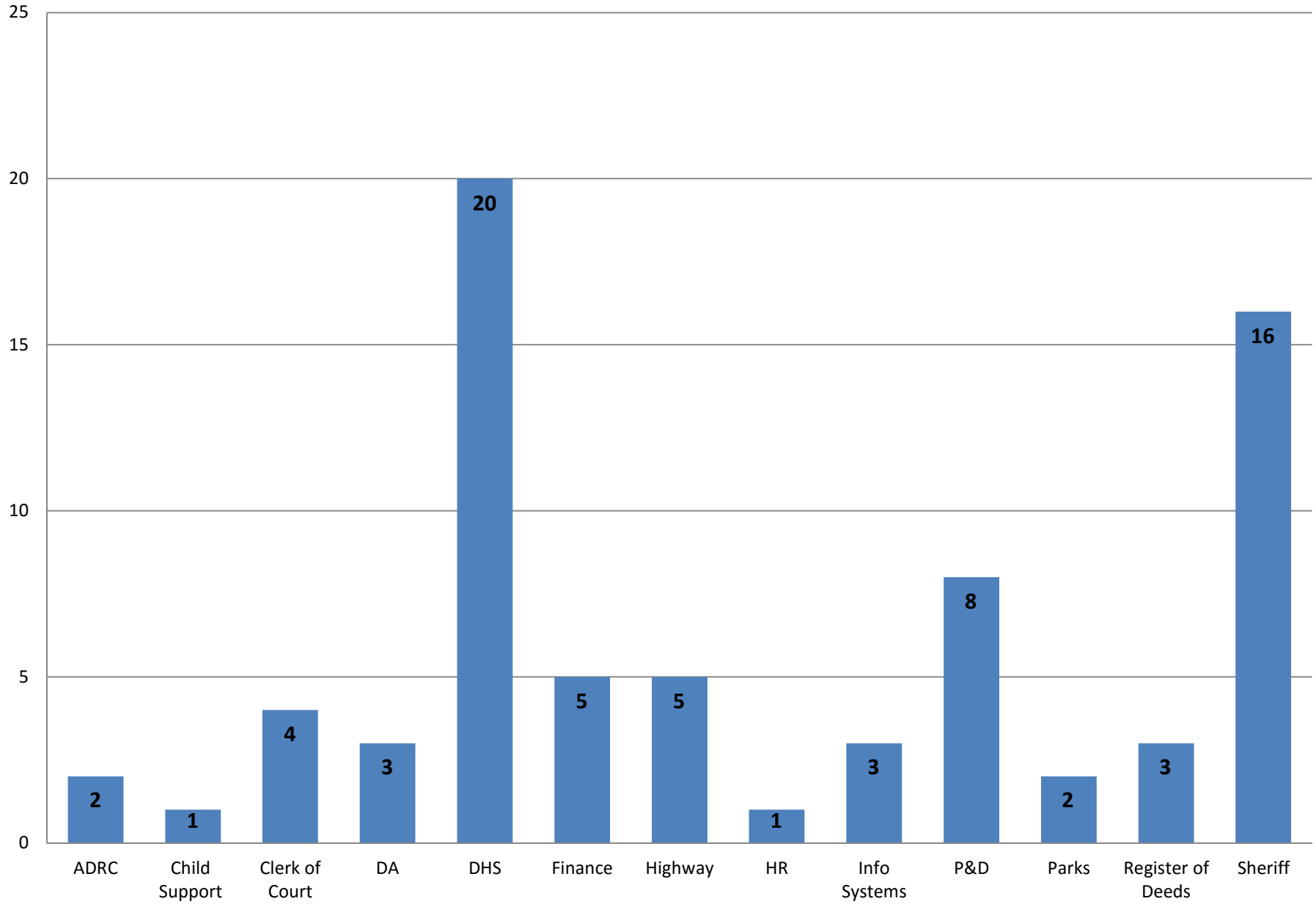
2017 - Open position by department

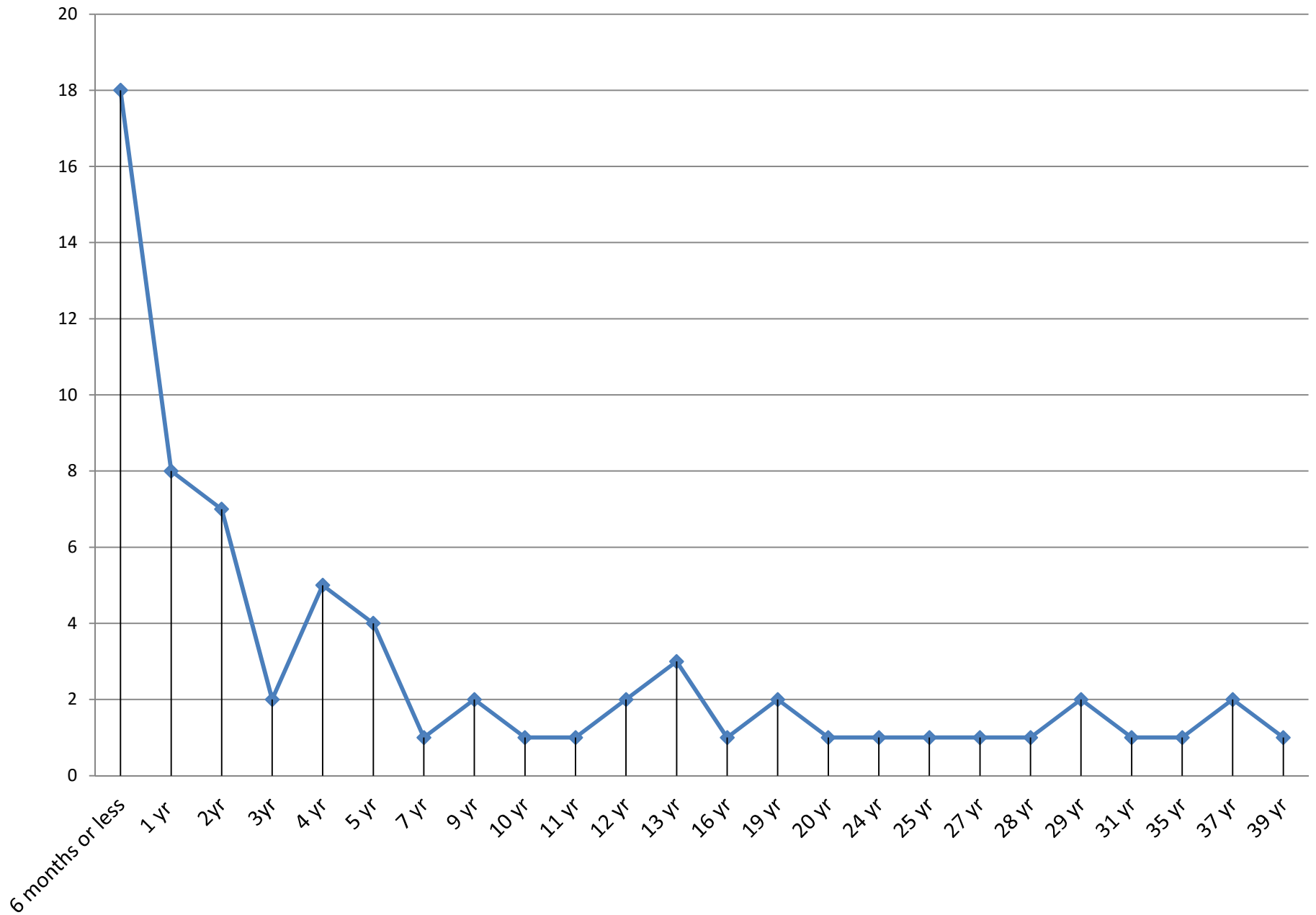


2017 Reason for Separation
