Assembly law AB442 changes the requirements for signs placed to mark all-terrain vehicle routes. Sargent John Staber asked who is responsible for posting roads that are not ATV routes. Several possibilities were discussed with regard to signing routes. This will be discussed at the next meeting.

 - o Review of Highway Dept. Policy Manual Committee members should read through manual. The manual will be reviewed a section at a time in future meetings
 - Trees in the right-of-way on CTH SS must be removed for public safety. Residents cannot take on liability for the trees. The County will work with the family to replace trees
- Operations Manager Brian Spilde spoke on the following:
 - o Reviewed work rules for entire department
 - o Upcoming construction projects include CTH Q and CTH I
 - o The Highway Department has been working together with townships on projects and this saves money
- Project Engineer Rod Thorson spoke on the following:
