## 1. Call meeting to order

## 3. Past committee meeting minutes (9/6) - Review/Action

## 5. Future highway facility - purchase of state-owned land

Commissioner Johnson explained the handout depicting the land purchase proposal and the associated costs. Total cost is \$383,719 for approximately 40 acres (including woods) and two buildings. There are many steps to the process once the property is purchased. Supervisor Gatlin moved for approval. Supervisor Anton seconded the motion. Approved 5-0

#### 6. Painting of buildings 2 and 3

The City of Altoona has requested we paint the buildings. Commissioner Johnson explained the handout showing the cost to have county employees prepare and paint the buildings, which is approximately \$17,000, versus approximately \$100,000 with an outside contractor. The committee agreed to this plan.

#### 7. Highway Report

- Highway Commissioner Jon Johnson spoke on the following:
  - o A new Finance Summary Report will be used moving forward, which is standardized for all county departments
  - Surface Transportation Program (STP): we have applied for funding through state programs
  - o Bridges: a schedule change has been requested

- o Operations Coordinator Brian Spilde spoke on the following:
  - Scheduling: preparations for winter weather underway
  - o Projects are being prioritized; we may hire out some work as needed
  - Fall Safety Day training is being planned including chainsaw, railroad crossing, safety harness and winter maintenance training
  - Yard cleanup is in progress
- o Engineer Rod Thorson spoke on the following:
  - o Projects slated for next year
  - o Some of the bridges to be replaced are over 80 years old
  - o Bridge inspections are in progress
