Report on Committee Progress

Nancy and Rod obtained a list of vacant land/properties owned by Eau Claire County. We reviewed four potential locations managed by Eau Claire County departments:

- (1) Town of Fairchild property where the Highway Dept manages the property. Will confirm if Internet available.
- (2) Town of Washington property also managed by the Highway Dept. This particular option may have septic problems which could be too much to consider.
- (3) Town of Union property in a subdivision called Blue Valley Estates. City lot so no issues with septic or Internet.
- (4) Town of Bridge Creek property is old plat near Dells Pond which could be in a flood plain and unknown about Internet.

- -Nancy will continue contact with Relator and Vendor
- -Diane and Rod will contact County Administrator to request attendance at the next Committee on Administration meeting to discuss possibility of purchasing county owned land/housing
- -Richard to reach out to Pepin County to see how they acquired housing
- -Rod will confirm if there is Internet connections in Fairchild
- -All Committee members keep their eyes open for potential properties. Any suggestions, please forward to Diane or Nancy
