Call of the Roll

Report on Committee Progress

-Next Court Hearing & Report: Richard Eaton will attend the next court hearing on April 1, 2019. At next that hearing, he will request an extension. However, Richard has talked with Attorney Peterson and he will oppose any extension requested.

-DHS Progress on location – Nancy reported she continues to communicate with the vendor and securing a mobile home to potentially place on county owned property

-No vacant housing available through REM, LSS, Brotoloc or Aurora

Since the deadline is approaching quickly, due to no choice:

-1,500 foot rule will not be considered; Mic in agreement in this case. Rich to file an affidavit to this affect. Nancy will help Rick with the details and send him the list of accomplishments

-Diane and Rod met with Kathryn Schauf last week. Kathryn is in favor of the plan to put a mobile home on county property managed by the Highway Dept. Rod has followed up with Jon Johnson, Highway Commissioner about the land. At this point too, we cannot guarantee a location with broadband width for GPS. Sherry agreed that wearing two bracelets would not be a problem if technology isn't accessible at the proposed property. Reviewed property on map indicating a road would need to be graded and due to heavy snow, frost may present a problem until spring. Not recommended to place client at an already established mobile home park.

Plan –

1. Temporarily place client at the location (Fifth Street) and/or pursue affidavit for 1,500 rule for other options; laundromat options discussed
2. Continue with plans for county owned property, place a mobile home on property; Sheriff's Dept prepare a report re: the county owned property. Diane will share the report with County Administrator
