12 county trunk highway during the months of April through October that is equipped with traction
13 devices that are carbide, tungsten, borium or any other protruding material that damages the
14 highway.

15 B. Violation and penalty. Any person violating this section may be required to
16 forfeit not less than \$100 nor more than \$500. Persons who violate provisions of this chapter
17 shall be subject to the forfeiture schedule in 1.50.020.

FACT SHEET

TO FILE NO. 19-20/039

This resolution is for the sale of a strip of vacant land containing more or less than .013 acres of land. The strip of land is seventeen (17) feet in width across the west ten (10) acres of the northeast one-quarter of the northwest one-quarter (N. E. $\frac{1}{4}$ N. W. $\frac{1}{4}$) of section 15, Township 27 North, Range 9 West.

The strip lies along the northern limits of Seymour road and the southern limits of said ten (1) acres.

The said strip was acquired by the County for the purpose of highway Right of Way. It has now been determined that said strip is excess Right of Way and can be sold with County approval.

On May 13, 2019 an appraisal report was completed by J.C. Norby & Associates on behalf of Andrew Holland. The resulting report indicates that the above-captioned land has an appraised value of \$850.00.

On August 2, 2019, Andrew Holland submitted an offer to purchase said strip of vacant land for \$400.00.

The County is exempt from the transfer return fee per Wis. Stat. § 77.25.
