Call to Order

The meeting was called to order by Chairperson Sue Miller at 4:00 PM.

Approve Minutes from August 13, 2019 Meeting

The Clerk noted the meeting room was incorrectly identified as Room 1273; the correct meeting room was Room 1301/1302. The minutes were updated to reflect that correction. Supervisor Pagonis moved to approve the minutes from the August 13, 2019 meeting, as corrected. The minutes were adopted as corrected via 5-0 voice vote.

CJCC Dashboard Update

A link to the dashboard website was included in the meeting materials. The data is completely refreshed monthly on the website with additional data being added periodically. The committee reviewed the information.

Circuit Court/Clerk of Court 2020 Budget Request

The committee reviewed the information and explanation that was included in the meeting materials. No action was needed nor taken by the committee. The material was provided as information only.

Eau Claire County Sheriff's Office

- Jail Population
 - Lt. Riewestahl reported as of the date of this meeting, the jail was at 80% capacity. Currently, no inmates are being housed out-of-county. Through July, out-of-county housing expenses are \$50,000.
- Transition Planning with Inmates
 - Becky Stendahl, Social Worker in the Eau Claire County Jail, was present to discuss and explain her role. Ms. Stendahl has been with Eau Claire County for approximately one year. Currently, inmates self-refer for the services Ms. Stendahl can provide. An information handout was provided and is included in these minutes. The committee engaged in general questions and comments related to affordable housing and options/resources available for inmates.

File No. 19-20/057 – Resolution in Support of Wisconsin Draft Legislative Reference Bureau (LRB) Bill 1522/P1

Supervisor Cronk was present to discuss the resolution. Supervisor Buchanan moved to approve the resolution, with the addition of language directing the resolution be forwarded to all state legislators, Governor, and WCA and forward to full county board. The committee engaged in discussion regarding the resolution. **Approved** 5-0 via voice vote.

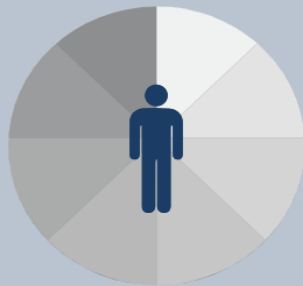

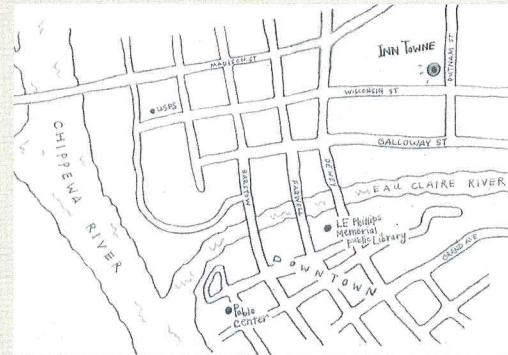

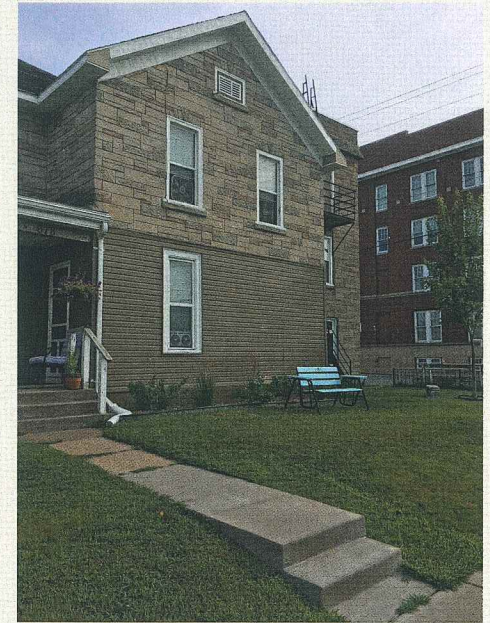

Mission Statement:

Provide safe, sober, affordable housing with Certified Peer Support Specialists for men reintegrating into the community after incarceration.

Core Values:

1. Treat each resident with compassion, dignity, and respect regardless of the individual's age, cultural differences, past offenses, or religious beliefs.
2. Assist each resident in connecting with our community-based resource partners for employment, mental and medical healthcare, and social services.
3. Provide Certified Peer Support Specialists.
4. Foster an environment that supports growth and development for the future, so that the resident may embrace his second chance at becoming a productive and responsible member of the community.

THE BASICS

The Inn Towne has 25 single occupancy rooms. Residents share a kitchen, dining room, and living room. Rent is paid weekly and includes food, utilities, garbage, Wi-Fi, free washer/dryer, and peer support specialists. We are on a bus line and close to downtown.

3 -IN SUPPORT OF WISCONSIN DRAFT LEGISLATIVE REFERENCE BUREAU (LRB)
4 BILL 1522/P1 THAT SEEKS TO RESTORE VOTING RIGHTS TO PEOPLE ON
5 PROBATION AND PAROLE AND DECREASE FELONY DISENFRANCHISEMENT IN
6 THE STATE OF WISCONSIN
7

8 WHEREAS, felony disenfranchisement is defined as the loss of a person's voting rights
9 due to a felony conviction; and
10

11 WHEREAS, in the state of Wisconsin a person is not eligible to vote if they have been
12 convicted of a felony and currently serving any portion of their sentence including extended
13 supervision, probation and or parole; and
14

15 WHEREAS, rates of disenfranchisement vary drastically by state due to broad variations
16 in voting prohibitions; and
17

18 WHEREAS, as reported by The Sentencing Project, 30 states deny voting rights to felony
19 probationers, 34 states disenfranchise parolees, and 12 states deny voting rights to some or all
20 individuals who have successfully fulfilled their prison, parole or probation sentence; and
21

22 WHEREAS, Maine and Vermont are the only two states that do not disenfranchise
23 felons; and
24

25 WHEREAS, as of December 2016, the Bureau of Justice Statistics reported there were an
26 estimated 4.5 million adults in the U.S. under community supervision, probation or parole and,
27 of that amount, 64,900 were residents of the state of Wisconsin; and
28

29 WHEREAS, the Ex-Incarcerated People Organizing (EXPO) group reports in 2016 that
30 the average length of stay for parole in Wisconsin was estimated to be 38 months or a little over
31 three years, that makes Wisconsin third nationally for probation and parole sentences as reported
32 by the EXPO group; and
33

34 WHEREAS, the EXPO group further reports that the average duration for parole across
35 all states is estimated to be 22 months; and

36 WHEREAS, a report by the Advancement Project titled *Democracy Disappeared How*
37 *Florida Silences the Black Vote through Felony Disenfranchisement* published October 2018,
38 suggests that the consequences of felony disenfranchisement disproportionately impact poor
39 communities and communities of color, which are likely to have high concentrations of returning
40 citizens who are disenfranchised; and
41

42 WHEREAS, the report further indicates that losing the right to vote is linked to socio-
43 economic conditions; felony disenfranchisement converges with low income, poverty, limited
44 education and employment opportunities to disempower entire communities; and
45

1 WHEREAS, the inability for disenfranchised people convicted of a felony to participate
2 in the political process limits their power to overcome inequality and systemic injustice and
3 isolates them from society; and
4

5 WHEREAS, the Advancement Project reports that when large number citizens are not
6 allowed to vote, entire constituencies may go unrepresented in the democratic institutions that
7 govern them; and
8

9 WHEREAS, under Wisconsin Legislative Reference Bureau (LRB) draft legislation
10 1522/P1 a person would lose his or her right to vote based on a disqualifying offense only while
11 he or she is incarcerated for that offense and a person that is released to extended supervision or
12 parole may resume voting; and
13

14 WHEREAS, additionally, LRB 1522/P1 would allow a person convicted of a
15 disqualifying offense and on probation retain his or her right to vote unless he or she is confined
16 as a condition of probation; and
17

18 WHEREAS, EXPO, Wisconsin Affiliate of the Gamaliel Foundation (WISDOM), the
19 American Civil Liberties Union (ACLU), Project Return, Wisconsin Voices, League of Women
20 Voters and Just Leadership USA plans to launch the “Unlock the Vote” Campaign seeking to
21 reengage 64,900 disenfranchised voters; and
22

23 WHEREAS, felony disenfranchisement is major social issue across the United States the
24 adversely affects more than 4 million people, including 64,900 people in the state of Wisconsin,
25 as it is a constitutional right that every citizen should be allowed the right to vote; now, therefore,

26 NOW THEREFORE BE IT RESOLVED that the Eau Claire County Board of
27 Supervisors supports Wisconsin Legislative Reference Bureau (LRB) draft legislation 1522/P1
28 that seeks to restore voting rights to disenfranchised felons and efforts to reduce felony
29 disenfranchisement and reform practices that disproportionately impacts communities of color in
30 Wisconsin and the United States; and
31


32 BE IT FURTHER RESOLVED, that the Eau Claire County Board of Supervisors
33 supports a comprehensive review and revision of Wisconsin’s sentencing guidelines, parole
34 processes, and revocation processes to ensure that best practices are being followed; and

1 BE IT FURTHER RESOLVED, that the Eau Claire County Board of Supervisors
2 supports LRB 1522/P1 which is anticipated to be introduced soon, and requests Government
3 Affairs staff to communicate this position to the Wisconsin State Legislature and the Governor in
4 support of its passage.

6 BE IT FURTHER RESOLVED, that the Eau Claire County Board of Supervisors are
7 requesting the support of all Wisconsin State Legislators, the Governor, and the Wisconsin
8 Counties association. The County Clerk is directed to forward a copy of this resolution to the
9 Legislature for the State of Wisconsin, the office of the Governor and the Wisconsin Counties
10 Association.
