The Council reviewed the minutes from the August 21, 2019 meeting. The following changes should be made:

Various departments updated the Council. The following highlights were noted:

- There are two new Assistant District Attorneys.
- Megan Severson is taking over AIM Court
- There are three new attorneys in the State Public Defenders Officer
- Restorative Justice has implemented a differed citation program for vaping and opportunity to do the Catch my Breath program
 - In 2020 there will be restitution programming with Goodwill Industries, given offenders the opportunity to earn money to go towards their restitution and gain job skills
- Treatment Court numbers are improving
 - o Judge Manydeeds will preside over AIM Court and Veterans Court
 - Vantage Point (provide Matrix Program and DBT) will not be continuing contract, which will run through February 2020
- The Jail Data Blitz process is happening again. The team will present to the County Board in December.
- There have been over 1000 different kind of weapons taken that have gone through second floor security. The change is appearing to be a great success.
 - Request to review the timing and shut down of the second floor for trials, jury deliberations, etc.

Strategic Planning is set for March 27, 2020 (8:00 a.m. – 4:00 p.m.). A focus will be restructuring the Council.

The Council discussed the implementation of a yearly recognition program. The first two recipients will be Judge Proctor and Judge Barland. The recognition will take place at a December County Board Meeting. Tiana will reach out to each recipient and work with Samantha to secure the plaques.
