Chair Smiar called the meeting to order at 2:30 p.m.

No members of the public wished to speak or were present.

The committee reviewed the minutes from the October 8, 2019 meeting. Supervisor Henning motioned to approve the minutes as presented; Supervisor Beckfield seconded the motion. 3-0, motion passed.

Departments who report to the Committee on Administration were in attendance and gave updates and highlights from Quarter 3.

Administrator Schauf gave updates on the 2020 Strategic planning process. We have identified a vendor who will incorporate Speak Your Peace with the Strategic Plan. The Administration department will work with the vendor to create a workflow and timeline. Frank Draxler noted that the County would like to move to a 5-year plan instead of a 2-year plan. The committee request that this matter is added to the next meeting and to provide additional material. Other updates shared was the recruitment of an HR Director, the County Department Heads working on Operational Effectiveness and the discussion of legislation regarding TPRs.

The committee reviewed and discussed the nominations for the 2020 Generous Jurors funds. There was a motion made by Supervisor Beckfield to approve the Drug Endangered Children (DEC) program for the 2020 year. The motion was seconded by Supervisor Beckfield. 3-0, motion passed.

The committee discussed the proclamation for School Choice Week. The proclamation will move forward to the County Board with the change of two grammatical errors.

The committee discussed the current Budget Reporting Policy. The committee asks that Corporation Counsel review wording and bring forth to the next meeting to review and refer to the Committee on Finance and Budget.

The committee discussed potential code changes to include the Chair of the Board as a non-voting exofficio member of all committees as well as updating the policy to follow current practice. Corporation Counsel presented Ordinance 19-20/081 – To Amend Section 2.04.030 D. of the Code: Rule 3- Opening of Meeting; To Amend Section 2.04.120 A. of the Code: Rule 12-Standing Committees. Supervisor

Henning motioned to approve; seconded by Supervisor Beckfield. Motion passed, 3-0.

Chair Smiar acknowledged Sue Millers departure from the Board of Supervisors. A solicitation for the vacancy has been posted.

Chair Smiar recommended the appointment of Philip Swanhorst to the Eau Claire County Housing Authority. Supervisor Beckfield motioned to approve, Supervisor Henning seconded the motion; motion passed 3-0. Recommendation will move to the County Board.

The meeting was adjourned at 3:38 p.m.

## **Budget Deviations**

# **Policy**

All Eau Claire County departments shall attempt to operate within their adopted balanced budget. When it becomes apparent that this is not likely or possible and a material deviation (> \$25,000) from the budget expectations has, will, or is likely to occur, resulting in a net budget shortfall, the department is required to alert their Oversight Committee, as well as the Finance & Budget Committee, of their anticipated deviation from the adopted budget, the reason for the deviation, and their strategy for mitigation. The notification should be regardless of whether the deviation is resulting from revenues below budget, expenditures exceeding budget, or any situation that results in a potential overall deficit.

#### **Procedure**

- 1. As soon as a department becomes aware that their overall annual budget **has**, **will**, **or** is **likely** to be exceeded, or a net deficit condition could occur, the department should alert their Oversight Committee and the Committee on Finance & Budget in writing at the next regularly scheduled meeting. The department shall provide an estimate of the amount of the deviation, and a detailed mitigation strategy to reduce the financial impact on the finances of the County.
- 2. When the department can estimate with more certainty the final amount of the deviation, taking into account any mitigating adjustments planned or made during the year, they should notify their Oversight Committee and the Committee on Finance & Budget in writing of the change in estimate for the deviation from the adopted budget.
- 3. If an emergency purchase causes a department's expenditures to exceed their approved budget, the department should report the situation to their Oversight Committee and the Committee on Finance & Budget at the next regularly scheduled meetings. As with above, an estimate of the amount of the overage, and a detailed mitigation strategy to lessen the financial impact on the finances of the County should be provided.
- 4. The department shall continue to report monthly to their oversight committee and the Committee on Finance & Budget on the status of the budget deviation and mitigation efforts until such time as the deviation has been mitigated or eliminated.
