The meeting was called to order by Chair Patrick LaVelle at 5:00 p.m.

- 1. Confirmation of meeting notice Meeting notice was confirmed.
- 2. Approval of minutes December 13, 2017 Meeting Gary made a motion to approve minutes from the December 13 meeting; motion carried 5-0.
- 3. Public Input No one was present for this item.
- 5. Resolution 17-18/086 Ratifying Lease Agreement with the National Rifle Club Gary made a motion to approve the resolution 17-18/086 and Lease Agreement with the National Rifle Club.
