- 1. Call to order and confirmation of meeting notice Chairperson Mowry call to order the meeting at 4:00 p.m. and he confirmed that the meeting was properly noticed.
- 2. Public Comment (limit to 3 minutes per person)
 Troy Schulner, Town of Drammen resident, attended to learn more about the expansion of Broadband in the county.

Michael Alberston, Town of Drammen resident, indicated he has poor broadband service at his residence and would like to see it improved so it would allow him to telecommute from home.

Mike Hill, Charter Communication, looking to partner to grow broadband in the county and looking possibly to partner in a future grant application.

Martin Voss, Town of Brunswick resident, shared his concerns about the lack of broadband services to his property.

- 7. Broadband Telecommuter Resolutions Update **Discussion**Mr. Eslinger indicated he spoke with Mark Zuber who is working with the Town Clerks regarding the Broadband Telecommuter Resolutions. Mr. Eslinger said that 5 of the 13 town boards (Brunswick, Bridge Creek, Drammen, Pleasant Valley, Seymour) have adopted Broadband Telecommuter Resolutions to date.
