Chair Stelljes called the meeting to order at 3 p.m. and confirmed public posting of the meeting.

The committee reviewed the minutes from the January 13, 2020 meeting. Lavelle moved to approve the minutes as presented. It passed unanimously.

No members of the public were present.

Peg Baumgardner was present to propose donation of a memorial bench at Lowes Creek park. The location has been approved by Director Pedersen and will be a nice addition to the park. Lavelle moved to approve the bench request. It passed unanimously.

Travis Blaeser from CVDGO was present to ask for approval for having discounted parking passes for the club's annual tournament in May. His proposal was that each participant in the tournament pays a \$2 fee. Gibson moved to approve the request. It passed unanimously.

Paul Johnson was unable to attend the meeting to give an update on the Lake Altoona District's plans for future dredging and lake improvements. Supervisor Knight stated that there were no immediate plans for dredging this summer. He also indicated that the Town of Seymour has been discussing improving the boat landing located along Indian Hills

Blaeser from CVDGO indicated that all disc golf baskets have been pulled for the winter. He stated that their group had no complaints or issues with other user groups. An additional 12 short tee pads are to be installed this summer.

Kathy Michels from Chippewa Valley Trail Riders stated that Tower Ridge is a popular riding destination for many organized groups for trail rides. She commended parks and forest staff for their work on trail cleanup this winter. Also indicated that they would like to see about having some new maps made, like the new ski trail maps.

Chris Gorzek of the Ski Striders stated that he has been working with the disc golfers on laying out the area for the new skills park.

James Melville of the Eau Claire National Rifle Club gave a report on the recommendations from the sound study. The club would like to install a concrete noise barrier. Grant cycles are coming up September 15<sup>th</sup> for a project application. He also indicated that they may have some issues with zoning, as the rifle club is located within the floodplain.

Gorzek provided a report on the skills park and Ski Striders activities. Currently, there are over 150 kids registered in the skiing program. The Chippewa Valley Nordic teams have about 40 kids on them and they use Tower Ridge three times per week. The striders have over 25 volunteer coaches and students from UW-EC that help. The lighting project phase 1 is completed and phase 2 will be finished this summer. The skills park dredge material hauling has been bid out and awarded to Haas. Work on that will begin towards the end of the month.

Lavelle mentioned that the floodplain cutting policy needs to be brought back up and put on a future agenda.

Gibson mentioned tabled items that need to be placed on the next committee agenda including the senior citizen discount and the CORBA maintenance building.

Next meeting dates were set. March 2<sup>nd</sup> and March 9<sup>th</sup> at 5:00 PM at the Ag Center.

The meeting was adjourned at 4:16 p.m.
