Call to Order

The meeting was called to order by Supervisor Stella Pagonis at 3:59 PM.

Confirmation of Public Meeting Notice

The Clerk confirmed this meeting was properly noticed to the public.

Public Comment

Supervisor Pagonis made comments regarding the actual vice-chairperson versus what is reflected in the county contact book. The actual vice-chairperson is Supervisor Gerald Wilkie.

Approve Minutes from December 05, 2019 Meeting

Supervisor McKinney moved to approve the minutes from the December 05, 2019 meeting. The minutes were adopted as published in the meeting materials via 4-0 voice vote.

4th Quarter Fiscal Updates

- **Circuit Court/Clerk of Courts**
 - Susan Schaffer was unable to attend the meeting. The committee reviewed the information that was distributed in the meeting materials.
- **District Attorney**
 - District Attorney Gary King & Eric Huse presented the District Attorney's Office update. A budget surplus is projected. New attorney staff have settled into their roles.
- **Register in Probate/Clerk of Juvenile Court**
 - Jean Gay presented the Register in Probate/Clerk of Juvenile Court update. Juvenile numbers were down overall. There was an increase in delinquency filings. TPR case will likely go up as a new contract with an attorney. Corp Counsel changed their process for mental commitments which has led to a decrease in case filings. Within budget for end of the year.

Criminal Justice Collaborating Council

- **Dashboard Update**
 - A link to the dashboard website was included in the meeting materials. The data is completely refreshed monthly on the website with additional data being added periodically. The committee reviewed the information with Dana Swanstrom, who compiled and organized the information.
- **4th Quarter Fiscal Update**
 - Tiana Glenna presented the CJCC fiscal update. Aimee Drivas was recently hired as the Community Service Coordinator and is overhauling the current community service program. The program now monitors all community service participants regardless if they are completing community service out of Eau Claire County or as a condition of probation. If probation is ordered by the Court, it will be monitored by the program.

- **Treatment Court Statistics**
 - Brenda Goettl, treatment court supervisor, provided a handout which describes the fiscal situation of the treatment courts and various other statistics. The handout is included in these minutes. Of note, the year-to-date revenue does not include the medical assistance reimbursement. The operating capacity for treatment courts was reduced by four between 2018 and 2019. Treatment Court graduation rates are up over the previous year. This trend has been attributed to changes in programming with Vantage Point Clinic. Beginning March 01, 2020, the clinical treatment of participants will be moving to the Department of Human Services run clinic.
- **Community Transition Center Referrals**
 - The committee had questions relating to testing procedures and occurrences of tampering with testing. The committee engaged in discussion regarding the differences between urine and breath tests including costs and reliability.

Eau Claire County Sheriff's Office

- **4th Quarter Fiscal Update**
 - Danielle Powers presented the fiscal update. The report provided in the materials includes two funds; Fund 100 and Fund 212. Fund 100 is the Sheriff's Office operating budget and Fund 212 is the West Central Drug Task Force operating budget. They are projecting an end of year surplus overall. Compared to last year, the number of total cases handled is up but total bookings are down slightly.
- **Jail Population Update**
 - Currently there are no inmates housed out-of-county. Jail population has been unpredictable with significant swings in population.
- **Recruitment, Overtime, & Staffing**
 - Two of the four newly created correctional officer positions start next week. The other two positions are in the final stages of background screening. One correctional officer resigned at beginning of the year and will be filling that spot as soon as possible. Special Deputy staffing has been difficult to fill.
- **2nd Floor Security Screening**
 - Screening began June 2019. More than 51,000 people have been screened since implementation. 1,658 weapons were brought to the second floor including five firearms, more than 1,000 knives/blades, and 308 miscellaneous items considered weapons.

File No. 19-20/085 - Ordinance to amend Section 9.10.001 of the Code: Declaration of policy; To amend Section 9.70.005 D. of the Code: Definitions

This Ordinance is being brought by Supervisor Roberts through work with Human Rights Campaign. This Ordinance broadens the scope of protected status for individuals. Supervisor Roberts moved to approve the ordinance and present to the full County Board. **Approved** 4-0 via voice vote.






8 SECTION 1. That Section 9.70.001 of the code be amended to read:

10 9.70.001 Declaration of Policy. It is the intent of this chapter to prohibit discrimination
11 in housing within the boundaries of the County of Eau Claire pursuant to the authority granted to
12 counties by Wis. Stat. § 66.1011 It is the duty of the County of Eau Claire to assist in the orderly
13 prevention or removal of all discrimination in housing through the powers granted by the State of
14 Wisconsin. It is declared, therefore, to be the policy of the County of Eau Claire, in the exercise
15 of its police power on behalf of the public safety, health, and general welfare, that all persons
16 shall have an equal opportunity for housing regardless of actual or perceived sex, race, color,
17 physical condition, disability as defined in Wis. Stat. § 106.50 (1m)(g), sexual orientation as
18 defined in Wis. Stat. § 111.32 (13m), religion, national origin, sex or marital status, familial
19 status as defined in Wis. Stat. § 106.50(1m)(k), lawful source of income, age, or ancestry as
20 defined in the Wisconsin Statutes, and in all subsequent amendments to the definitions and
21 provisions outlined therein and age, gender identity, gender expression or veterans status.

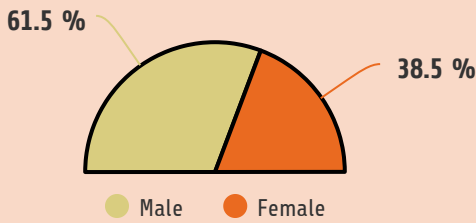

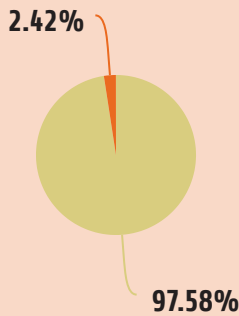

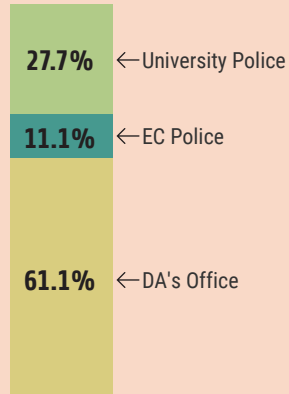

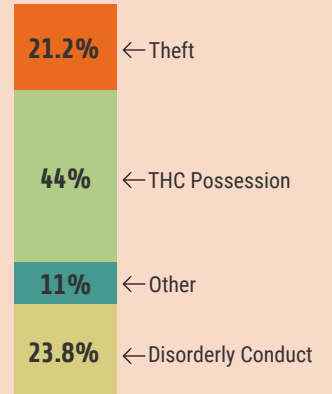

Referral Sources



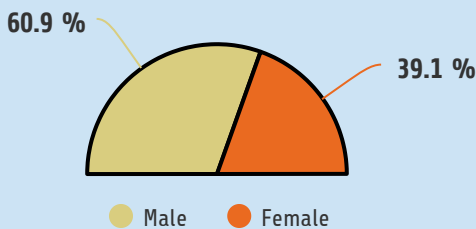

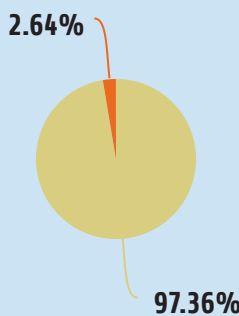

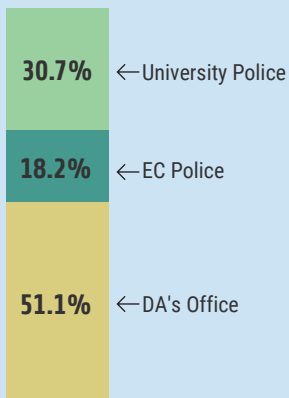

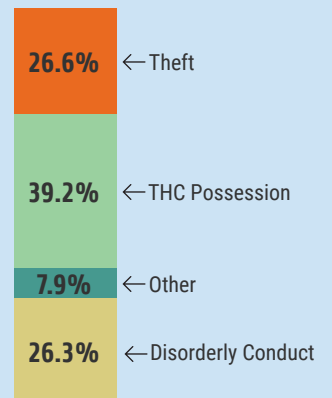

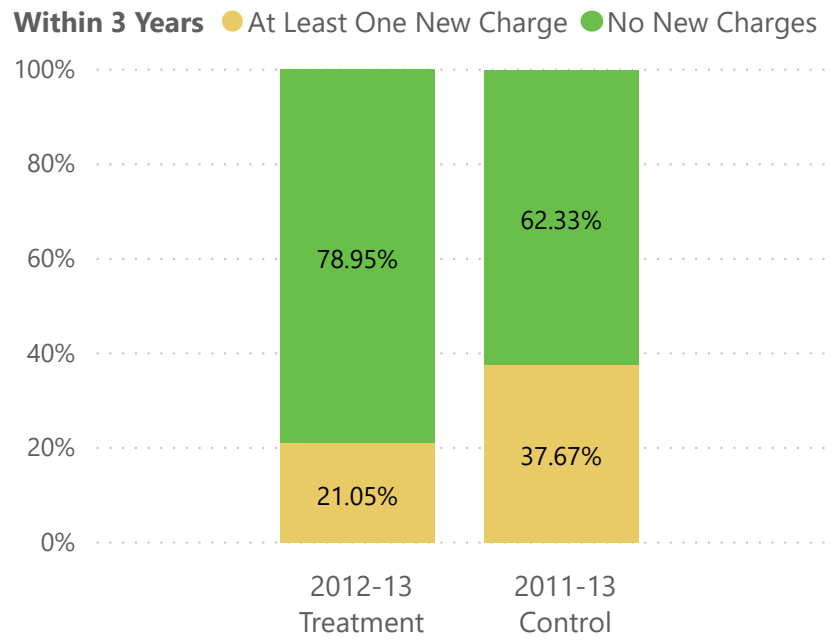

Recidivism Analysis

Review of Original Study

In 2016, the Eau Claire CJCC published [An Evaluation of the Eau Claire County Pre-Charge Diversion Program as Measured by Three Year Recidivism Rates](#). The key finding from the report was "...the risk of re-offense nearly doubles when offenders do not complete the Diversion Program and are instead formally charged."

The study compared offenders who successfully completed the Diversion Program in (2012-2013 Treatment) to a comparable low-risk group that did not receive the program (2011-13 Control) but would have qualified based on their charges and past criminal history. The graph to the right shows the 3-year recidivism rates for the participants in the original study.



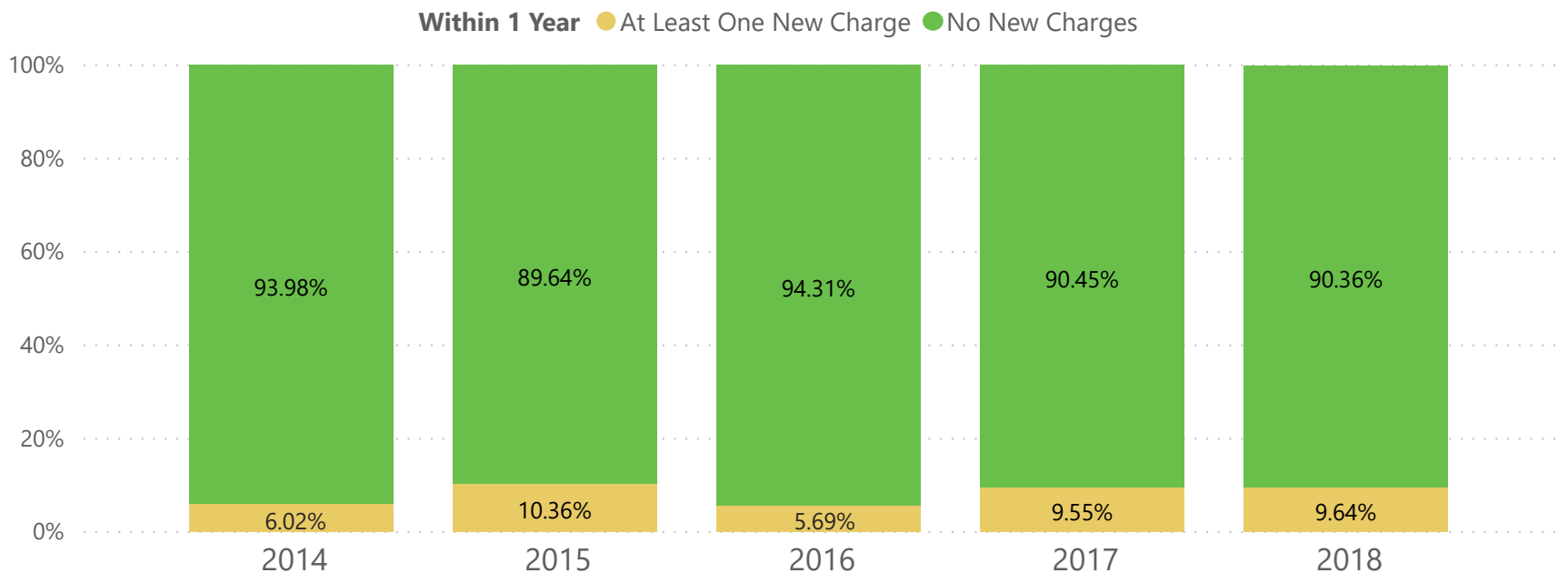
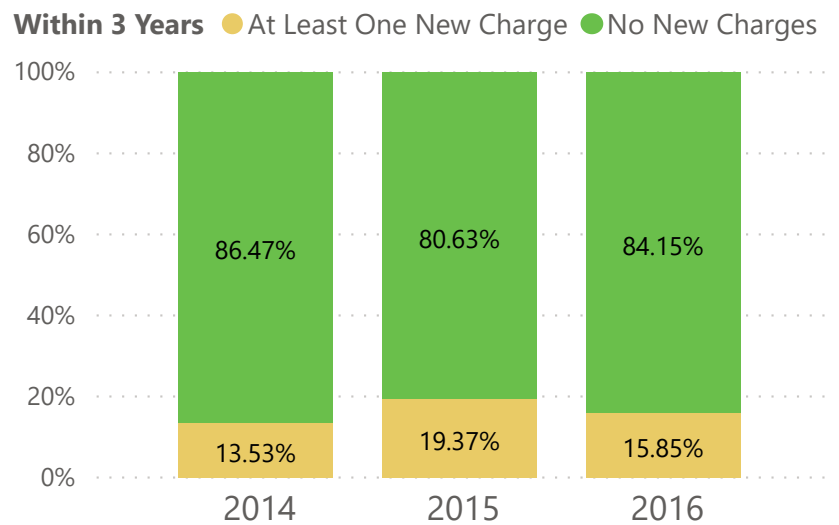
Recent Performance

Recidivism rates have continued to remain low for diversion groups since the original study.

The 2014-2016 3-year recidivism rates are shown to the right. All three years were an improvement of the original study.

Below are the 2014-2018 1-year recidivism rates. For comparison sake, 13% of the the diversion group (Treatment) from the original study had at least one new charge in the first year.

As you know by now, Governor Evers has signed the judgeship bill calling for an additional 12 judges in the state with 4 judges being added in each 2021, 2022, and 2023. The bill provides that the Director of State Courts determine which counties get new judges and when. There is no criteria or direction in the bill as to how to determine which counties get judges or when. The Director of State Courts has advised that he intends to announce the first 4 “sooner rather than later” and that the next four will be announced later this year.

Courtroom readiness was one of the considerations when the Office of Court Operations ranked the top 12 counties in need of a new judge in July of 2019. At that time, Eau Claire County ranked #5 on the list even without a ready courtroom. That may change, as other counties jockey for position to get a new judge. It is a competitive situation.

In the past I have urged the County to get Branch 6 completed as soon as possible, in light of the courtroom readiness issue. The Board has chosen to wait until a new judge has been approved for Eau Claire County before beginning construction.

I will continue to be in contact with the Director of State Courts in an effort to find out where Eau Claire County falls with respect to getting a new judge. In the meantime, I firmly believe that we should begin construction as soon as possible to enhance the likelihood that we will be included. The plans are finished and the money has been budgeted.

I will keep you advised of developments.

Gov. Evers Signs Bill Adding 12 New Branches to the Wisconsin Circuit Court

WAUSAU — Gov. Tony Evers today signed Assembly Bill 470 in Wausau, creating 12 new circuit court branches in the state of Wisconsin to be allocated by the director of state courts. This is the first addition of branches to the circuit court since 2010 and the largest addition in over two decades.

“Our justice system has been doing more with less for far too long, and today we are taking another step in ensuring that our justice system is operating efficiently and best serving our communities,” said Gov. Evers. “It took a strong bipartisan effort to get Assembly Bill 470 to my desk and I want to thank the folks who pushed to get this done to keep our justice system just and our communities safe.”

[Assembly Bill 470](#), now 2019 Wisconsin Act 184:

- Creates 12 new circuit court branches to be implemented four at a time on a rolling basis for terms beginning on August 1 in 2021, 2022, and 2023; and
- Allows the Director of State Courts to allocate the branches to counties based on need, resolutions, and established infrastructure, and to require a county to establish or apply for a treatment and diversion program grant or drug court grant as a prerequisite.

2019 WISCONSIN ACT

AN ACT to create 753.0605 of the statutes; **relating to:** adding 12 circuit court branches to be allocated by the director of state courts.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 753.0605 of the statutes is created to read:

753.0605 Additional circuit court branches. Notwithstanding s. 753.06, the director of state courts may add additional circuit court branches as follows:

(1) By November 14, 2020, the director of state courts may add 4 additional circuit court branches, to begin operation on August 1, 2021. The director of state courts may allocate each branch to any county that the director of state courts determines is in need of an additional circuit court branch if the county has passed a resolution requesting an additional circuit court branch and the county has established, or will have established by May 31, 2021, the appropriate infrastructure to support an additional circuit court branch. The director of state courts may require any county, as a condition for receiving a circuit court branch allocation under this subsection, to have established or to apply for a grant under s. 165.95 or 165.955 to establish a drug court.

(2) After November 14, 2020, and before November 14, 2021, the director of state courts may add 4 additional circuit court branches, to begin operation on August 1, 2022. The director of state courts may allocate each branch to any county that the director of state courts determines is in need of an additional circuit court branch if the county has passed a resolution requesting an addi-

tional circuit court branch and the county has established, or will have established by May 31, 2022, the appropriate infrastructure to support an additional circuit court branch. The director of state courts may require any county, as a condition for receiving a circuit court branch allocation under this subsection, to have established or to apply for a grant under s. 165.95 or 165.955 to establish a drug court.

(3) After November 14, 2021, and before November 14, 2022, the director of state courts may add 4 additional circuit court branches, to begin operation on August 1, 2023. The director of state courts may allocate each branch to any county that the director of state courts determines is in need of an additional circuit court branch if the county has passed a resolution requesting an additional circuit court branch and the county has established, or will have established by May 31, 2023, the appropriate infrastructure to support an additional circuit court branch. The director of state courts may require any county, as a condition for receiving a circuit court branch allocation under this subsection, to have established or to apply for a grant under s. 165.95 or 165.955 to establish a drug court.

SECTION 2. Nonstatutory provisions.

(1) **ELECTION FOR CIRCUIT COURT JUDGESHIPS.** The initial election for circuit judge positions created under s. 753.0605 (1) shall be at the spring election of 2021 for a

term beginning on August 1, 2021, and ending on July 31, 2027. The initial election for circuit judge positions created under s. 753.0605 (2) shall be at the spring election of 2022 for a term beginning on August 1, 2022, and ending on July 31, 2028. The initial election for circuit judge positions created under s. 753.0605 (3) shall be at the spring election of 2023 for a term beginning on August 1, 2023, and ending on July 31, 2029.

(3) 2021–23 BIENNIAL BUDGET REQUEST. The 2021–23 biennial budget request to the department of administration from the director of state courts for the court system shall include all of the following:

(a) Funding for 8 circuit court judge positions for the circuit court branches created under s. 753.0605 (1) and (2).

(b) Funding for 8 circuit court reporter positions for the circuit court branches created under s. 753.0605 (1) and (2).

(4) 2023–25 BIENNIAL BUDGET REQUEST. The 2023–25 biennial budget request to the department of administration from the director of state courts for the court system shall include all of the following:

(a) Funding for 4 circuit court judge positions for the circuit court branches created under s. 753.0605 (3).

(b) Funding for 4 circuit court reporter positions for the circuit court branches created under s. 753.0605 (3).

(c) Any proposed statutory changes necessary to conform the statutes to account for circuit court branches added under s. 753.0605.

TO FILE NO. 19-20/094

TO CREATE SECTION 10.30.040 DAMAGE TO COUNTY HIGHWAYS BY HORSES AND HORSE DRAWN VEHICLES; AND, TO AMEND SECTION 1.50.020 A.

SUBJECT

This ordinance addresses two items related to horses and horse drawn vehicles on county roads. The first item addressed is damage caused to county roads by horses and horse drawn vehicles. The second item addressed is horse manure on the roadway, including the shoulder, of county roads.

REQUEST

To help prevent damage to county highways by horses and horse drawn vehicles that use cleated horseshoes, only flat soles horseshoes are permitted on county highways during the months of May through Octobers each year. Also, all horse drawn vehicles operated on county highways shall be equipped with manure catching devices.

PURPOSE / JUSTIFICATION

Eau Claire County invests millions of dollars into our roadway infrastructure annually. These investments are designed to have a service life of 25 years. The damage caused to the roadway by horseshoes reduces the pavements surface performance by removing the fine aggregate surface that protects the asphalt composition from aging. This increases the rate of which the pavement deteriorates by 5 years on average.

TO CREATE SECTION 10.30.040 DAMAGE TO COUNTY HIGHWAYS BY HORSES AND HORSE DRAWN VEHICLES; AND, TO AMEND SECTION 1.50.020 A.

The County Board of Supervisors of the County of Eau Claire does ordain as follows:

SECTION 1.

Create: 10.30.040 Damage to County Highways by horses and horse drawn vehicles.

- A. To prevent damage to county highways by horses and horse drawn vehicles that use cleated horseshoes, only horseshoes with flat soles are permitted on county highways during the months of May through October each year.
- B. All horse drawn vehicles operated on county highways shall be equipped with manure catching devices.
- C. Violation and penalty. Person who violate provision of this chapter shall be subject to the forfeiture schedule at 1.50.020.

SECTION 2.

Amend Section 1.50.020 A. by adding the following to the schedule of deposits:

Original plans were to budget for the replacement of the oven in 2021 with Capital Funding. However, the urgency to get this equipment replaced is more immediate than originally anticipated. The oven has recently become non-functioning. Please see the attached letter taking the current oven out of service. This oven is original to the facility that opened in 2011. It is of high importance to replace this oven immediately as it is used to provide three meals daily to the Eau Claire County Inmates and the Northwest Regional Juvenile Detention Center Clients.

We are requesting to use contingency funds to replace this oven.

Fiscal Impact: The estimated cost of the replacement is \$18,100.00

We found a cracked/damaged heat exchanger in your oven during the inspection. In this condition, your unit is not safe for use and must be repaired or replaced. Under rare circumstances, the unit's heat exchanger could fail. Failure could pose a serious risk of injury or death to bystanders, as well as significant property damage. Lock out and tag out your unit. If you operate the unit in its current condition against our direction, you assume all risks.

We understand the inconvenience this will cause your business and would like to share options to help address this issue:

Background: The Criminal Justice Collaborating Council (CJCC) is currently within the department of Administration and the CJCC Manager reports to the County Administrator. The CJCC Manager position description was reviewed and changes were made to bring this position to a director level.

The CJCC Manager has been increasingly responsible for duties that would be asked of a department head and has been working in a near-autonomous manner. The CJCC Manager position description was reviewed and updated to better reflect current responsibilities and to adjust language to reflect a standalone department and the duties that accompany it. These changes move the position from Pay Range R to Pay Range S.





