Judge Michael Schumacher called the meeting to order at 7:30 a.m.

The Council reviewed the minutes from the December 18, 2019 meeting. Administrator Schauf motioned to approve the minutes as presented; Tim Wavrunek seconded. The minutes were approved.

Bill Stein – Department of Human Services, presented on the CCS (Comprehensive Community Services) program about what the program is, what it does and what it can do, its link to Stepping Up and jail reentry work and process issues on referrals. Currently there are 261 participants in the program. The program has 25 service facilitators, 6 mental health counselors, 6 substance abuse counselors and many various other support staff. There are currently children and adults on the waitlist. This program is a voluntary program. MA is the fiscal provider of the program.

Department/Other Updates:

- Tim Wavrunek will be leaving Restorative Justice to pursue a new opportunity with Goodwill.
- Tiffany Winter has joined the DA's office.
- CJCC has been selected for 1 of 13 sites for the PLN through NACo.

Brenda Goettl gave an update on Treatment Courts. 82 people were served in 2019. Graduation rate of 66% and the goal was to be over 60%. LSS will be assisting with assessments. Treatment services are changing on March 2 from Vantage Point to in house services.

Judge Schumacher reminded everyone of the CJCC Strategic Planning Session on March 27 beginning at 8 a.m. at the airport. Lunch will be provided.

The meeting was adjourned at 8:36 a.m.
