- 1. Call to order and confirmation of meeting notice Chairperson Mowry call to order the meeting at 4:00 p.m. and he confirmed that the meeting was properly noticed.
- 2. Roll Call Members present noted above.
- 3. Public Comment (limit to 3 minutes per person) None
- 4. Review/Approval of Committee Minutes from February 20, 2020 **Discussion/Action**Mark Zuber motioned to approve the minutes as presented, Luke Hanson seconded the motion; all in favor.
- 5. Closed Session pursuant to Wisconsin Statutes 19.85 (1)(e) for the purpose of discussing and sharing proprietary information from an outside agency regarding research and potential revenue of that agency.

RE: FirstNet/ATT

Scott Hoffman motioned to go into closed session, Lynn Thompson seconded the motion; all in favor.

Mark Zuber motioned to go out of closed session, Scott Hoffman seconded the motion; all in favor.

6. Update on current and future projects - Discussion

Mark Zuber gave an update of the Town of Drammen broadband project. Mr. Zuber has been in conservation with TriCounty-24/7 and is discussing an advisory survey. The town board would require that a minimum of 75% of the surveys be returned and 60% of those would have to be in support to raise taxes. Mark indicated that it would be \$85 per 100,000 of assessed value. If there's citizen support the Town would actively look for partners for the project. Mr. Zuber anticipates having an answer by the town board meeting in July which would allow time to prepare the grant.

Luke Hanson, Economic Development Association – EDA due to the CARES Recovery Act 1.5-billion-dollar broadband expansion grant is available with a 80/20. Craig Johnson with the West Central Regional office is the lead contact.

Dave Hayden updated the committee regarding work on LTE on several towers in Eau Claire County. This project replaces the WiMAX technology with LTE. He noted that this is a public/private partnership with Astera (formerly Packerland).

Lynn Thompson inquired about Charter Spectrum and what their next steps was considering expanding service to marginal areas of Eau Claire County.

7. Funding sources for project match and any new grant funding opportunities - Discussion

Don Mowry updated the committee regarding potential funding sources. April 1st deadline for the FCC 5G fund for rural American 1 billion dollars available. The program focuses on rural areas that lacks mobile service with a second phase available for precision agriculture.

Mr. Draxler noted that the telecommuting health grant just closed which focused on health care.

Taylor County Broadband for profit project that costs 7 million dollars.

Eau Claire County needs to be part of the funding solution but currently funds are not available. The County could assist by securing low interest loans for township.

Mark Zuber indicated that there are no new updates.

9. Broadband Survey Update - Discussion/Action

Rod Eslinger gave a brief of the broadband survey.
