Motion to approve the minutes from the June 10th Fair Committee Meeting by Jennifer Haahn, second by Tyson Flottmier. Motion carries.

Fair Coordinator Report: Debbie Kitchen updated the committee on her meeting with the Health Department. The current order allows 50 to be indoors, and 100 outdoors. Discussion among the committee regarding if we could hold a fair under the current order. There would be a lot of planning we would need to do to meet the requirements. Discussed among the group our options of holding a live fair, a virtual fair, or cancel. Discussed how we would have to monitor people coming into the grounds. Would have to consider using wrist bands, and take down the name of the people attending. Discussed the amount of exhibitors we have for certain species, and if they each had a parent on the grounds we are already at our capacity. Discussed how we could still have a live auction.

Motion by Scot Zimmerman to not have a virtual fair. Second by Tammy Schlewitz. Motion carries. Vote was taken: 8 in favor, 1 no vote

Discussed having the most people on the grounds on Saturday with the swine show and the live auction.

Motion by Scot Zimmerman that based on the county order that comes out on June 24th, that if the order doesn't allow 200 people on the grounds we cancel, or if it allows 200 or over, we will continue with the last schedule that Debbie Kitchen provided. Second by Tyson Flottmier. Motion carries. Vote was taken: 5 in favor, 3 no, 1 did not vote

The next County Order comes out on June 24th. After that order we will make our final announcement.

Motion by Scot Zimmerman to announce that the final fair announcement will be following the County Order that is issued on June 24th. Second by Jennifer Haan. Motion carries. Vote was taken: 7 in favor, 2 did not vote

Discussion on pushing back the fair entry dates.
