Chair Pagonis called the meeting to order at 4:36pm and confirmed compliance with open meetings law.

Amy Weiss took roll call.

No members of the public wished to comment.

Norb Kirk reviewed the Covid-19 cost summary report. Through May 20, 2020, the county incurred approximately \$259,000 of Covid related costs. The county expects FEMA to cover about 75% in supplies costs. The sales tax report only includes data through March. April activity will be reported in June.

Norb Kirk gave an update on the 2020 bond issue and Moody's rating call update. The analyst cautioned that continued impacts to the general fund will eventually result in a downgrade, but highlighted the county's strong tax base growth. The 2020 bond sale, which includes a new issue for 2020 capital needs and a refunding of the 2010B issue, is scheduled for June 16, 2020 at 10:00am.

Norb Kirk gave an update on the 2019 audit and presented an updated general fund balance which is central to audit discussions. This updated general fund balance was also referenced during the Moody's rating call. The managing partner on the audit is scheduled to present the 2019 audit at the July 13 Committee on Finance & Budget meeting.

Diane Cable and her team presented fiscal information for the DHS fiscal review. Vickie Gardner reviewed the 2019 preliminary budget to actual comparison by program.
