During public comment, Supervisor Pagonis informed the committee that the Butterfly House at Beaver Creek Reserve is open.

Brock Geyen from CliftonLarsonAllen reviewed the draft audit summary for year ended 12.31.19.

Board Chair Nick Smiar left the meeting at 5:20pm.

Sean Lentz presented options for possible refunding of 2011B bonds. Advanced refundings were eliminated under tax law changes, but alternative methods are available that still align with federal law. These include a Cinderella bond issue, a taxable bond issue, or a Forward Purchase issue.

Jason Szymanski and Jon Johnson presented five phased scenarios for the new highway facility. The committee feels that it is not palatable to fall behind on Pacer rating. The committee favors scenarios one or two.

The committee reviewed ECC's current debt structure. ECC should be borrowing for facility related improvements and is working toward putting operational equipment on the operational levy, beginning with the 2021 budget.
