Call to Order

The meeting was called to order by Chairperson Wilkie at 3:00 PM.

Call of the Roll

The Clerk called the roll. Attendance was noted above.

Confirmation of Public Meeting Notice

The Clerk confirmed this meeting was properly noticed to the public.

Public Comment

David Carlson made comments in opposition to High Intensity Drug Trafficking Area (HIDTA) funding. A transcript of the comments are included in these minutes.

Kimberly Cronk made comments requesting additional information regarding HIDTA grant funding.

Approve Minutes from Previous Meetings

Supervisor McKinney moved to approve the minutes from the July 22, 2020; August 26, 2020; and September 02, 2020 meetings. The meeting minutes were adopted as published in the meeting materials via 5-0 voice vote.

Criminal Justice Collaborating Council Dashboard Update

- Dashboard
 - A link to the dashboard website was included in the meeting materials. The data is completely refreshed monthly on the website with additional data being added periodically. The Committee reviewed the information with Director Tiana Glenna.
- Report from Supervisor Russell
 - Supervisor Russell gave a brief overview of what occurred at the August 19, 2020 meeting. The CJCC reviewed the CJCC and Treatment Court budgets. The CJCC also appointed LaRue Pierce to the vacant citizen member position.

Eau Claire County Sheriff's Office Updates

- **Jail Population, Staffing, & COVID-19 Response**
 - Since COVID-19, the jail population has been around 130-150 inmates. Bookings are also down significantly but there has been an increase as of late.
 - Captain Dan Bresina has retired. Dave Riewestahl has been promoted to Captain filling the spot vacated by Bresina. There are a number of other retirements and resignations in the next month across all divisions. The fingerprint/DNA room is open again though there are staffing concerns with the Special Deputies that staff that room.
 - Captain Riewestahl recapped the August 11, 2020 National Guard COVID-19 testing event at the jail. He noted he could not force staff and inmates to be tested. Each person had a right to choose whether they were tested or not. Captain Riewestahl consulted with Corporation Counsel, Human Resources, and the Health Department throughout the planning of the event. Testing was open to all inmates, jail staff, and any other individuals who frequent the jail (maintenance staff, chaplains, etc.). 49 out of 138 total inmates were

tested. 31 staff were tested. Test results as of Monday, September 21, 2020: 144 tested, 8 positive, 8 recovered, no hospitalizations, no deaths.

- **Inmate Voting**

- Captain Riewestahl said he has been collaborating with County Clerk Janet Loomis. They updated the Jail Kiosk to add resources including voting websites and information, however, due to system vulnerabilities that has had to be scaled back. The jail is following the ACLU Ballots for All checklist.

Transferring \$100,000 from Sheriff's Department Overtime Account to Investigative Services Account

The Sheriff's Office currently has \$100,000 in overtime budget that will not be spent. The Sheriff's Office is asking to move that money to perform a forensic audit of the Department of Human Services. Supervisor Roberts moved to support the transfer of \$100,000 from the Sheriff's Department Overtime Account to Investigative Services Account and recommends this course of action be taken by the Committee on Finance and Budget. The Chair called for a roll call vote on the motion: JANSSEN no; MCKINNEY no; ROBERTS aye; RUSSELL no; WILKIE aye. The motion **failed** 2-3.

My name is David Carlson and I live at 2212 Altoona Avenue, Eau Claire, WI 54701.

I have provided the Committee on Judiciary and Law Enforcement, the Criminal Justice Collaborating Council, and the Eau Claire public with factual information pertaining to the High Intensity Drug Trafficking Designation placed on Eau Claire County, and general data showing the failure of the war on drugs, both in human cost and economically.

I will now pay recognition to the names of the people of color killed by police in HIDTA Designated counties. Breonna Taylor. She was shot to death by Louisville Police in front of her boyfriend Kenneth Walker. Louisville is in Jefferson County Kentucky, a HIDTA designated County.

George Floyd. He was killed on the street in South Minneapolis by Minneapolis Police Officer Derek Chauvin. Most of the world has seen the footage of Chauvin's knee on Floyd's neck. Minneapolis is in Hennepin County, Minnesota. Hennepin County is a HIDTA designated county.

Philando Castile. Pulled over in his car with his partner Diamond Reynolds and her four-year-old daughter in the back seat, Castile was shot to death through the driver side window by a Minneapolis Police Officer. Once again, Minneapolis is in Hennepin County, a HIDTA designated county.

Michael Brown. Shot to death by law enforcement in front of his friend Dorian Johnson in St. Louis County, Missouri. St. Louis County is a HIDTA designated county. Eric Garner. Died from being placed in a chokehold by New York City Police Officer Daniel Pantaleo. Once again filmed for the world to see. New York City is part of the New York/New Jersey HIDTA designation. John Crawford III. Shot to death by law enforcement in a Walmart in Beaver Creek, Ohio. The surveillance cameras recorded the shooting. Beaver Creek is in Greene County Ohio. Greene County, Ohio, is a HIDTA designated county.

Ezell Ford, Dante Parker, Michelle Cusseaux, Rayshard Brooks, Daniel Prude, Atatiana Jefferson, Aura Rosser—all killed by law enforcement in HIDTA designated counties.

These names belong to human beings, American citizens. I have given public comment after public comment detailing the factual basis of my arguments. So now I am appealing to every listener's humanity. The law enforcement infrastructure of our area is choosing to model the actions and practices of the counties in which these human beings of color were violently killed at the hands of police. If we continue down the same road these other counties have, we will produce the same outcomes. And just because it has not happened yet, does not mean it will not happen.

The actions of police departments, sheriff's departments, district attorney's offices, criminal courts, departments of corrections—these are the institutions that are traumatizing our Black and Brown brothers and sisters. These institutions are partly responsible for the perpetuation of violence, addiction, incarceration, and suffering witnessed in populations of color. I say

partly, because the United States as a collective has reinforced discriminatory practices in housing, education, and employment, that push Black and Brown people into contact with law enforcement officers.

If we are to find sustainable solutions to these issues, we need the Eau Claire County law enforcement infrastructure to cease undercutting our efforts at progress. Pull out of this HITDA designation. Give back the federal money if it has already been received. Thank you.

Good afternoon Judiciary and Law Enforcement Committee Members,

My name is Kim Cronk and I am a long-time resident of Eau Claire County. I appreciate the opportunity to make some brief comments today for your consideration.

When the Eau Claire Co. Board recently approved the grants for the West Central Wisconsin Drug Task Force, I questioned and will continue to question the need for ongoing militarized equipment. It is not a question of monetary cost per se, as clearly these items are funded, but a question of need in our community, human cost, and the inequitable outcomes that have and can continue to be created.

As all departments have been showing their performance measures and the County Board unanimously approved the Resolution Declaring Racism as a Public Health Crisis in July, it is important that we establish metrics and data (both qualitative and quantitative) with each area and their outcomes. While the public is able to view some simple metrics of the West Central Wisconsin Drug Task Force, there is not much information on the demographics of who they interact with, use of force data, no knock warrant data, what they actually seize, and how those funds or items are tracked and utilized. Those are all some examples of indicators of performance, though additional metrics may be needed as well. In a conversation with Corporation Counsel, it seems that the Sheriff's Department can keep up to 50% of the forfeitures, if their receipts of work, staff time, etc. is documented on the Wisconsin Department of Administration's Forfeitures website, while the other 50% goes to the School Fund. I am trying to understand the way the public can view the tracking of these funds as there is nothing listed for our County's department/Drug Task Force for the years of 2018, 2019, or 2020, yet the County Board approved (though not unanimously) on Sept. 15th, 2020 the West Central Drug Task Force's Forfeiture Funds in the amount of \$13,794. I still do not understand what that entails, not from this year nor previous years, so I am looking for some more in-depth education in this area to ensure not only I, but the public understands. Since this Committee has oversight, I am looking to you to assist in that understanding.

Along the same lines of concern and need for communication/explanation is the High Intensity Drug Trafficking Area Designation (HIDTA). This designation has been a source of community concern, conversation, public comments, at least one public forum, and the need for more information. It has been an item on at least three different committee or council agendas so far with no more information nor understanding than when the designation was initially granted months ago. At one of the recent CJCC Exec meetings there was an ask by County Board Chair Smiar to have the grant application be brought to the next full CJCC meeting as the HIDTA was going to be on their agenda. The grant was not available at the time to the public, nor was there much, if any discussion or information. It would be important to have this again on an agenda for education, along with the aforementioned original grant application, not only for this Committee, but for a potential presentation to the full County Board.

As we work to move forward in our community to collaborate, provide transparency, and center community on how people view public safety and desire to be protected, it is important that we have the information we need to ensure we are committing to creating equitable budgets, policies, and outcomes. Having accurate information and centering community are critical. I am hopeful you will look to add agenda items on both the West Central Drug Task Force detailed performance metrics, including forfeiture explanations, and the HIDTA grant with an in-depth explanation and the previously requested grant application for your next Judiciary and Law Enforcement Committee meeting.

Good morning Supervisor Wilke,

I appreciate your patience with this email as it has been busy and productive since our Co. Board meeting. I also appreciate your willingness to potentially add items to the agenda that need more information and understanding, both internally and for the public. When the Board recently approved the grants for the West Central Wisconsin Drug Task Force, I questioned and will continue to question the need for ongoing militarized equipment. It is not a question of monetary cost per se, as clearly these items are funded, but a question of need in our community, human cost, and the inequitable outcomes that have and can continue to be created.

As all departments have been showing their performance measures and the County Board unanimously approved the Resolution Declaring Racism as a Public Health Crisis in July, it is important that we establish metrics and data (both qualitative and quantitative) with each area and their outcomes. While the public is able to view some simple metrics of the West Central Wisconsin Drug Task Force, there is not much information on the demographics of who they interact with, use of force data, no knock warrant data, what they actually seize, and how those funds or items are tracked and utilized. Those are all some examples of indicators of performance, though additional metrics may be needed as well. In a conversation with Corporation Counsel, it seems that the Sheriff's Department can keep up to 50% of the forfeitures, if their receipts of work, staff time, etc. is documented on the Wisconsin Department of Administration's Forfeitures website, while the other 50% goes to the School Fund. I am trying to understand the way the public can view the tracking of these funds as there is nothing listed for our County's department/Drug Task Force for the years of 2018, 2019, or 2020, yet the County Board approved (though not unanimously) on Sept. 15th, 2020 the West Central Drug Task Force's Forfeiture Funds in the amount of \$13,794. I still do not understand what that entails, not from this year nor previous years, so I am looking for some more in depth education in this area to ensure not only I, but the public understands. Since this Committee has oversight, I am looking to you to assist in that understanding.

Along the same lines of concern and need for communication/explanation is the High Intensity Drug Trafficking Area Designation (HIDTA). This designation has been a source of community concern, conversation, public comments, at least one public forum, and the need for more information. It has been an item on at least three different committee or council agendas so far with no more information nor understanding than when the designation was initially granted months ago. At one of the recent CJCC Exec meetings there was an ask by Chair Smiar to have the grant application be brought to the next full CJCC meeting as the HIDTA was going to be on their agenda. The grant was not available at the time to the public, nor was there much, if any discussion or information. It would be really important to have this again on an agenda for education, along with the aforementioned original grant application, not only for this Committee, but for a potential presentation to the full County Board. Chair Smiar, I am respectfully including you in this email because I am mentioning you and was hoping your ask would shed some light internally and for the public.

As we work to move forward in our community to collaborate, provide transparency, and center community on how people view public safety and desire to be protected, it is important that we have the information we need to ensure we are committing to creating equitable budgets, policies, and outcomes. Having accurate information and centering community are critical. I am hopeful you will look to add agenda items on both the West Central Drug Task Force detailed performance metrics, including forfeiture explanations, and the HIDTA grant with an in-depth explanation and the previously requested grant application for your next Judiciary and Law Enforcement Committee meeting.

10 **WHEREAS**, in Children in Need of Protection or Services (CHIPS) proceedings pursuant to Chapter 48, Wis.
11 Stats. (The Children’s Code), when a child is taken into custody and not immediately released to a parent, guardian,
12 or legal custodian, the judge or circuit court commissioner in the county where the child is being held must hold a
13 detention hearing within 48 hours of the time in which the decision to hold the child was made (excluding Saturdays,
14 Sundays, and legal holidays); and

15 **WHEREAS**, in similar actions involving Juvenile Justice proceedings pursuant to Chapter 938, Wis. Stats.
16 (The Juvenile Justice Code), when a juvenile is taken into custody and held by a county, the circuit court must hold a
17 detention hearing within 24 hours after the end of the day on which the decision to hold the juvenile was made
18 (excluding Saturdays, Sundays, and legal holidays); and

19 **WHEREAS**, as a result of the discrepancy in the timelines between the Chapter 48 and Chapter 938
20 proceedings, in Chapter 938 cases county circuit court judges, commissioners, juvenile intake workers, and other
21 courthouse staff need to be prepared to conduct hearings in circumstances in which the county courthouse may
22 otherwise be closed, such as the Friday after Thanksgiving, extreme weather days, etc. Failing to meet the statutory
23 deadlines places the county at risk of losing jurisdiction over the pending matter. Additionally, concerns may arise
24 regarding transportation of juveniles and children on non-work days in order to accommodate hearings.

25 **NOW, THEREFORE, BE IT RESOLVED** by the Winnebago County Board of Supervisors that it hereby
26 supports legislation that would align the statutes that compute the detention hearing timelines for Children in Need of
27 Protection or Services (CHIPS) proceedings under Chapter 48 and juvenile delinquency proceedings under Chapter
28 938 by specifying that a day in which the Clerk of Circuit Courts Office is closed does not count toward the
29 computation of the detention hearing timeline under Chapter 938. This will ensure county governments are in a
30 better position to save limited resources and protect the safety of their employees and the public.

31 **BE IT FURTHER RESOLVED** by the Winnebago County Board of Supervisors that it hereby directs the
32 Winnebago County Clerk to forward a copy of this Resolution to all Wisconsin Counties, the Wisconsin Counties
33 Association, and all state senators and assembly members representing Winnebago County constituents.
