### MINUTES

#### Eau Claire County Committee on Parks and Forest Monday, November 9, 2020 at 5:00 p.m. *Virtual Meeting*

Members Present: Kevin Stelljes, Tami Schraufnagel, Joe Knight, Gary Gibson, Missy Christopherson

Others Present: Samantha Kraegenbrink – Acting Committee Clerk, Jody Gindt, Jacob Tumm, Dale Zank, Josh Pedersen, Chris Gorzek, Erika Gullerud, Mark Blaskey, Kyle Johnson

Public: Present

Chair Stelljes called the meeting to order at 5:00 p.m. and confirmed meeting notice.

Verbal roll call was taken and indicated above under present.

No members of the public wished to make comment.

Supervisor Christopherson motioned to approve minutes from October 19, 2020 as presented. All in favor, none approved, minutes approved.

Dale Zank was in attendance to provide detail and an ask to place a state historical marker at the Lake Eau Claire Dam. There would be no cost to the County unless the County wished to donate. The County would be involved in all signage and design. Motion by Supervisor Schraufnagel motions to approve the beginning of the process, all in favor.

Mark Blaskey was in attendance to request placing a sculpture (example provided in the November 9, 2020 packet – page 5.) After discussion, Supervisor Knight motions to accept the donation of the memorials to be placed at Tower Ridge. All in favor, none opposed.

The committee discussed CORBAs request to rent storage space at Expo Center Building C. Representatives (Bailey and Dan) from CORBA joined the Webex meeting to answer questions/provide more detail of the request. In order to proceed, would need to have an agreement and rent considerations per Corporation Counsel. Motion by Chair Stelljes to authorize Director Pedersen to negotiate a three-year contract with CORBA in lieu of the storage container authorized previously. All in favor, none opposed.

Jacob Tumm provided an update on the fall 2020 timber sales. Advised there is current 14 sales out for bids or about to go out for bids. The committee further discussed timber sales and location. Chair Stelljes asked if there was the ability to change the contracts to extend out to two years to stay competitive and minimize the need for companies to ask for extension. Supervisor Knight motions to extend the base contract period to two years. No further discussion. All in favor, none opposed.

The committee discussed approval of the timber sales as presented to the committee. All in favor of the sales, none opposed.

The committee discussed the 2021 budget that was approved by the County Board at the November 5, 2020 meeting. Position addition was approved as well as approval of the capital funds to replace the failing septic system at Lake Altoona.

Director Pedersen discussed the 2021-2036 County Forest Comprehensive Land Use Plan Public. Originally planned was to have a public open house to discuss the plan. Pedersen is proposing that draft chapters be approved by the committee and once approved, would be released for the public to provide comment. Once

posted, the committee would have a public meeting to answer any public concerns at the next committee meeting followed by a vote to approve the plan. Supervisor Christopherson motions to approve the amended plan for the public comment process of the comprehensive plan. All in favor, none opposed.

Chair Stelljes provided background and detail on agenda item Forest carbon sequestration paper.

The following items were requested to be placed on the next regular meeting of the Parks and Forest Committee:

- Request to add discussion of Kickin Kids and COVID-19 (Health Dept.) concerns. Would like more details.
- Compliance on parks admission
- Review of four to six chapters of the 2021-2036 County Forest Comprehensive Land Use Plan

The meeting was adjourned at 6:35 p.m.

## FACT SHEET

## TO FILE NO. 20-21/091

## **RE:** Amending Section 16.30.010 D. of the code: Designating the Riverview Road Trailhead as a wayside.

Riverview Road terminates at a trailhead at the corner of Seymour, Washington, and Lincoln Townships. Presently there is a parking area adjacent to a section of the County Forest containing approximately 407 acres. This area contains a network of trails and logging roads, including numerous access points to the south side of the Eau Claire River.

This parking area and trailhead is gated and bermed to restrict vehicle traffic. The area is widely used for walking, snowshoeing, hunting and access to the Eau Claire River. Unfortunately, the parking/trailhead area has also become a common area for uncontrolled shooting. There have been several incidents reported by users of dangerous encounters with firearm discharges accidentally coming near people. Also the area has been a chronic source of shooting litter, including spent ammunition and target debris consisting of anything from clay target pieces, glass, cans, to semi-explosive materials. Recently, there have also been incidents of firearms being used to shoot down small trees using weapons apparently capable of large round capacities.

The proposed ordinance will designate the trailhead area of approximately 1.7 acres as a wayside. Existing County code 16.30.180 prohibits the possession of loaded firearms in the named waysides. Loaded firearms will continue to be allowed in the remaining 405 acres. The legal description and map of the wayside will be retained by the Parks and Forest office as noted in existing code. A copy of the map is attached for reference only.
