The meeting was adjourned at 6:47 p.m.

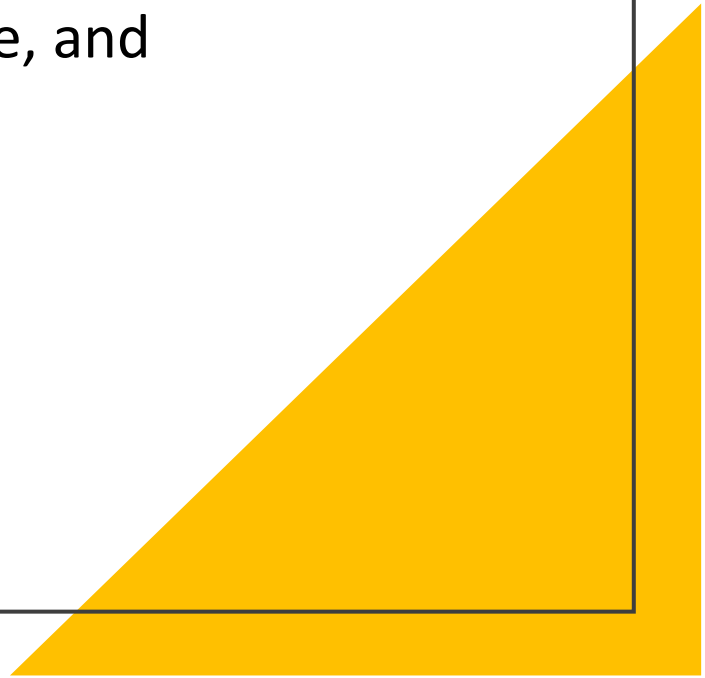

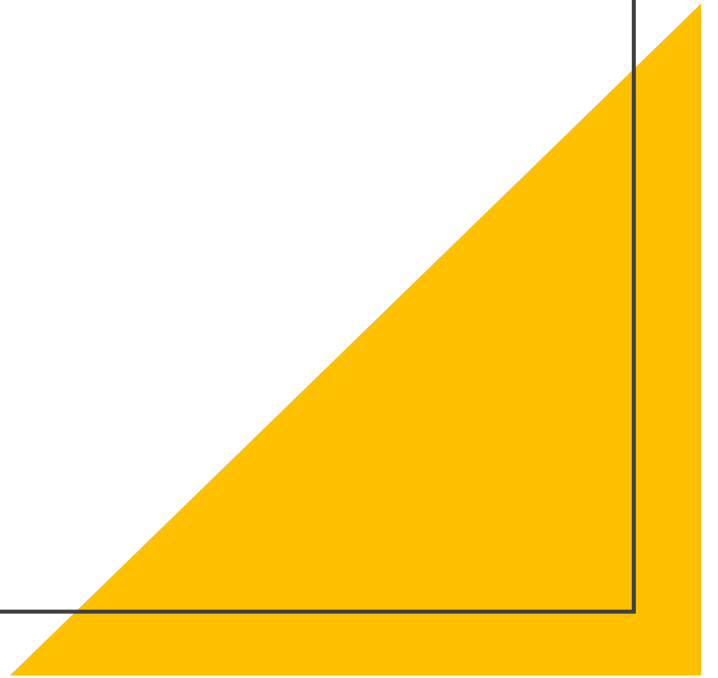

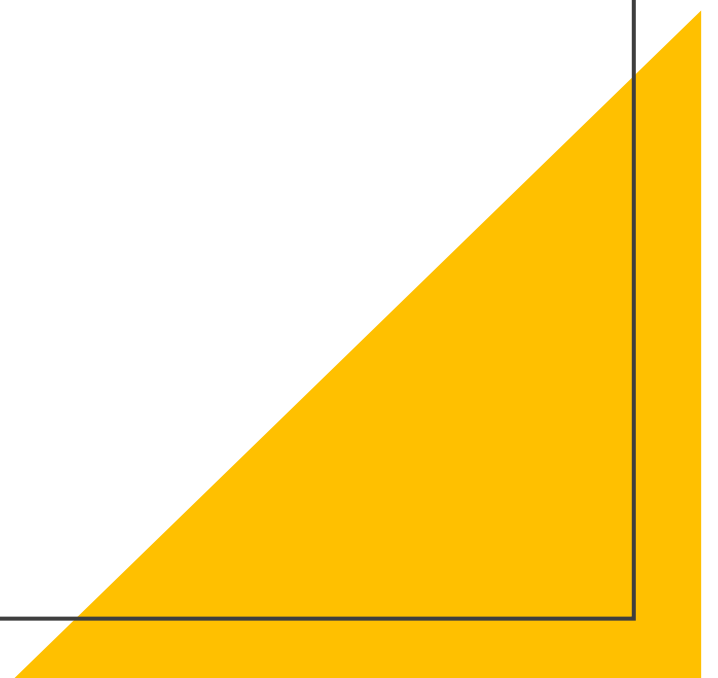
Vision
