BEHAVIORAL HEALTH SERVICES

Comprehensive Community Services (CCS)

CCS provides recovery focused programming for people of all ages living with either a mental illness and/or substance use disorder. CCS is for individuals who need ongoing services beyond occasional outpatient care, but less than the intensive care provided in a hospital setting. The individual works with a dedicated team of service providers to develop a treatment and recovery plan to meet the individual's unique needs and goals.

Community Support Program (CSP)

For chronically mentally ill persons who are able to live in the community when they receive these services.

- Provides a range of treatment, rehabilitation, and support services
- Help persons function in the community with a better quality of life
- The majority of services are provided to people in the community, in non-office or non-agency based settings
- Provision of treatment services by way of a multidisciplinary and integrated recovery team including AODA services
- Goal is to enhance the recovery and functioning of individuals with serious mental illness

Coordinated Services Team (CST)

The mission of the CST is to maintain children with multiple needs in a family setting. The program partners believe a family setting is key to a child's growth and are committed to a working partnership with families and agencies to achieve this mission.

Children's Long-Term Support (CLTS)

CLTS MA Waivers support children who are living at home or in the community who have substantial limitations in multiple daily activities as a result of one or more of the following disabilities: Developmental and /or physical disabilities, severe emotional disturbances

Adult Protective Services/Crisis Services

Adult Protective Services/Crisis provides protection, advocacy, outreach, intervention and guardianship/protective placement coordination to Eau Claire County residents who are Elder Adults at Risk, persons age 60 or older who have experienced, are currently experiencing, or are at risk of experiencing abuse, neglect, self-neglect, or financial exploitation, and/or Adults at Risk, persons age 18 to 60 who have a physical, cognitive, or mental impairment that restricts his or her ability to care for his/her needs and who has experienced, is currently experiencing, or is at risk of experiencing abuse, neglect, selfneglect, or financial exploitation.

Intensive Case Management

Eau Claire County Department of Human Services – Intensive Case Management provides Recovery based case management to Eau Claire County residents who have been diagnosed mental health and/or substance abuse condition that are under a Mental Health Commitment, Settlement Agreement, and on-going voluntary clients with mental health and/or substance abuse issues. Case managers assess safety and compliance regarding court order treatment and services as well as collaborate, coordinate and secure a variety services for individuals involving appropriate professional and paraprofessional staff in programs, through provider agencies, and other community resources.

Eau Claire County Treatment Courts

We serve adults with substance abuse and/or mental health diagnoses who have recurring criminal justice system involvement.

•Alternatives to Incarcerating Mothers (AIM Court) – Serves mothers with substance use dependencies who have dependent children. Participants also may have a mental health condition.

•Drug Court – Serves adults with substance use dependencies. Participants also may have a mental health condition.

•Mental Health Court – Serves adults with mental health conditions that contribute to criminal offenses. Participants also may have a substance use condition.

•Veterans Court – Serves adults with mental health and/or substance use conditions who have served in any of armed forces.

Outpatient Mental Health Clinic
