1. Call to Order and confirmation of meeting notice

Chairperson Gibson called the meeting to order at 7 pm and confirmed that the meeting was properly noticed.

4. Regan Watts, Recycling & Sustainability Coordinator – Introduction / Discussion

Rodney Eslinger, Director of Planning and Development introduced Regan Watts as the County's Recycling & Sustainability Coordinator. Ms. Watts updated the committee on her background.

5. Department Draft 2022 Fee Amendments / Discussion – Action

Jared Grande, Land Use Manager discussed the draft of the proposed 2022 fee amendments to the committee. Regan Watts, Recycling & Sustainability Coordinator presented an overview of the proposed hauler fee increases to the committee. Ms. Watts showed several graphs and charts that revealed that the current hauler fees are no longer covering the cost of the program.

6. **Proposed Resolution: File No. 21-22/020** "Supporting Eau Claire County Joining the Wisconsin Local Government Climate Coalition" / Discussion — Action

Regan Watts presented an overview of the resolution to the committee. She indicated that the coalition would provide an opportunity for networking, ability to share information across municipalities related to renewable energy policies and action plans, and the resolution also gives the municipality the ability to comment on PSC dockets that could lead to policy change at a state level.
