- Move the fair office back to Building E exhibit building (lots of questions from exhibitors, superintends and judges very inconvenient for them to travel to the office building. Need to find a way to re-engage public realize with COVID wasn't possible in 2021. Bring back the 4-H food stand in building E. Bring back the OYC stand and dairy promotions to where the fair office was located. The fair schedule was spread out to long not ideal for working parents/youth again

understand this was a COVID adjustment but would consider moving back closer to the past schedule. If continue with schedule this past year, I could see volunteer issues as difficult to balance it all in today's busy schedules.

- Decorating the barns is very nice but not particularly necessary. I do feel the exhibitors should be required to put up signs with their name, club, and cattle information.

- The tables we had for the blue ribbon tent are in really rough shape. The sides are coming apart, they're all different sizes, they are SO heavy. We have to use plastic table cloths on them because they are so beat up and the table cloths were really tricky to deal with in the wind.

The Fair Committee needs to support and promote all areas of the fair. The Fair Committee should consist of a variety of members, not just livestock members.
- Open up to the public and more advertising
- Again, just miss how things were pre Covid. Would like to see the fair go back to how it used to be prior to Covid.
- A huge THANK YOU to all involved!!!! I know it takes a village to make this happen. You all worked so hard. This fair is about the youth and I hope it can continue that way. We all need to work together to get more kids involved in 4-H and FFA.
- Thank you for an amazing fair! Looking forward to 2022.
- Thanks for your hard work! **
- Tribute garden event, very special and moving. Loved it.
- Is there a possibility to have "clinics/training" for older members to help younger participants with advice, tricks, tips, etc that could be scheduled throughout the weekend to help provide more knowledge to the younger youth? I know it's already incredibly busy so maybe that's not an option, but since everyone is there & some have additional time, it would be nice to share the wealth of knowledge that they have. ©
- Just some general 4H observations (and I know Covid has possibly affected some of this):
 - It would be nice to have project meetings for things other than just livestock. (Foods, cultural arts, modular construction, etc.) Is this something that is up to each club to do?
 - Kids and families that are new to projects need to be identified and have more/better information shared with them. It should not be an expectation that everyone knows the projects or to just wait for them to ask questions.
- Great job with current conditions. Don't let a few negative comments about not being open to the public get in the way of doing what is right. Great fair!
- The fair office was very friendly and helpful, unlike the Livestock committee. It is time for a change of the Livestock Committee. They are very rude and unfriendly. People are scared to talk to them.
- There is a ruling in the fair book that all animals on the grounds need to be cared for and feed by 9am each morning. It was very sad to me that the Livestock Leaders we not on the grounds Sunday morning. They should be setting an example for the kids. If you sign up for a job, follow thru.
- The schedule of events was well laid out and easy to follow.
- I absolutely loved this fair! Thank you so much for all the hard work. **

- Thank you for the opportunity to share my opinions.
- Appreciate the work and efforts put in to make the fair successful. The youth were able to have more of a normal county fair experience this year. Thank you for your work.
- The show tent was not set up for each of the shows. Should have been done after the previous show. Felt bad for the rabbit and poultry superintendents, nothing was set up for them. Setting up of the auction should have been done, right at the beef show. Embarrassing that the set up was going on while the buyers were coming into the tent.
- We signed up to volunteer, but really weren't needed, which was frustrating.
 We would love the schedule to return to the way it was, rather than spreading it out all week.
 - My kids really enjoy and are fulfilled by turning in their own projects, and we would like to see that return. My daughter really learns a lot from face-to-face judging in knitting, crocheting, family living, home furnishings, foods and nutrition and cake decorating and we would like to see that return. We missed the food and working in the food stand. And the shakes! We loved the music judge. She was very knowledgeable and my daughter learned a lot from her. It was frustrating not being able to bid on the silent auction items in person. It really didn't serve as a public exhibit, since the public wasn't invited, and is fruitless for the kids to make projects not to be seen by the public. The ribbons would feel more earned if there were more projects. I think projects were way down this year due lack of interest in the fair, which may not have appealed to as many people.
- Don't understand why a family was at the fair when the dad / husband tested positive for COVID. Very irresponsible!
- It was such a strange year, not knowing how many people were going to come on the grounds. I'm hoping that more people will participate with our Blue Ribbon Tent next year.
- The only thing I did not like was having the swine show at 9:00 a.m. on Friday, but other than that I think everything was as close to perfect as it could be.

Fair Coordinator:

- 4 Judges for Cultural Arts.
- Bring Amy & Rachel back for Photography.
- Consistent and clear expectations of judging on projects. Example: wildflower collection said to be pressed, identified, and labeled. My 5th grader was the only one in her class and was judged down (2nd place) because she put scientific names instead of just common name. She did more than expected (even though the fair book did not say it that way) and was penalized for it. If face-to-face judging locations need to be changed, please let people know. Even something as simple as a sign or announcement on Facebook would be helpful. Bring back more activities for the kids.

- Lego judging. Needs a more accurate time. Or more judges. We waited 3 hours to be judged.
 - Most items were from kits. Conference judge maybe original categories maybe and not kits.
- I think Legos or at least the kit Legos don't need a face-to-face conference. They hand the books in with the set. I think ceramics need to be face to face judge those projects take a lot of time to do and some that do a simple paint and done get better placement then those who put hours and hour and hours into a project. Maybe the 3 by 5 needs how long it took to work on those projects.
- Need 2 judges for Lego's way to long for kids.
- For larger face-to-face or conference judging events (e.g., Modular Construction/Legos), it would be helpful to provide a time frame for the judging of each lot (e.g., 2-3 minutes). Although the judge was very attentive with each participant, the event went very long into the evening, especially when the older participants in high school were first and younger ones being last.
- Don't handle exhibits. Let the kids move their own creations so they don't get broken.
- 1)The clerk's paperwork, the page where you can circle results. It has the kids name listed but not the back
 - tag number. It would be super handy to add the back tag number.
 - 2) We had several entries that were incorrect. For Poultry even if there is no entry in a class, I would like a blank sheet with that info on it, so I could hand write in an entry if needed. It allows me to keep things in order and stay organized.
 - 3) I need to recruit one more helper so we can divide duties up and add some professionalism to the show. We did good but we can do better.
 - 4) Add Poultry to the Livestock sale! I will need someone to help lead this charge.

What could we make better for next time?

- On the thank you letters or in the envelope add a little slip of paper to identify what trophy they belong to. We had a few that got de-tached so we made an educated guess.
- Next year: Would love to request helpers in photography for judging which takes 2-3 hours, plus stapling ribbons, displaying photos as my daughters get busier with jobs in the summer and less available to help me. (See comment below) This year the 3 interns popped in at just the right time to help with ribbons and hanging photos!! With my one bad foot, this was especially helpful this year (hopefully my surgery in August will get me back to normal!!)
- Project tags
- Change check in time for projects for the Expo to later in the day i.e. 1-7:00 p.m.

Any other comments you feel need to be shared?

If someone is willing to donate a trophy, I feel it should be used even if only one entry. I have been donating a sand candle for 15 years. There was 3 entries & it was not used!

- While I realize that there is still pandemic protocol in place, everything should be even across the board. We were stopped and told we had to wait to get our things at pick up due to metering. Yet a family walked right in behind us and was let right in after we waited. Also, I understand that children are to be helping because it's their fair, however, projects should really be handed with more care during resort and pick up. Also, pick up was very rushed this year and last year. They do not even give you a second to make sure what you have is everything or even yours. Either make more pick-up time or slow down.
- Judges (poultry and rabbits) were very knowledgeable. It was great how much time they took with the kids explaining their thoughts and about the animals. In fact, one of the judges helped us diagnose something with chicken so we were able to care for her. Please thank them for their long day and fantastic work. Also, the coordinator volunteers for the animals worked so hard. They put on a great fair even with the limitations because of Covid. They deserve many thanks and acknowledgement.
- I was a little disappointed in the fact said any kid not vaccinated and those under 12 needed masks. My kids both wore their while other kids didn't while in the closed building. My kids wanted to take theirs off but I wouldn't have allowed it according the rules that were sent out but not enforced. I did appreciate how many people were allowed in for pick seemed work out really well. Thank you to all those who made the fair possible for these kids I know its hard thing to coordinate!
- Many great volunteers that do a great job but a better ring man for the beef show is needed.
- Debbie Kitchen and Cindi Syverson deserve all the credit. They went through a
 lot throughout the week, along with all the volunteers, and deserve recognition for
 their efforts. Debbie particularly! She was there all day every day.
- Thank you, Debbie, for all your hard work that you put into the fair.
- Change it up every year so the same club isn't always the farthest from the show tent, make it fair.
- Multiple complaints from multiple buyers. The buyers do not want to sit through awards prior to the auction for over 30 minutes. Make a different time or day to give the awards out. Most buyers do not know any of the people receiving or giving the awards. It's a waste of the buyer's time. For the Lego project entries, would it be possible to do a tiered option based on price (Under \$25, \$26-\$100, \$100+) or something like that? It seems unfair for kids that are spending as much as they can afford on a Lego set to go up against other families that are willing to spend incredible amounts on theirs.
- Dairy Show cannot be on Sunday again in the future. It is a long day of showing and then long night of clean up. Not fair dairy always gets the short end of the stick.

Comments:

What was your favorite part of this year's Fair?

- The auction was very well run! The personalization that Steve brought to the auctioneering makes the auction so much more enjoyable then moving them through quicker.
- Ultrasound and Carcass Evaluation option.

What could we make better for next time?

- Better communication from the Livestock Project. Very unorganized swine/sheep/
 & goat check-in.
- Livestock leaders were very rude to families and exhibitors. Livestock leaders posted their children's winnings, and not the other livestock champions on the Livestock Facebook page.
- Paperwork at the fair was very unorganized. Not all families have Facebook, and notifications were sent on Facebook, and at the last minute. We need a change in the Livestock leadership. The youth should be running the project, and they have not meet as a committee since November. Very disappointing how the Leaders handled themselves at the fair.
- Not as many rules for livestock participants.
- Why were the bleachers not used during all of the livestock shows under the tent? There were nice crowds in attendance and this made it difficult to see what was happening in the show ring if you were not close to the gates. Many people guestioned why they were not used. Since they were available, why were they not used? From what I heard, when DATCP arrived at the fairgrounds, the representatives were not treated respectfully. And the information was incomplete and not properly prepared. It is so important that this information be reviewed and made sure it is complete BEFORE an animal gets off a trailer. It is a safety issue. There are protocols that MUST be followed for the safety of animals and exhibitors. Information MUST be made available whenever they request it. Period. Not doing so will be remembered and acknowledged by DATCP. Eau Claire will not be viewed as fair friendly and instead, difficult. This is embarrassing for the county. This is not the kind of reputation I would hope the fair would want to have. The people who were disrespectful to the DATCP people should submit an apology letter to the appropriate people and commit to making sure protocols will be followed going forward.
- While there were and are many positives from the fair, there was clearly an underlying tension with the Livestock Committee that was felt and not positive. People mentioned how unorganized the Livestock Committee was and how unpleasant they were to work with compared to a few years ago. This is NOT going to encourage kids to participate in the county fair. The fair is much larger than just the livestock projects. Yes, they are an important part of the fair ... but so are many other aspects. All families, kids, superintendents, volunteers, leadership, judges, attendees, county personal, DATCP staff and anyone else who is involved with the fair should be treated with respect. No one aspect of the

fair is more important than another. Yes, people can be passionate about various areas. This is helpful and great. But teamwork between all the many different aspects of the fair is so important. Without respect and teamwork, it will be very difficult for the fair to maintain itself and keep going into the future. Personal priorities and agendas can quickly become the demise of the fair if this attitude continues.

What could we make better for next time?

- Ask Alyssa our county Ag Educator to help with check in/weigh in of the Livestock species. Weights were totally messed up with the swine. We need a neutral person reading the scale. Exhibitors were told they could only go across the scale once, and then some were allowed more than once. If the committee is going to make a ruling it needs to be fair with everyone in the project. Seems like if you're a buddy to the Livestock leadership committee you get special privileges.
- Why aren't the swine superintendents in charge of the swine paperwork? This is their responsibility. This has been an issue for the last couple of years. The swine superintendents should be in charge of the swine ear tags, weigh in (if allowed), all the paperwork. The Livestock Leadership only wants the swine superintendents to do the work they do not want to do.
- Paperwork needs to be completed and double checked at the time the animal gets off the trailer. Livestock had to go ask exhibitors for premises I'd numbers after the animals were already in the barn. The person checking paperwork should have been catching this before the animals were allowed off the trailer.
- The record keeping process for the swine weigh in needs to be smoother.
 Multiple mistakes were found after the weigh in. Maybe too many people involved and helping with the weigh in?
- Extremely disappointed there was not a buyer's dinner.
- Considering that the fair was smaller a lot of things didn't seem to be ready for the auction.

Any other comments you feel need to be shared?

- Lots of unfriendly, grumpy adult helpers/parents/board members that are not easy to approach. The fair is about the kids, not the adults. Take a step back and relax, let the kids have fun. Miss the old days when the kids had water fights, barn dances, grill out. Now you have to watch what you say or do because you will get reprimanded. Lots of board members and livestock committee members need to step down, so many unhappy families due to strict rules. People are leaving to go to other fairs. It's not fun anymore.
- Being organized is always appreciated! At the fair we were asked to submit livestock information "ASAP" multiple times all in regard to the same forms or event (auction)...just difficult for those of us in many places to keep running around for little bits of information. And more difficult for those of us that are new to projects too!

- Weigh in for pigs done at time of drop off, or assign times for clubs or groups to go it was kind of crazy in the barn during that time.
- Have a bye stander helping with writing down weights so that way the correct weight gets wrote down.
- Have a basket outside of the Livestock office that you could drop things off if no one is there. Also have a sign that says livestock office so people are aware of where it is.
- For the auction just announce kids name and club or FFA chapter.
- Clean up around the barns and don't leave stuff laying around- dividers sitting
 out, rabbit cages by the wash racks, gates that look like a mess in the back row.
 Lack of machinery to put things away. Having gates set up before the sale.
- It's time for a change in Livestock Committee We need volunteers who are friendly, and willing to work as a team. Committee members are rude, talk nasty about other exhibitors, and families. The future of this project is very sad with how these adults have presented themselves this past fair.
- Livestock committee said pigs couldn't be put on the scale twice. But yet they allowed it for a few exhibitors. When a pig is within a couple lbs. of making weight what is the big deal! This fair is the strictest one in the area. It is taking the fun out of it for the exhibitors, parents, and volunteers. Thank you to everyone that could make the fair happen! Your work doesn't go unnoticed and it is so appreciative!

DRAFT: MEMORANDUM OF UNDERSTANDING between Extension Eau Claire County and the Eau Claire County Fair Committee

Purpose

This Memorandum of Understanding establishes the guidelines for collaboration between Extension Eau Claire County (referred to as Extension) and the Eau Claire County Fair Committee (referred to as Fair Committee). The purpose of this MOU is to define the roles, relationships, and obligations of the parties as it relates to the Eau Claire County Fair.

Introduction

Extension Eau Claire County is an education arm of Eau Claire County and is part of UW-Madison Division of Extension and the Land Grant University's Cooperative Extension System and the United States Department of Agriculture. The educators with Extension Eau Claire County cooperate with the Fair Committee to support the education associated with the Eau Claire County Fair.

The Fair Committee is a working committee comprised of citizen volunteers that provide hands-on assistance in producing a well-run, family-oriented and sustainable fair for all. As members of a county committee, volunteers must comply with all federal, state and county non-discrimination laws and policies. The Eau Claire County Fair is conducted on land owned by the county and marketed as the "Expo Center."

The 4-H Name and Emblem is a Federal trade mark and can be used only as authorized by land grant universities' Extension 4-H state offices and their local 4-H employee designees. Criminal misuse of the 4-H name and emblem is prohibited by 18 U.S.C. 707. The primary consideration for granting authorization to use the 4-H Name and Emblem is for the educational and character-building purposes of the 4-H program to serve the educational needs and interests of 4-H youth.

ROLES AND RESPONSIBILITIES

Joint responsibilities: Extension and the Fair Committee mutually agree to work together to:

- 1. Provide open communication and leadership to achieve the mission and goals of this partnership.
- 2. Each entity acknowledges that they are responsible for the reporting and filing associated with their organization.
- 3. Use the official and approved logo and identifying mark for each partner on all communications and promotional materials in equal size. See the 4-H Name and Emblem use guide here: 4-H Name and Emblem Wisconsin 4-H
- 4. Work collaboratively to update the Fair Book, annually.
- 5. Uphold the policies of the Eau Claire County Fair as outlined in the Eau Claire County Fair Premium Book and Wisconsin Administrative Code ATCP 160 County and District Fairs.

Extension agrees to:

- 1. Allow the Eau Claire County Fair to use the 4-H Name and Emblem in accordance with the federal law, regulations, and guidelines regarding use of the 4-H Name and Emblem. The emblem may be used for marketing, communication pieces including letters, postcards, etc.
- 2. Advise the Fair Committee on programming, Fair Book updates, and other topics as a non-voting member on the Fair Committee.
- 3. Provide educational programming in accordance with the "Roles and Responsibilities" document on Fairs at the EC County Fair.
- 4. Promote exhibition at the EC County Fair to youth enrolled in the 4-H program and families who participate in Extension programming.
- 5. Facilitate sign up of youth enrolled in Cloverbuds and Exploring for face-to-face judging.

Junior Fair Committee agrees to:

1. Provide structure, guidelines, and policies to run the Eau Claire County Fair in support of Positive Youth Development.

Meetings and Reporting

To accomplish these objectives, partners will meet/confer regularly for the purposes of program planning, monitoring, and evaluating outcomes.

Termination or Amendments

- 1. This agreement becomes effective upon the document being signed and filed with the relevant parties.
- The 4-H Educator and the Fair Committee Chair will meet to review this Memorandum of Understanding. This meeting shall occur between the end of the Fair and November 1.
- 3. This agreement shall be for a five (5) year period and will be renewed upon mutual agreement of the parties. The terms of the MOU may be amended during the five (5) year period upon mutual agreement of the parties as evidenced in writing.
- 4. Termination Clause: If either party wishes to withdraw from this agreement at any time outside of the five-year period, notification needs to be provided to the other party by November 1, with a final decision by November 30.
