

After hearing the proposal for swapping animal placement for buildings C and D for the fair, I do have several concerns with this idea. And from my point of view, I do not understand the necessity of this request nor do I support it.

One of my major concerns is that the brackets in Barn D would either need to be removed entirely to Barn C, or new brackets would need to be purchased for Barn C to hang the livestock gates. As you know my staff spent a substantial amount of time measuring everything out in Barn D for appropriate placement just a couple of years ago. This would need to be done all over again and I cannot dedicate staffing to do this. This would 100% need to be the responsibility of the fair committee. The same would be the case with moving/purchasing and installation of the brackets for Barn C.

At the present point in time, this is a proposal that I do not feel is needed. If someone can further justify the reasoning for this, I would be open to having additional discussion.
