1. Call to order by Chair

4. Review/Approval of July 22, 2019 minutes – Discussion/Action

5. Subgroups items related to State of the Groundwater Report – Discussion/Action

- **a. Technical subgroup** Steinbach reported interns are doing GIS data quality of DNR supplied data. Only 50% was good but they are working on improving this data.

- **c. Budget requests** Leonard reminded the members of the subgroups to keep in mind funding requests for projects and tasks which may be beyond current staff/departments abilities.

6. Request by Leonard Rice Engineering (LRE)-Discussion/Action

Dunning was recently contacted by Leonard Rice Engineering. The firm is proposing a groundwater project but is requesting what would Eau Claire County desire. Consensus of the group is the State of the Groundwater Report contains the Groundwater Advisory Committees goals and Dunning can refer the firm to that document and focus on the groundwater quantity section.

- **e. Health Department** Steinbach reported that their lab fees will remain flat for next year, new staff within the Environmental Division, and the Groundwater and Wetlands presentation scheduled for October 17 at the Augusta Library with state hydrogeologist Ken Bradbury.
