RE: ORGANIZATIONAL MEETING; RULES OF THE BOARD

Consistent with Section 2.04.030 of the Eau Claire County Code, the agenda for the organizational meeting of the county board, that is to be scheduled for the third Tuesday in April, requires one of the agenda items to be "adoption of the rules of order."

The rules of order and procedure are found in the County Code, section 2.04.010 through section 2.04.030. It is the responsibility of the Committee on Administration to report to the newly elected board any proposed changes to the rules of order. Because they are part of the code it will require the adoption of an ordinance if there are any changes to the rules of order.

If there are no proposed changes, a verbal report and vote by the board to adopt the rules as they currently exist will be sufficient. If the committee is recommending changes, then an ordjnance will need to be drafted and considered by the board at the organizational meeting.
