## Updates -

- Judges masking update -signed order on Friday signed by chief judge / posted will remove mask requirement on 2<sup>nd</sup> floor. Same as rest of the county. Jury trials will be masked.
- Office of court operations will be holding 3 pretrial webinar lunch series in July sent info to group earlier.
  - Continued education on promising practices, principles of EBDM are needed. State and NIC working to create video segments for continued training.
- Selected as a Safety and Justice Challenge IMPACT site First meeting July 8th (5 members to attend/identified in application)

### Purpose/VALUE

The IMPACT Network will be devoted to accelerating best and promising practices in behavioral health reform and diversion across the criminal justice system, with an emphasis on local jails, and with a commitment to pursue community-driven race-conscious solutions to reduce harm to populations overrepresented in, or disparately impacted by, the criminal justice system—Black, Latinx, and Indigenous communities.

The IMPACT Network sites will be integrated into the existing SJC Network and receive expert technical assistance including facilitation of peer-to-peer support in an issue-focused forum for the development and exchange of

innovative systemic strategies and promotion of best practices across the selected sites, maximizing the sites' impact on the broader field across the U.S.

- Screening process at the jail Team meeting every Tuesday afternoon to discuss crisis /SMI/Screening for those booked into the jail.
- Police Department hired a LE focused co-responder Chad to update next meeting.
- Update from Gaining Ground now located at CTC able to provide expanded services and meet clients where they are. Able to hold classes at CTC. will receive CCS training to provide more services through DHS. Can meet clients at the jail also for signing up to programming/services.
- MA is able to pay for residential and IOP... able to save CJCC funds as we now only have to pay for room and board.
- City / County collaboration to hire EDI coordinator Jeneise Briggs
  - o Focusing on cultural organizational perspective will likely follow out into community. Excited to see this journey.
- Data SMI and RED dashboard Review next meeting
- Continue to bring concerns to this group or CJCC. If we do not know we cannot act on.
