Judge Schumacher called the meeting to order at 7:00 a.m.

No members of the public wished to make comment.

Supervisor Smiar motioned to approve minutes from October 20<sup>th</sup>, 2021. Seconded by Kathryn Schauf. No discussions or corrections. Minutes were approved unanimously.

The Council discussed the CJCC Awards, and potential recipients – Judge Schumacher opened the floor to recommend individuals for nomination.

Supervisor Smiar nominated former Police Chief Jerry Matysik for the CJCC Award – Kathryn Schauf seconded, all in favor, nomination approved.

Tiana Glenna discussed updates to the CJCC webpage and the progress underway to update, streamline, and increase usability of the website.

Tiana Glenna spoke about the data analyst position, and the ongoing search for a new data analyst.

Lieske Giese inquired further about the webpage updates, and about potential gaps in information for community members without internet access.

Kathryn Schauf spoke briefly in response to this about the broadband committee, and the concept of tech equity within the county.

The Council reviewed the CJCC bylaws and Tiana Glenna noted the amendments made. Tiana Glenna provided an overview of the two standing committees of the CJCC with the Council.

Kathryn Schauf motioned to approve bylaws as amended, Supervisor Smiar seconds, all in favor, none opposed, bylaws are approved.

Lieske Giese inquired about recruitment for the new CJCC position. Tiana Glenna noted that work is underway with corporation counsel to create verbiage for the listing, and that the process is still ongoing.
