Kathryn Schauf motioned to approve minutes from the March 15, 2022 Board meeting. No discussions or amendments, minutes approved.

Tiana Glenna provided operational updates to the Board, discussing updates from the jail and ongoing changes with regards to the Covid-19 Pandemic.
